	Jake Hush has attended a MWQAC meeting, where he met the committee. The Marion County Board of Commissioners formed the Marion Water Quality Advisory Committee (MWQAC) on July 28, 2010. The committee membership consists of six at-large positions and six positions from the Marion Soil and Water Conversation District, Local Home Builders Association, Marion County Agriculture Industry, Land Development and a local Watershed Council. The terms of the individual positions are four years. The MWQAC is a public body, which in compliance with their bylaws, makes recommendations to the Marion County Board of Commissioners for appointment and re-appointment. Marion County policy and the MWQAC bylaws require the board make the final appointments. There are currently no other applicants.
