In the Matter of Appointing

This matter came before the Marion County Board of Commissioners at its regularly scheduled public meeting on January 29, 2020, to appoint members to the Marion County Justice Reinvestment Council;

WHEREAS, the Council is comprised of up to 19 members, who are appointed by the Sheriff; and WHEREAS, the following council members are appointed by county position: Marion County Commissioners or designee, Marion County Sheriff and Undersheriff, Marion County District Attorney or designee, Sheriff's Office Community Corrections Commander, Marion County Community Services Director, Marion County Health and Human Services Administrator or designee; and

WHEREAS, At least one representative will be appointed from organizations including, but not limited to: Bridgeway Recovery Services, Chemeketa Community College, City of Salem – City Council or Police Department, Emergency Medical Providers, Marion County Defense Bar, Mid-Willamette Valley Community Action Agency, Salem Health, Strategic Economic Development Corporation (SEDCOR), Union Gospel Mission of Salem, Victim Services, WorkSource Oregon, Business Member; and

WHEREAS, the Sheriff has appointed, and recommends that the Board appoint, the individuals identified in Exhibit A as members of the Justice Reinvestment Council representing the identified organizations; now, therefore,

IT IS HEREBY ORDERED by the Board of Commissioners that the individuals identified in Exhibit A are appointed as members of the Justice Reinvestment Council representing the identified organizations.

IT IS FURTHER ORDERED that this order will take effect immediately. Membership of the Marion County Justice Reinvestment Council will begin upon signature and for a term ending December 31, 2022.
