**TITLE**      Distribution of Oregon State Forestry Timber Revenue as per ORS Chapter 530

Issue, Description & Background      ORS 530.115 provides for the distribution of revenues generated by timber sales from certain lands located within the county. Pursuant to the statute, the State has distributed \$51,802.33 to the county for the third quarter of 2022-2023. The county must now also distribute the monies in accordance with the statute. The Treasurer has applied the distribution formula and prepared a list of the entitled entities and the appropriate amounts to be distributed. The distribution list and a form of Board Order are attached.
