Requested Action: Approve the distribution of the ORS Chapter 530 timberlands revenue as required by ORS 530.115.

Issue, Description & Background: ORS 530.115 provides for the distribution of revenues generated by timber sales from certain lands located within the county. Pursuant to the statute, the State has distributed \$1,260,531.11 to the county for the second quarter of 2023-2024. The county must now also distribute the monies in accordance with the statute. The Treasurer has applied the distribution formula and prepared a list of the entitled entities and the appropriate amounts to be distributed. The distribution list and a form of Board Order are attached.
