Issue, Description & Background:	The tax collector received duplicate payments on account 589205 for the 2022-23 tax year. ORS 311.806(1) requires the county governing body to issue refunds in situations like this. The total amount of the refund due is \$79,364.87. The Board has delegated authority to issue tax refunds under \$20,000 to the tax collector; all others must go to the Board for approval. By statute, no interest is due on this refund.
Financial Impacts:	The amount of the refund is \$79,364.87.
