Economic Development – Oregon Garden Foundation Second Quarter Report. – Mark Hunter, Development Director

Summary of presentation:

- Application to change the comprehensive plan designation from Single Family Residential to Commercial:
 - o Change the zone from Single Family Residential to Commercial Office.
- Hearings officer held a public hearing December 4, 2015 and issued a recommendation that the board approve the request;
- The board conducted a public hearing on December 30, 2015 and approved the request, subject to conditions;
- The conditions include:
 - o Right-of-way dedication;
 - o A site plan showing parking and traffic circulation; and
 - Lighting plan and the screening of all trash receptacle areas from adjacent residential uses and public streets.
