BOARD OF COMMISSIONERS

Approve an order to establish the board, committee and commission appointments for Marion County Elected Officials.

Approve an order to appoint Jim Ferraris and John Van Dreal to the Marion County Public Safety Coordinating Council with term ending dates respectively, July 31, 2018 and July 31, 2019.

Approve a resolution to designate John Lattimer as the official representative to the Courthouse Square Condominium Association and consider approval of a Memorandum of Action electing John Lattimer and Allan Pollock as Directors of the Courthouse Square Condominium Association.

COMMUNITY SERVICES

Consider approval of an ordinance revising and updating Marion County Code, Chapter 8.40 relating to Smoke-Free and Tobacco-Free County Property. Second reading. – Tamra Goettsch, Dylan Wells

Summary of Presentation:

- Allows designated smoking areas on the state fairgrounds during the Marion County Fair;
- The Fair Board has asked to bring forward the request to the Board;
- Looking to follow State policy that is in place on their fairgrounds:
- Feels that the revision to the policy would encourage more attendance;
- The budget will allow for increased signage to inform the fair attendees where the designated smoking areas are; and
- Will discuss with the Fair Board, event coordinators, and their staff; as well as Community Services staff on how to handle situations where people are smoking or vaping outside of the designated smoking areas.

Board Discussion:

- Marion County Health Department is opposed to the ordinance;
- The direction of Marion County is to reduce smoking at the fairgrounds; and
- Marion County is standardizing the policy with the State Fair to reduce confusion.
