Colm Willis called the meeting to order at 9:00 a.m.

INFORMATIONAL:

Review Request for Support for Willamette Behavioral Health Facility - Cydney Nestor

Summary of presentation:

- United Healthcare wants to build a facility in Wilsonville, Oregon that is a free standing psychiatric inpatient facility for adolescents and adults:
 - Would offer intensive outpatient services for a wide variety of services.
- They run the Cedar Hills facility in Beaverton;
- It is a for-profit organization;
- The email included letters of support, but the letters didn't come from CCO's, community mental health providers, or full commissioner boards;
- Concerns:
 - This facility is not attached to a hospital;
 - There is an aging population in Willamette Valley with severe mental health issues;
 - They stated they will accept all insurance, but that doesn't usually happen; and
 - Making a statement that Oregon needs more acute care beds, but Ms. Nestor does not agree with that assessment.
- Investments needs to be made in community based outpatient care:
 - o Intensive outpatient programs; and
 - Programs for long-term care.
- Staff recommends that the commissioners do not write a letter of support; and
- Marion County does not have the same issues that the Portland/Metro Area has.

Discuss Owner Surrender Services Provided by Marion County Dog Services for Dog with Dangerous Behaviors and Fee Schedule Change

Summary of presentation:

- Historically, Marion County Dog Shelter does not take in owner surrenders for dogs that are dangerous to the community;
- They are taken to the Humane Society, or are encouraged to work with their local veterinarian clinic;
- Community Services/Dog Shelter has been working with Behavioral Health in an effort to reduce suicide:
 - There have been cases that individuals that commit suicide have surrendered their animals beforehand.
- Believes that this is an important issue;
- Does not believe that there would be any code amendments attached to the new fee schedule;
- Staff recommends a fee of \$100 for unlicensed dogs:
 - A fee of \$65 for licensed dogs.
- For a community safety standpoint, this fee schedule would be very beneficial; and
- Health and Human Services can provide training for Dog Shelter employees to help with responding to someone who is thinking about suicide.

Board discussion:

- Marion County does not offer emotional support animal interaction:
 - There are other programs within the community that offer this option.
- The commissioners do not want staff to ask individuals if they are suicidal.

COVID-19 Update:

Summary of presentation:

- The commissioners sent the Phase 2 letter to the governor's office on Friday, June 5th:
 - It was accepted without changes on Sunday; and
 - Will find out on Thursday, June 11th if Marion County will open on Friday, June 12th.
- Total COVID-19 cases in Marion County are 1,055, and presumptive cases are 1,030:
 - The county is documenting the contact tracer follow-up:
 - They are at 94.9 percent follow-up rate.
