

ALDER ESTATES

SURVEYOR'S CERTIFICATE:

I, Karl D. Goertzen, being first duly sworn, depose and say that I have surveyed and marked with proper monuments the land, hereon shown as ALDER ESTATES, which is described as follows: Beginning at the Initial Corner of this subdivision, which is a section of iron pipe two inches in diameter and 36 inches in length, set six inches below the surface of the ground; which point is 1148.28 feet SC^o 40' 30" W and 1513.67 feet S88^o 40' E and 30.00 feet S^o 03' 02" W from the Southwest corner of the Jacob Robins Donation Land Claim in Section 30, Township 7 South, Range 2 West of the Willamette Meridian, Marion County, Oregon, said point also being on the West line of Lot 23, Auburn Addition to Salem 30.00 feet from the Northwest corner of said lot; thence N0^o 03' 02" E 30.00 feet to the Northwest corner of said lot 23; thence S88^o 40' E along the North line of said lot 23 211.60 feet; thence S1^o 20' W 30.00 feet; thence along the arc of a 20.00 foot radius curve to the left, the chord of which bears S45^o 41' 41" W 28.61 feet, an arc distance of 31.88 feet; thence S0^o 02' 28" W 123.86 feet; thence along the arc of a 120.00 foot radius curve to the left, the chord of which bears S12^o 52' 34" E 53.66 feet, an arc distance of 54.11 feet; thence along the arc of a 180.00 foot radius curve to the right, the chord of which bears S2^o 31' 11" E 2.33 feet, an arc distance of 2.33 feet; thence S0^o 02' 28" W 226.44 feet; thence N88^o 54' 15" W 23.00 feet; thence S0^o 02' 28" W 100.01 feet to a point on the North line of the Southern Pacific Railroad Right-Of-Way; thence N88^o 54' 15" W along the North line of said railroad right-of-way 180.55 feet to a point on the West line of said Lot 23; thence N0^o 03' 02" E along the West line of said Lot 23 525.70 feet to the point of beginning and containing 2.495 acres, more or less.


