

WHEREAS, the Board recommends approval, denial, or makes no recommendation regarding the OLCC liquor licenses for certain establishments as listed in Exhibit A; NOW, THEREFORE,

IT IS HEREBY ORDERED that the Board adopts the recommendations for approval, denial, or no recommendation regarding the OLCC liquor licenses as listed in Exhibit A, attached and incorporated herein.
