- 4. Consider the adoption of the Marion County Transportation Safety Action Plan. –Carl Lund *Summary of presentation:*
 - FHA- Federal Highway Administration;
 - Identified High-Injury Network Locations:
 - o McKay/Yergen/Ehlen Roads:
 - River Road to Main Street.
 - Silverton Road:
 - Fossholm Street to Cordon Road.
 - o Corden Road:
 - Hazelgreen Road to Wagon Wheel Drive.
 - North First Avenue:
 - Shaff Road to Water Street.
 - O Golf Club Road:
 - Santiam Highway to Shadd Road.
 - o River Road:
 - St. Paul City Limits to Brooklake Road.
 - o State Street:
 - Cascade Highway to Cordon Road.
 - High-Risk Intersections:
 - Silverton Road at Howell Prairie Road;
 - Silverton Road at 81st Avenue;
 - McKay Road at French Prairie Road; and
 - Brooklake Road at River Road.
 - Detailed crash analysis:
 - Lane and roadway departures:
 - Nearly 40 percent of all county crashes;
 - Over 60 percent of fatal and serious injury crashes:
 - Of these, 80 percent of fatal crashes involve vehicles leaving the road and hitting objects (trees, mailboxes, fences).
 - Chevrons, rumble strips, lane widening help prevent these; and
 - Clear zones are for vehicles that have left the road.
 - Impaired drivers on rural roads:
 - o Harder to address as it depends on individual behavior;
 - o 9.3 percent of all Marion County crashes:
 - Of this 36.3 percent are fatal.
 - Funded to do Listen and Learn Session:
 - Related to drunk driving.
 - Federal Highway Administration's (FHWA) Safe Systems Approach:

- o Focus on zero fatal or serious injuries;
- Humans make mistakes;
- o Humans are vulnerable;
- o Improving driver, pedestrian, and vehicle safety; and
- o Have post-crash care, safer speeds and roads.

Board discussion:

- Engineering, education, and enforcement:
 - o These are all important components to keep the roads safe.
- This is 3.5 years of work to find the roads that need improvement and systems to do so;
- Plan:
 - o Comprehensive project scoping; and
 - o Cost estimates for potential safety improvements.
- There are issues with congestion on these roads:
 - o As frustration grows, worse decisions are made.
- There is an estimated \$127 million in potential safety improvements:
 - o There are other roads and bridges that need improvement that are not included.
- This is the first Transportation Safety Action Plan for Marion County; and
- Transportation System Plan for the rural areas needs to be done next.

MOTION: Commissioner Cameron moved to adopt the Marion County Transportation Safety Action Plan. Seconded by Commissioner Bethell; motion carried. A voice vote was unanimous.
