# Summary of presentation:

- Over the last year, Intellectual and Developmental Disabilities Advisory Council (IDDAC) has:
  - o Showcased activities, events and resources throughout the community;
  - o Increased awareness in our community;
  - o Served people from birth to death; and
  - o Participated in Keizer Rapids Park for disability accommodations for the Big Toy.
- Posters recognizing March as Intellectual and Developmental Disabilities Awareness Month will be displayed in Courthouse Square;
- IDDAC provides outreach for families and providers in the community; and
- The fifth annual Support Services Fair is scheduled for April at the Keizer Civic Center.

#### **Board Discussion:**

- The "Creating Opportunities second annual, Celebrating Achievements Awards Gala" is scheduled for March 12, 2016;
- IDDAC was a wonderful resource for the Big Toy disabilities accommodations;
- A program on CCTV showcased IDDAC and its services; and
- The commissioners shared their opinions as to the importance of people with disabilities being able to receive the care and support services offered in the community.

## SHERIFF'S OFFICE

2. Consider approval of the Contract for Services with Liberty House for \$176,704 from January 1, 2016 through December 31, 2017 to provide a mental health program manager/therapist to assist children and their families. - Jeff Wood

### Summary of presentation:

- During the current legislative biennium, the State of Oregon received \$37 million for Justice Reinvestment and Marion County received roughly \$3.5 million;
- Goal is to:
  - o Provide for a reduction in the prison population;
  - o Reduce recidivism: and
  - Hold offenders accountable.

- One of the key caveats of Justice Reinvestment is a minimum of 10 percent must go to victim services for victims of crime;
- In domestic violence shelters, 30-35 percent of the victims are from communities of color;
- Half of children suffered or witnessed physical and/or sexual abuse;
- Lack of trauma counseling for families in Marion County;
- Contract is new and solely for Justice Reinvestment Plan; and
- The contract will staff a fulltime Mental Health Program Manager/Therapist at Liberty House.

**MOTION:** Commissioner Brentano moved for approval of the Contract for Services with Liberty House for \$176,704 from January 1, 2016 through December 31, 2017 to provide a mental health program manager/therapist to assist children and their families. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.

3. Consider approval of the Contract for Services with Center for Hope and Safety for \$276,706 from October 1, 2015 through September 30, 2017 to provide advocates assisting children and youth. - Jeff Wood, Jayne Downing

# Summary of presentation:

- Contract will provide a Children's Advocate, a Bilingual Advocate and a three-quarter time Intake Coordinator;
- Three-quarter Intake Coordinator:
  - o First time able to have an intake coordinator;
  - o Individual has been hired;
  - Attended 45+ hours of training:
  - o Bilingual/Bicultural;
  - Meets every person who comes into the office to make sure they connect with an advocate;
  - o Also doing other functions:
    - Answering 24 hour crisis line; and
    - Able to help get individuals the services they need.
- Children's Advocate:
  - o Bilingual/Bicultural;
  - o Meeting with children every day;
  - o Attends support groups:
    - Providing children therapeutic services during support groups.
- Third position is a partnership with local Victim Assistance Office:
  - Been an advocate for two years;
  - Already had victim's assistance training;
  - Helps with protection orders;
  - Goes to Courthouse every day at 2:00 p.m. so there is an advocate on hand; and
  - Bilingual/Bicultural.
- Grateful for three extra positions;

- Contract is retroactive; and
- Reporting is required.

**MOTION:** Commissioner Carlson moved for approval of the Contract for Services with Center for Hope and Safety for \$276,706 from October 1, 2015 through September 30, 2017 to provide advocates assisting children and youth. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.
