BUSINESS SERVICES

1. Consider approval of the lease agreement for \$182,770.05 to allow the Sheriff's Office to lease office space with Fairway Development Group, Inc. – Larry Tilford

Summary of presentation:

- New lease agreement;
- Current site lease is expiring at the end of June 2018;
- New sit is off the highway and freeway;
- Satellite location for the Sheriff's Office;
- When the old lease agreement was initiated, it was only set for that term:
 - o Landlord has put new tenant in the original office space.

MOTION: Commissioner Brentano moved for approval of the lease agreement for \$182,770.05 to allow the Sheriff's Office to lease office space with Fairway Development Group, Inc. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

2. Consider approval of the incoming funds Intergovernmental Agreement with Oregon Department of Transportation for \$2,355,412.50 to provide federal funds for the Lancaster Drive Project. — Brian Nicholas

Summary of presentation:

- The county has been awarded federal funds through Salem-Keizer Area Metropolitan Planning Organization;
- The money will go towards improvements on Lancaster Drive;
- The project is between Center Street and Monroe Avenue;
- It is a high volume corridor;
- Issues:
 - There are deep valley gutters, which causes drivers to slow down when entering driveways:

- Causes car accidents.
- Long sections of asphalt sidewalks;
- o Steep driveways;
- o Pavement distress; and
- o Non-ADA Compliant ramps.
- Will be replacing sidewalks and driveways:
 - o Fix valley gutters;
 - o Replacing failing concrete;
 - o Correct ADA deficiencies;
 - o Install new stormwater system;
 - o Resurfacing Lancaster Drive; and
 - o Installing durable paving striping.
- Total estimated cost of the project will be \$2,625,000;
- The county will need to match 10 percent in funding; and
- Start of construction will be spring of 2021.

Board discussion:

- There is a lot of business access points in front of Hometown Buffet:
 - o Will be reducing the access entry point on Lancaster Drive to two.

MOTION: Commissioner Cameron moved for approval of the incoming funds Intergovernmental Agreement with Oregon Department of Transportation for \$2,355,412.50 to provide federal funds for the Lancaster Drive Project. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.

PUBLIC WORKS

A. Public hearing to consider the application for Mass Gathering Case #18-002/Whitewind Woodland, LLC. – Brandon Reich

Summary of presentation:

- The property is zoned Exclusive Farm Use;
- It is located at 6518 Cascade Highway NE, Silverton;
- The property is located on the south side of Cascade Highway, on the southwest corner of Valley View Road;
- Surrounding properties consist of farm use and timbered property in the farm zone;
- The applicant is requesting to hold a renaissance era fair and a wild west show as a small mass gathering;
- The event will take place on July 21-22, 2018:
 - o July 28-29, 2018;
 - o August 11-12, 2018; and

- o August 18-19, 2018.
- Estimated attendance is between 1,500 and 2,000 people;
- Based on this information, the proposed event meets the definition of a small gathering;
- According to the information submitted with the application, sound amplification will be used:
 - o Alcohol will be available; and
 - o Fireworks will not be used or shown.
- Sound amplification will be used at noon and 4:00 p.m. during shows:
 - o There will not be amplified sound after 11:00 p.m. or before 9:00 a.m. on any day.
- Mass gathering ordinance requires the applicant to coordinate with various governmental agencies to ensure there are adequate facilities and services available:
 - o Marion County Public Works;
 - o Marion County Sheriff's Office;
 - o Marion County Environmental Health;
 - o Marion County Risk Management; and
 - Silverton Fire District.
- Each agency was provided with a copy of the request and given an opportunity to comment on its requirements:
 - o All of the Marion County agencies approved the plans submitted by the applicant, or they requested final permits prior to the date of the event; and
 - Silverton Fire District requested that the applicant allow them to inspect the property prior to the event.
- Staff recommends the board approve the application subject to the conditions of approval.

Support:

Nancy White:

- Owner and the host of the Canterbury Renaissance Fair and the Whitewinds Wild West;
- A neighbor submitted a letter of opposition stating that he has issues with parking on the grass and sound amplification;
- Has never had an issue with people parking on the grass:
 - o Has a 750 gallon water tank on a trailer for fire safety and dust mitigation.
- Fair is not held near the berry bushes, high grass, or timber;
- Fair is held in the mature oak grove area;
- The noise is during the joust, which is between 12:00 p.m. and 4:00 p.m.
 - o Only an hour long.
- There is sound amplification during Wild Bill's Western Stunt Show;
- Enforces quiet time from 10:00 p.m. 9:00 a.m.;
- The only structures left on the property are completely removable; and
- Requires all vendors to have fire extinguishers at their booth.

Board discussion:

• Mass Gathering Code prohibits permanent structures associated with the mass gathering;

- The fire department inspects the property every year:
 - o Two weeks before the event; and
 - o Right before the event.
- Access roads on the property can accommodate emergency vehicles;
- The board adopted a provision that small mass gatherings can be approved for five years:
 - o The renewals can be approved by the planning director;
 - o Neighboring properties will be given copies of the renewal;
 - o If comments are received, Public Works will work with the applicant to address the issues; and
 - o If there are concerns that the applicant is not meeting the conditions of approval, the planning director will send it back to the board for another hearing.

MOTION: Commissioner Brentano moved to close the public hearing and approve the application for Mass Gathering Case #18-002/Whitewind Woodland, LLC. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

Commissioner Carlson read the calendar.
