United States Forest Service presentation of the 2017 fire season – Tracy Beck, Forest Supervisor – Willamette National Forest, Grady McMahan, Detroit District Ranger, and Dave Halemeier

## Summary of presentation: (See Attachment A)

- The U.S. Forest Service presented an overview of the 2017 fire season;
- The firefighters try to create fuel breaks between public lands and private lands, so private lands do not burn;
- Detroit had four acres of private burned land;
- Marion County is very easy to work with and very proactive;
- Partnership with the Little North Fork drainage has been outstanding;
- Sheriff's patrol on Detroit Lake has been very helpful;
- Danielle Gonzalez from Community Services Department has been doing amazing things in the canyon;
- The Detroit Federal Highways Project will develop a park in downtown Detroit with a trail out to Detroit Flats:
  - o Will be completed by November 2018.
- The U.S. Forest Service just finished repaying the first two miles of Breitenbush Road.

#### Board discussion:

- The commissioners appreciate Mr. McMahan's participation in the community;
- The commissioners are concerned with the lack of communication abilities in the canyon:
  - o Radio systems are important.

## HEALTH

1. Consider approval of the Contract for Services with Northwest Human Services, Inc. for Warmline Crisis Services to residents of Marion County for \$294,021. – Scott Richards

# Summary of presentation:

- Northwest Human Services provides emotional support for less severe crisis services;
- Strengths in helping people navigate the following:
  - o Food pantry access;
  - o Emergency financial assistance;
  - o Housing;
  - o Transportation; and
  - o Helping with access to Oregon Health Plan.
- Health and Human Services would like to continue to provide support services to the warmline;
- The warmline received 1,909 Marion County calls last year:
  - o 234 crisis calls;
  - o Most of the individuals are adults;
  - o 80 calls came from ages 13-24; and
  - o 1,565 calls were resolved without a follow up.
- Provides additional service to Marion County residents; and
- Social services connection is very strong.

## Board discussion:

- The phone number is on their website, but Mr. Richards believes more marketing needs to be done to advertise the number;
- Same line handles suicidal callers; and
- The focus is more for the mental health connection.

**MOTION:** Commissioner Brentano moved for approval of the Contract for Services with Northwest Human Services, Inc. for Warmline Crisis Services to residents of Marion County for \$294,021. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.







- · This should lead to greater efficiencies in our planning
  - More flexibilities with Categorical Exclusions (CE's)
  - · Compressed timelines to complete projects
  - · More acres/volume per decision

- Substantially increase project area size (ie, Green Mtn. and Lowell Country)
