BUSINESS SERVICES

1. Consider approval of a Public Improvement Agreement with Andy Medcalf Construction, Co. in the amount of \$1,102,879.00 for the Juvenile Court Addition project. — Colleen Coons-Chaffins

Summary of presentation:

Andy Medcalf:

- Primarily does commercial and industrial construction;
- Has 16 employees; and
- Currently involved in a lot school projects.

Colleen Coons-Chaffins:

- Put out a Request for Proposals (RFP) on May 26, 2017;
- Made sure to use local contractors;
- Received five bids:
- Contract includes fixing existing light fixtures and carpet in the older part of the building to match the new building;

- Will start construction at the end of August; and
- Working with Mr. Sybrandt to relocate some employees temporarily due to noise.

Board discussion:

- Working with Carlson Veit for the Juvenile Administration Building;
- All courts will be in Juvenile Detention Facility;
- Both office staff will be together; and
- Working with the Sheriff's Office to manage both courts.

MOTION: Commissioner Carlson moved for approval of a Public Improvement Agreement with Andy Medcalf Construction, Co. in the amount of \$1,102,879.00 for the Juvenile Court Addition project. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

PUBLIC WORKS

2. Receive and consider appeal of hearings officer's decision denying Conditional Use (CU) 17-012/Greenwood, Clerks file #5729. – Joe Fennimore

Summary of presentation:

- Conditional Use to change the occupant of temporary hardship dwelling on 55 acre parcel on Exclusive Farm Use (EFU) Zone located on Santiam Loop SE, Aumsville;
- In 2006, the applicants got approval for a temporary mobile home to house a caregiver for Mr. Greenwood;
- In 2010, the applicants were granted approval to convert the hardship mobile home to a secondary farm dwelling to house an employee of the farm and to convert an accessory structure into an apartment to house a caregiver;
- The hardship applications were renewed on a yearly basis until 2016;
- In December 2016, the applicant filed a Conditional Use case 1633 to change the medical hardship from Mr. Greenwood to Mrs. Greenwood;
- The decision was denied by the planning director and due to unusual circumstances, was not appealed;
- On Aril 5, 2017, the planning director allowed the applicant to re-file the application and send the matter straight to the hearings officer;
- The hearings officer conducted a hearing on May 3, 2017 and left the record open until May 10, 2017:
 - o On June 27, 2017, the hearings officer issued a decision denying the request; and
 - o The issue was appealed to the board on July 12, 2017.
- In the denial, the hearings officer found the applicant did not satisfy several of the criteria:
 - o Failed to provide requisite medical hardship certificate from a medical doctor;
 - o Did not demonstrate that the care required a caregiver;
 - o Did not identify the specific extent and nature of care needed; and
 - o Did not prove that the current caregiver had the ability to provide the care.
- The hearings officer found that the mobile home on the property is not being occupied by an employee of the farm;

- Under Marion County Code 17.110.680, a land use permit cannot be issued if property is in violation of a code;
- In the appeal, the applicant disagrees with the conclusions of the hearings officer:
 - o The certificate provided was adequate to meet the criteria;
 - o Family members are unable to care for the applicant;
 - o The proposed caregiver is qualified to care for the applicant; and
 - The occupant of the mobile home does perform work on the property to offset some of the rent cost.
- In the appeal, the applicant did not provide any additional evidence;
- The board has the options to accept the appeal and remand the matter back to the hearings officer:
 - o Accept the appeal and schedule a public hearing:
 - Suggested hearing date is August 23, 2017.
 - o Deny the appeal and uphold the hearings officer's decision denying the request.
- Staff recommends that the board deny the appeal and uphold the hearings officer's decision denying the application.

Board discussion:

- The decision is based on Oregon Administrative Rule (OAR) and Oregon Revised Statutes (ORS);
- Marion County has interpreted OAR and ORS to come to the conclusion of denial;
- The applicant paid \$100 to change the occupant dwelling:
 - o \$500 fee to have a public hearing to the board.
- The applicant has an attorney for this case;
- This application is a poster story for what Commissioner Carlson went to the legislature and explained issues just like this one:
 - The legislature stated that a property like this case can have two separate dwellings based under current law.
- The application is to change the care from Mr. Greenwood to Mrs. Greenwood;
- The caregiver lives in the apartment in the barn;
- If the commissioners determine that the occupant is not an employee of the farm, the applicant is in violation of the conditional use and the mobile home has to be removed;
- If it is determined that the caregiver is not necessary for Mrs. Greenwood, then the apartment would need to be removed;
- Both homes were put on the property under a conditional use; and
- The applicant is trying to legitimately change the conditional use.

MOTION: Commissioner Cameron moved for appeal of hearings officer's decision denying Conditional Use (CU) 17-012/Greenwood, Clerks file #5729 and set a public hearing for August 23, 2017. Seconded by Commissioner Carlson; motion carried. A voice vote was unanimous.
