#### PUBLIC WORKS

2. Consider approval of the Contract for Services with Finley-Buttes Limited Partnership for the hauling and disposal of leachate wastewater for \$6,966,000 through September 5, 2021. – Alan Haley, Brian May

# Summary of presentation:

- Five year contract;
- Covers approximately 30 million gallons of leachate;
- Rain that flows through ash piles collects into a lagoon;
- Considered waste water;
- Haul out throughout the year;
- Looking at ways to change process;
- Leachate is a necessary evil of landfilling;
- Should see reduced generation by reducing footprint:
- Evaluating idea of sealing off; and
- Cost analysis underway.

#### Board discussion:

- The chemical composition is non-hazardous material which is basically a salt water;
- Unique ash which comes from incinerator;
- The salt has a tendency to reduce the biological activity and kills traditional water treatment process;
- Done some evaporation within the confines of the lagoon itself;
- Six companies showed up for a pre-bid meeting, but only received one bid;
- Planning on 2.5-4.5 million gallons per year, but do not anticipate it being higher; and

• Covanta is currently testing how leachate will affect their boiler system, but can only divert about one million gallons.

**MOTION:** Commissioner Carlson moved for approval of the Contract for Services with Finley-Buttes Limited Partnership for the hauling and disposal of leachate wastewater for \$6,966,000 through September 5, 2021. Seconded by Commissioner Brentano; motion carried. A voice vote was unanimous.
