## PUBLIC WORKS

- 1. Consider adoption of an administrative ordinance granting zone change/comprehensive plan amendment, case #ZC/CP 14-002, Freres Timber, Inc., Clerk's File #5688. Joe Fennimore *Summary of presentation:* 
  - Item is a request to change the comprehensive plan designation from Primary Agriculture (PA) to Farm Timber (FT) and to change the zone from Exclusive Farm Use (EFU) to FT on a 28 acre parcel located in the 7500 block of Sherman Road SE;
  - Initial application was to change the comprehensive plan to Rural Residential (RR) and the zone to Acreage Residential (AR), with exception of statewide planning goal 3, Agricultural Lands;
  - Following public hearing, hearings officer issued recommendation that the board deny request;
  - At subsequent hearing before the board, the applicant requested that the board remand the matter back to hearings officer to consider a modified request;
  - Modified request to change the comprehensive plan and zone to FT and would not require a goal exception:
    - o Hearings officer held public hearing on modified request on January 7, 2015; and
    - Hearings officer issued recommendation that the board grant request on February 18, 2015.
  - Ordinance and findings have been prepared and notice of adoption was on April 15, 2015; and
  - Administrative ordinance is now set for formal adoption.

## Board discussion:

- Very lengthy process for applicant;
- Hearings officer has done a thorough analysis and met each requirement; and

Encouraged by the ability to find a way to make this work to the benefit of all.
