2. Consider approval of an ordinance amending the Ambulance Service Area Plan, by emergency procedure. – Rod Calkins

Summary of presentation:

- Ambulance services regulated by counties by ordinance and Ambulance Service Area plan (ASA):
 - o ASA last reviewed spring 2012.
- Boundary descriptions as stated in ASA are correct;
- Geographic Information System (GIS) boundary descriptions between Salem Fire Department and Marion County Fire District #1 need correction:
 - o Correction will ensure ambulances are dispatched appropriately.
- Salem Fire Department and Marion County Fire District #1 support amendment.

Board discussion:

PUBLIC WORKS

3. Consider approval of amendment #13 to the current contract with Covanta-Marion, Inc. to reduce annual medical waste tonnage requirements accepted at the Waste-to-Energy Facility. – Alan Haley, Jeff Bickford

Summary of presentation:

- Covanta Energy owns and operates Waste-To-Energy Facility (WTEF);
- Marion County began accepting infectious medical waste in 1989;
- Mid-1990's Marion County Board of Commissioners set 1,500 tons per year limit on out-of-county boxed infectious medical waste as recommended by the Marion County Solid Waste Management Advisory Council.
- Existing agreement states Covanta may terminate its obligation to accept medical waste material upon 60 days written notice if Marion County fails to provide at least 1,000 tons of out-of-county boxed infectious medical waste per year:

- o Contract runs through September 2014.
- Marion County has specific exclusion not to receive human fetal tissue in infectious medical waste;
- Marion County no longer accepts material form Stericycle, Inc., Canada;
 - Concerns raised about Marion County's ability to meet contractual requirement of 1,000 tons per year; and
 - Covanta agreed to lower minimum obligation for out-county boxed infectious medical waste to 300 tons per year:
 - Lowering minimum medical waste tonnage obligation helps ensure medical waste program remains available for Marion County customers.

Board discussion:

- 1,500 tons per year is maximum out-of-county boxed infectious medical waste allowed;
 - o WTEF accepted 1,500 tons in 2013;
 - o Stericycle, Inc., Canada provided 500 of 1,500 tons; and
 - Company in California has approached Marion County about disposing of their boxed infectious medical waste.
- Inspection/Audit Process:
 - Request For Proposal (RFP) being drafted to perform random inspections of boxed infectious medical waste:
 - Ensure no human fetal tissue in medical waste; and
 - Inspections performed offsite.
- Certification Process:
 - o Medical waste haulers and generators must certify there is no human fetal tissue in the medical waste.
- Marion County controls flow of waste;
- Consequences if hauler/generator violates contract:
 - Ordinance states if contract violated county will no longer do business with generator; and
 - o Legal Counsel revising boilerplate for infectious medical waste haulers.

MOTION: Commissioner Carlson moved approval of amendment #13 to the current contract with Covanta-Marion, Inc. to reduce annual medical waste tonnage requirements accepted at the Waste-to-Energy Facility. Seconded by Commissioner Cameron; motion carried. A voice vote was unanimous.

Government Affairs Committee Leadership Salem Synopsis of Upcoming Annual Report to Commissioners North Santiam Canyon Economic Development Corporation d/b/a GROW•EDC June 11, 2014

Since launching GROW North Santiam in September 2008, our primary focus has been on offering free, confidential, one-on-one consulting to business owners and aspiring entrepreneurs as well as other organizations (non-profits, governments, groups working on a special project) in our service area, from Aumsville/Scio to Marion Forks. In recent years we have also developed and presented many classes and workshops that augment our consulting process and provide an opportunity for entrepreneurs to network, collaborate and learn together and from each other.

Direct client work:

- To date we have served 348 clients, the majority of whom are people who want to start a new business of some kind;
- The majority of GROW clients are low/moderate income earners, particularly in the upper canyon area;
- Women-owned or businesses with a woman partner consistently make up 2/3 of our client base; chronic underemployment among this population and the appeal of our collaborative business development model help drive the participation of women entrepreneurs in our programs;
- Our work is done face-to-facé (one-on-one or in group settings), by telephone, and by email, depending on the time constraints and needs of the client we are serving; most clients benefit from a combination of these communication methods. In the last 11 months we have had 2,338 client contacts.

Classes & Workshops:

- In the last 11 months we have facilitated 11 workshops of our own, and facilitated two classes for the Stayton-Sublimity Chamber of Commerce. Total attendance at these events is 144.
- Small Steps, Big Results was created during our last CDBG grant cycle when we noticed that our entrepreneurs often had time to work in their businesses but not much time to work on them. This monthly class remains our most popular offering and routinely draws 10-12 participants each month.
- As one participant said earlier this week, "As a new business owner, I've really enjoyed the camaraderie and the feeling of being uplifted by fellow entrepreneurs in the GROW 'Small Steps, Big Results' workshops. The monthly workshop has given me the confidence, contacts and support network I need to run a successful business."

Other Projects/Collaborations/Participation:

- We participate in a variety of programs and events throughout our area each year. Some of these workshops, meetings and collaborations in the past 11 months include:

- o Rep. Sherrie Sprenger's Scio Resource Fair
- o Keizer Sustainability Summit presenter
- Oregon Microenterprise Network conference this group has also been providing in-depth market research for some of our clients
- o Rural community revitalization research
- Facilitating Stayton-Sublimity Chamber of Commerce Strategic Planning sessions and Board Retreat; and the Silverton/Mt. Angel tourism collaboration meeting

New Initiatives:

- We are launching a Young Professionals group on Thursday, June 5, which is open to entrepreneurs, key employees and civic leaders who are under the age of 40 and who live or work in our service area. Our hope is that making connections between folks in this age group will inspire larger projects region-wide, further anchor the investment these young people have made in our communities, and provide an active forum for them to do business their way while bringing a fresh perspective to economic development in our area.
- The board recently voted to become a **KIVA-Zip Trustee**, a crowd-funded 0% loan program for entrepreneurs that is gaining traction in Oregon and other parts of the country. We plan to launch this program in the fall after we create our endorsement committee this summer. KIVA loans are funded by micro-lenders, often in the hometowns of the entrepreneurs. Our role is to set criteria for recommendation, endorse candidates to KIVA-Zip, and help selected entrepreneurs reach out to virtual networks to attract lenders. KIVA loans have worked especially well for entrepreneurs who cannot or do not want to go through traditional lending avenues; they also help build community commitment to and investment in local businesses.

Upcoming Projects:

• We are researching larger economic development programs that would have a wide reach around our region, including Advancing Rural Prosperity's Community Entrepreneurship Accelerator (the next iteration of Home Town Competitiveness) which helps build four pillars of sustainability in communities (Leadership, Entrepreneurship, Youth Engagement and Wealth Retention) and which would leverage and build on the work being done by GROW and others in our area, and WealthWorks NW, a program that helps a region access existing resources to build a value-chain around a particular industry that has clear market demand, such as tourism or specialty forest products.

The City of Keizer is proposing to expand the Salem/Keizer urban growth boundary by approximately 58 acres for park land at Keizer Rapids Park. 38 acres of land is inside the city limits of Keizer but outside the UGB. 20 acres of land is both outside the city limits and outside the UGB.

Once inside the UGB, the city intends to begin a master planning process to identify future uses at the park.

The city has held two public hearings on this proposal, one before the city's planning commission and one before city council. On May 5, 2014, after the Keizer City Council took testimony from interested persons, the Council approved the proposal.

The City of Salem is also considering the UGB amendment. On June 9th Salem held a public hearing and took testimony on the proposal. Salem city council subsequently approved the proposal and is scheduled to concur in the amendments by ordinance by the end of June.

On May 7, 2014, the county adopted a resolution to initiate consideration of the amendment and schedule public hearing for today. The county must review proposal because it affects rural land that would be brought into UGB and coordinates a population forecast for Keizer for 2032.
