### Summary of presentation:

- Ms. Butler has approximately 30 years of experience in social services including:
  - o Domestic violence therapist;
  - o Adolescent alcohol and drug treatment counselor; and
  - o School counselor.
- She has volunteered on the committee since 2019.

# Revisions to Policy 518 and Procedure 518A Drug and Alcohol-Free Workplace

### Summary of presentation:

- The drug and alcohol policy and the drug and alcohol procedure were last updated in 2018;
- The primary changes include:
  - o Formatting;
  - o Grammar; and
  - o Updates to web links.
- Added a definition for "breath alcohol test"; and
- Updated directions for accessing The Guide, a tool for supervisors if they have a reasonable suspicion.

## Board discussion:

- The updates bring clarification, primarily to the procedure:
  - There have been changes in testing facilities;
  - There have been changes to The Guide; and
  - It was brought into alignment with specific requirements of a bargaining unit agreement in regards to alcohol testing.
- Supervisors and managers who recommend testing for reasonable suspicion consult with Human Resources:
  - Two managers have to agree.
- Legal has reviewed the updates;
- Commissioners Willis and Bethell do not want the training requirement for the assessor removed;
- Situations could arise where an employee needs to be dealt with and there is no county trained employee available; and
- Training was interrupted due to COVID.

#### **Revisions to Policy 502 and Procedures 502-A, Driving on County Business** -Justine Flora, Kyle Wonderly

## Summary of presentation:

- A definition section was added;
- Policy language was moved to the procedure;
- The primary reason for making the revisions are the points requirements for being qualified to drive for Marion County have changed;
- The primary reason for the policy is to ensure safe driving and that employees are responsibly using county vehicles, and their own vehicles when on county business; and
- The county self-insures for auto liability.

### Board discussion:

- The points requirements changed:
  - Good applicants were not being hired for open positions that require driving due to the current point system:
    - Changes were made to the requirement that an applicant has at least five years of driving experience; and
    - Tickets received by applicants are looked at for infraction type.
- Risk Management and Human Resources have helped departments determine if driving is actually an essential job function when job descriptions are being reviewed;
- Employees are required to carry their own liability insurance to be able to drive for the county:
  - Commissioner Bethell would like to understand if this is a state requirement or a county requirement:
    - If it is a county requirement, she would like it eliminated.
- Insurance goes with the vehicle in Oregon; and
- The policy needs to be clarified to state that if an employee is driving their own car on county business, they need to have their own liability insurance.

## Wildfire Update

## Summary of presentation:

Chris Trussell:

- Building is continuing in the canyon, but has slowed down a little due to the weather;
- Currently at 45 percent of anticipated rebuild for residential properties;
- Only three commercial buildings have been rebuilt, including the community center and a church;
- Contract Services is looking at the Intergovernmental Agreement for the fire hardening grant program;
- Educational outreach is going to be done on how to maintain the life of a septic system; and
- Public Works would like to do a full fee waiver for commercial property rebuilds:
  - The number of commercial facilities is small.

## Board discussion:

- There is a resident on the North Fork who cannot afford a required geotechnical analysis:
  - The analysis cost from \$3,000 to \$8,000;
  - The analysis determines how far back from the bank the rebuild can occur; and
  - The Service Integration Team can facilitate finding funding for the property owner.
- Oregon State University extension services has an individual who gives seminars on living on wells and septic systems:
  - It would be good to have a third party providing this educational outreach in the canyon.

### Kevin Cameron:

- Attended the House Wildfire Recovery committee meeting:
  - Several speakers brought up continuing with a Wildfire Recovery Ombudsman:
    - The current ombudsman is retiring in March.
  - The county needs to submit a list of outstanding needs to the committee;
  - The wildfires occurred across the entire state, not just the canyon; and
  - The committee will be holding a public hearing next Tuesday:
    - Individuals can sign up to testify.
- Consumers Power Inc. has staked out their underground power in Detroit; and
- Ziply Fiber is working in Detroit:
  - Need to find out if Ziply Fiber and Consumers Power are following the Dig Once policy:
    - A request would have to be directed by the City of Detroit.

<u>Jan Fritz:</u>

- Attended the House Wildfire Recovery committee meeting:
  - The City of Gates is requesting money to buy land to lease back to downtown businesses.

## Summary of presentation:

Katrina Rothenberger:

- Health and Human Services (HHS) has discontinued providing work release letters to employers:
  - HHS has not been receiving a lot of requests for the letters;
  - A press release is going out;
  - The HHS webpage will be updated; and
  - Letters are still being provided to county employees for COVID leave.
- HHS distributed home test kits that were received from the Oregon Health Authority.

## Board discussion:

• All the Chamber of Commerce groups in the county should be given the press release.

## Legislative Update

## Summary of presentation:

- The Commissioners were provided a report that lists everything that is up for public hearings this week;
- The funding for childcare providers to provide new childcare options has not found a home in a bill;
- The forest bills will have their public hearings February 2, 2022, and February 3, 2022;
- The Commissioners were provided with updates on House Bill 4063; and
- Bills that are coming up this week:
  - House Bill 4002, prevents mandatory overtime for agricultural workers;
  - House Bill 4061, water resource allocation;
  - Senate Bill 1573, forest thinning;
  - Senate Bill 1582, fire protection districts;
  - Representative Hoy's state land for housing bill; and
  - House Bill 4140, public meeting bill.

## Board discussion:

- The Commissioners would like to send a letter against House Bill 4002;
- The Commissioners would like to track House Bill 4140; and
- Commissioner Bethell would like to have a letter written opposing the childcare bill:
  - She opposes the bill the way that it is currently written.

o HHS will have to do a contact investigation.
