TITLE	Authorization of Director's Designees
Background	Shall the board approve an order identifying authorized director's designees? County Mental Health directors and their designees are authorized to initiate a director's custody and to direct police to take a person with a serious mental health condition to a hospital. The Board of Commissioners must approve those individuals authorized to direct the police to take a person with a mental health challengs to a hospital. Periodically we need to update the list; adding new employees at the Psychiatric Crisis Center (PCC) needed in this role and deleting those who are no longer employed at PCC. Before being recommended to be authorized, potential director's designees become familiar with statute and rules governing director's custody and demonstrate proficiency on a written test.
