TITLE Appointment of Wayne Rawlins as Chair and Kyleen Zimmer as Vice-Chair of the Marion County Parks Commission.

Issue, Description & Background The Marion County Board of Commissioners formed the Marion County Parks Commission by order on September 16, 1958. The commission consists of seven voting members who serve four-year terms appointed by the board of commissioners. At the parks commission meeting on March 21, 2019, the commission nominated and voted unanimously to recommend that the Marion County Board of Commissioners appoint Wayne Rawlins as chair and Kyleen Zimmer as vice chair of the Marion County Parks Commission. Mr. Rawlins is retired from the Oregon Parks and Recreation Department. He is a Salem resident and has served on the commission since October 17, 2012. Ms. Zimmer was previously the Assistant Director for the Oregon Parks and Recreation Department and is now employed at the Oregon Health Authority (OHA). She is a Silverton resident and has served on the commission since June 7, 2017.

Options for Consideration: 1. Appoint Wayne Rawlins as chair and Kyleen Zimmer as vice-chair of the Marion County Parks Commission. 2. Not appoint Wayne Rawlins as chair and Kyleen Zimmer as vice-chair of the Marion County Parks Commission.

Recommendation: Public Works recommends that the Marion County Board of Commissioners appoint Wayne Rawlins as chair and Kyleen Zimmer as vice-chair of the Marion County Parks Commission for two year terms, to end May 31, 2021.
