Transportation Package Review

-Commissioner Danielle Bethell

Summary of Presentation:

- Comprehensive review of proposed transportation funding bill
- Key concerns include:
 - Multiple taxation mechanisms.
 - Fuel tax increases.
 - Weight mile tax.
 - Road use charges for electric and commercial vehicles.
- Proposed changes include:
 - 15-cent gas tax increase on July 1st.
 - Additional 10-cent increase next year.
 - 5% inflation adjustment after 37 years.
 - Potential per-mile tracking for vehicles.

Board Direction:

- Draft testimony opposing certain taxation provisions.
- Emphasize opposition to:
 - Dual taxation on gas and electric vehicles.
 - Arbitrary fuel tax increases.
 - Lack of transparency in funding allocation.
- Protect the county's 30% transportation funding allocation.
- Highlight fiscal responsibility.
