- Paige Clarkson (RESTORE Court):
 - o Program focuses on non-violent offenders with restitution.
 - o Total referrals: 81.
 - o Potential participants: 47.
 - o Criteria include:

- Non-person crimes.
- Clear substance use disorder connection.
- Potential for rehabilitation.
- Ryan Matthews (Treatment Engagement):
 - o RESTORE Court referrals: 31.
 - o Active treatment participants: 20.
 - o Deflection hotline referrals: 14.
 - o Treatment engagement: 7 individuals.
 - o Highlighted growing program effectiveness.

5. YOUTH VIOLENCE UPDATE & JUVENILE CRIME PREVENTION PLAN

Summary of presentation:

- Increasing gang activity observed.
- Juvenile detention at highest capacity in 8 years.
- Key concerns:
 - o Youth involvement in robberies.
 - o Guns on school campuses.
 - o Gang-related incidents.
- Family Support Program highlights:
 - o Targets youth ages 9-13.
 - o 3 family support specialists.
 - o Aims to serve 168 youth annually.
 - o Focuses on early intervention.

7. JUSTICE REINVESTMENT GRANT APPLICATION

Summary of presentation:

- Programs to reduce recidivism.
- Key achievements:
 - o 5,400 months of prison usage avoided.

- o 72% reduction in prison use.
- o 24% drop in three-year recidivism rate.
- Programs include:
 - Prison diversion.
 - o Resource center.
 - Specialty court support.
 - Student opportunity programs.

8. DEPARTMENT OF PUBLIC SAFETY STANDARDS AND TRAINING (DPSST) OVERSIGHT

-Steve Webster

Summary of presentation:

- Oregon State Police (OSP) identified in two problematic areas:
 - Stop Outcome Analysis.
 - Search Findings Category.
- Experienced statistically significant disparities in stops and arrests.
 - o Latino Individuals.
 - Native American individuals.
 - Black individuals.
- Root Causes of Data Issues:
 - Heavy involvement in downtown Portland.
 - o Significantly more pedestrian stops than typical for OSP operations.
- Data Collection Errors:
 - o "Unknown" option incorrectly used.
 - o Troopers required to select race by personal perception.
- Corrective Actions Implemented:
 - o Comprehensive internal memo issued.
 - o Mandatory online stop program training for all troopers.
- Transparency Requirement:
 - DPSST must report intervention details to Local Public Safety Coordinating Council.
- Specific reporting required for OSP as their headquarters are in Marion County.
- Outcome Goal:
 - o Improve data accuracy.
 - o Reduce demographic disparities in policing practices.
 - o Enhance overall transparency in law enforcement data collection.
