# Proposed Second Amendment to the Private Development Agreement for Public Road Improvements with East Park, LLC Contract #PW-4927-22

## Summary of presentation:

- This is a large subdivision between Auburn Road and State Street within Salem city limits;
- The first amendment was done in the beginning of the year;
- The developer reached out two months ago stating there are delays getting equipment for permanent signalization at Auburn and Cordon Roads;
  - This is a condition under the current agreement for the Phase Four plat;
  - This releases 80 lots for construction to begin in the next phase;
- An alternative plan has been in the works with the developer to get the Phase Four Plat recorded to continue construction and have signalization occur in phases;
- The second amendment includes the following;
  - A temporary signalization with wooden poles and aerial lines;
  - A permanent signalization will be constructed in 180 days;
  - The developer provides a performance bond worth three times the construction cost;
    - If something happens this covers construction of the permanent signalization; and
- This will allow the developer to continue while getting the signalization needed.

# **Board Direction:**

- It is three times less expensive for a private company to install signalization;
  - $\circ$  The cost isn't necessarily more but there is a cost to collecting the bond.
- The developers legal counsel agreed to the three times;
- The developers are working as quickly as possible but there are delays; and
- This will come to board session on consent in September.

# Transportation Planning/Feasibility Study Grant Opportunity: Rural and Tribal Assistance Pilot Program

## Summary of presentation:

- Asking to submit three feasibility study grant applications for the following;
  - River Road North and Brooklake Road;
  - Silverton Road and Howell Prairie Road;
  - River Road South and the low clearance bridges where trucks get stuck;
- The grant will accept 10 to 20 applications this year;
- This seems to be a feeder grant for construction grants;
  - This may increase the odds of getting further construction grants;
- The cost of the feasibility studies is as follows;
  - In the first year it will be between \$160,000 to \$320,000;
  - In the second year it will be up to \$360,000;
- This is a federal grant;
- The signs on River Road are obvious and the turnaround point goes toward Brown's Island;
  - The difficulty is that Browns Island requires a lot of backing up and trucks are using driveways to turn around;
  - Part of the feasibility study is having something that actively detects;
    - This has been investigated for years, but it is very expensive.
- There are signs on Kuebler Road before Liberty Road;
- River and Brooklake Roads are struggling with capacity issues;
- Silverton and Howell Prairie Roads are struggling with capacity issues;
- The bridges on River Road are low clearance;
  - These issues have had difficulty in finding other grants to help them;
    - $\circ$   $\,$  This helps start the competitive process when grant opportunities come up;
    - $\circ$   $\,$  Safety grants are easier than capacity grants to come by; and
- These areas are either not in the Salem-Keizer Area Transportation Study (SKATS) jurisdiction or did not score high enough.

# **Board Direction:**

- The signs on River Road are on Salem's right-a-way are obvious and the turnaround point goes toward Brown's Island;
  - The difficulty is there is much backing up and trucks are using driveways to turn around;
- The Board of Commissioners (BOC) is good to proceed.

# Proposed Placement of Septic System Components in the Taylor Park Road Right-of-Way

#### Summary of presentation:

- A month ago, a grant easement was to be proposed to the property owners;
- The owners and septic vendors are having trouble finding a spot to lay the system;
  The area needs to meet standards;
- The well is one foot into the property line and the foundation for the well shed is in the right-of-way;
- There are not many areas to place the drain field;
- The drain field must be 100 feet away from the well;
  - But with wildfire recovery rules this can go down to 50 feet;
- The parcel is on basalt bench;

- The property was previously two properties but has since been combined;
- The drain field was on the other side of the retaining wall;
  - This is next to the river and cannot be there;
- The drain field can be either in the corner or in the pocket of the two well setbacks;
- The wastewater specialist met the owners and septic installer, measured the drain field and outlined it;
- Stakes were set for a potential easement to place the drain lines;
  - $\circ$  The owners asked for a larger easement than what was needed;
- There is suitable soil, but it is in the right-a-way;
- The available space is on top of the basalt;
  - $\circ$   $\,$  The basalt can be worked and a seepage bed placed on top;
  - Specific soils would need to be brought in to do the work;
  - This is an expensive option;
- The owners are eligible for the Residential Septic Grant, but the cap is \$50,000;
  - The seepage bed and all its requirements would be more than this;
  - The owner already paid for the surveyor;
    - They can be reimbursed for this through the Residential Septic Grant;
- Costs may need to be brought down to where they are covered;
- After researching the feasibility and easement of the area there are issues;
  - Taylor Park was deeded to the county;
  - The county owns the right-of-way and fee simple;
  - The deed has a restriction that is limited to public road use;
    - The area legally cannot be granted for anything other than road use;
  - An option is a limited vacation defining the footprint and vacate that rightof-way;
    - It will become an unencumbered parcel;
    - The cost is about \$1,500, this is public property, the homeowner would have to pay for the parcel;
      - A negotiated sale may be done;
    - The parcel will be created, conveyed, and then become the owners;
    - 10-foot setbacks at every point of the field from the parcel boundary it can be used;
    - A property line adjustment may be needed to combine the two units;
      A drain field over a property line can be a problem;
- The septic grant is broad, and this may all be covered but it is a long process;
- Taylor Park Road may widen to a two-lane road, but it will not be anything more;
- The grant will pay a large portion of locating the field on the ballast but there will be significant out of pocket costs;
- There was no discussion with planning regarding sale of a vacated portion the county will be fee title holder of;
  - There may be concern of a unit of land being conveyed to the neighbor; and
- This should be done in six months.

- Per the resident the septic and well were in the same area next to the road;
  The well has been in there since the 1990s;
- Per the resident they never met with the septic installer, the contractor did;
- The owner is frustrated and would like to know where to place the septic system;
  - $\circ$   $\;$  She does not want to move the well that in place for a long time;
  - $\circ$   $\,$  She also does not want to pay a surveyor again; and

• The BOC is good to proceed with the first option.

## **Oregon Health Authority Choice Model Services Intergovernmental Agreement #HE-4614-22**

# Summary of presentation:

- This is the second request as the first ended June 30, 2023;
- Counites are negotiating with the OHA regarding IGA's and funding;
- The Choice Model serves those with severe and persistent mental health illness;
  This covers the gaps in service for individuals in Medicaid;
- This contract doesn't shift the burden from the State Hospital to the county;
  - The new contract being negotiated is monitored and there is a meeting;
- It will be presented to the board on the consent agenda in two weeks;
- Individuals are covered as long as needed;
  - The work begins when they are hospitalized;
    - The Exceptional Needs Care Coordinator facilities discharge planning;
  - It covers those in licensed care systems;
    - Length of stay depends on needs;
    - Some move on in a few months and may go to supported housing;
      The housing program is covered by choice dollars;
  - The goal is for individuals to live as independently as possible in the community;
- There are those on Medicaid but some services are not covered by Medicaid;
  - Certain barrier removals for supportive housing;
  - Subsidy payments for rent;
- A few on Medicare or Indigent have services that are not covered, and they have coverage through this program; and
- The agreement is to the end of the calendar year and a new contract is being negotiated.

# Summary of presentation:

- Marion County receives a biennium allocation from the Juvenile Crime Prevention Basic and Diversion funding;
  - This is part of the Oregon Youth Authority biennium budget;
- A portion of this money funds the Guaranteed Attendance Program;
  This funding is to be done retroactively for July 1, 2023;
- It is late because the Oregon Youth Authority was finalizing their budget;
- The funding is slightly less than before as a reduction was chosen; and
- This covers 43% of the staffing for the Guaranteed Attendance Program.

#### Summary of presentation:

- This is a continued discussion from last week's meeting;
- The funding is from congressional appropriation for disaster relief;
- The following changes took place per the BOC direction;
  - The letterhead was changed on the grant application;
  - The spreadsheet of project categories was removed;
- The application needed to be submitted in November;
  - Senator Jeff Merkley gave pressure to submit before the new federal fiscal year;
- The application needs to be submitted this week; and
- The application is bare and after funding is secure detailed amendments will be submitted.

# Summary of presentation:

- The packet includes the individuals that applied and for what position;
- Some individuals are reappointments;
- There are positions that expired on July 31, 2023;
- The Volunteer Application included is filled out by all who sit on an advisory board for the county;
- A supplemental question asked how the applicant plans to communicate the board's discussions with the group they represent;
  - Would like the BOC recommendations as there is a MCPSCC meeting today;
    - As well as prepare board orders for the earliest board session available;
- Two applied for the city councilor/mayor position;
  - Julie Hoy;
  - Aumsville city councilor Douglas Cox;
- Tim Mcloud applied, and would like to serve either on the MCPSCC or Parks Board;
  - He has not submitted the supplemental question;
  - This would be an additional member at large position;
  - The parks board usually invites applicants to a meeting and see the interest;
- There are at large positions that are opening next year which are staggard;
  - Chris Baldridge was the only applicant for the School District Representative;
    - All school superintendents were contacted through email, twice;
    - There were two individuals that reached out;
- The full board meets once every quarter, and the executive council meets monthly; and
- Shaney Starr is applying for the member at large position it does not indicate if she is representing Court Appointed Special Advocates (CASA).

- Tim McCloud didn't submit the supplemental question so won't be appointed;
  Brian May has his parks application;
- Julie Hoy has shown interest in public safety as a city councilor and business owner, this is her second time applying;
- It would be good to not have the group grow bigger;
- Everyone must apply even if they are previous members;
- Would like to see the attendance list of those reapplying;

- Would like to see what city each member represents;
- There are that need to be assessed when regarding the applications;
  - Those on the council because of their role in the public safety system;
    - School setting, hospital setting, the sheriff, etc.;
  - Those that have the geographic component;
  - $\circ$   $\;$  Those that are interested and invested in the public safety system;
- Chris Hoy was city councilor of Salem and has a background in public safety, parole and probation, and reentry;
- Douglas Cox to be appointed under the city councilor position;
  - He needs to realize that he will need to communicate with all city councilors;
- In 2024 the positions will have to be looked closer in to;
- Those filling specific roles need to inform their peers across the county;
  - $\circ$   $\,$  Commissioner Willis will let Douglas Cox know this; and
- The BOC is good to proceed with all appointments other than Tim McCloud.

# Summary of presentation:

- Oregon Department of Transportation (ODOT) requesting a letter of support for a project on I-5 near Kubler Road;
  - They would like to expand four lanes into six lanes;
  - This is ODOT's number one priority and the only one they are applying for;
  - They are funded for the southbound widening;
  - This is for the northbound widening;
  - There are cost savings in doing south and north widening at the same time;
    Similar to Donald Aurora which was about \$5 million in savings;
  - Phase one of construction is moved from September to early next year;
  - This goes down to Delany Road;
- The meeting with Representative Tom Andersen has been set up;
  - Legislative priorities for short session; and
  - Funding opportunities.

- ODOT Letter of Support the BOC is good to proceed;
  - The meeting with Representative Tom Anderson;
    - Commissioner Cameron will leave a little earlier;

  - Mid-Willamette Valley Area Commission on Transportation (MWACT);

# **OTHER**

Commissioner Willis - Road concerns;

- Stayton Road citizen concerns;
  - Carl spoke with her, and she would like a no pass area in front of her home;
  - Road analysis was done and there is a meeting today with the analyst;
  - The road and Fatal and Serious Injuries Crash maps were observed:
    - Once all the data is analyzed the board and citizen will be updated;
    - There is a two-year lag with the maps;
    - The problems clumped around Rainbow Road;
    - This was discussed with residents as they see more of what happens;
    - The map will highlight which locations are more problematic;
  - $\circ$   $\,$  There were crashes in front of the resident's home, and her fence was taken out;
- Cascade Highway North of Sublimity intersection;

- This is a Marion County and Oregon Department of Transportation (ODOT) intersection;
- The Highway Safety Improvement Program All Road Transportation Safety Program (HSIP ARTS) was applied for;
  - This is money that comes through ODOT;
  - A feasibility study was started to look at alternatives;
    - The project would take many right-a-ways;
      - A home could be lost;
    - The cost benefit did not score high enough;
  - There needs to be serious and fatal crashes to be eligible for ARTS;
    - The project was eligible, but the cost was too high;
    - There was a benefit for the low severity accidents; and
    - Need to have fatal or serious injury.

Salvador Llerenas, Jeff White, Cheryl Carder, and Jane Vetto – Paid Leave Oregon (PLO);

- There were questions about what can and cannot be done;
- Would like to share the proposed policy so it can be sent to the union for review;
- Allowing augmenting with benefit accruals? depends on the situation;
  - If Oregon Family Leave Act (OFLA) and Family and Medical Leave Act (FMLA) are taken at the same time this is allowed as they are under designation;
    - Both allow employees to take paid leave;
- Those are not under the OFLA FMLA designation then it is permissive;
  - They have not been employed with the county 90 days, but their previous job earned them more than \$1,000 in leave;
  - They have been employed more than 90 days, but OFLA FMLA has been exhausted;
  - While they are out they will be getting the accrued vacation, sick time and two paid holidays;
- An employer is notified an employee is taking PLO by the employee giving 30-day notice if there is policy in place asking for this;
- Under Paid Leave Oregon the statute does not discuss how to find out what employee benefits are;
  - If an employee wants augmentation part of the policy needs to be the employee disclosing what the benefits are;
  - Have a form asking what is being received from the state so the correct augmentation amount will be provided;
- Under short term disability the employee is allowed to augment or not;
  - The same type of form will be replicated so it can be declared;
- Currently split pay checks received on an automated payroll system tax base off the annual tax table and then calculate too bi-weekly;
  - The annual gross is the same;
  - The split checks are two tax tables and there is a reduction in taxes;
  - Biweekly there is extra money;
  - At the end of the year, it will have to be paid;
- This could be reduced by augmenting to net instead of gross;
- Net pay would not be 100% as you would then get taxed on the net amount;
- Under the law the employer's contribution to health insurance must continue;
  - $\circ~$  There is a provision stating an employer can recoup the employee's health care contribution by;

- The employee writes a personal check to the employer;
- Under Bureau of Labor and Industries (BOLI) 10% arrears can be collected on checks until it is paid back;
- Paid Oregon Leave will give a certain amount of money but if wages are more this will limit how much can be augmented to not exceed regular net pay;
- Can try to work out what the average net take home is and coordinate with Human Resources to ensure augmenting is being calculated at that amount;
- The unions need to be notified of the policy 20 days for Marion County Law Enforcement Association (MCLEA) and the other unions are 15 days;
- The year starts in September;
- The county system will be apart from Paid Oregon Leave six days and it will be corrected July 1, 2024;
- Starting August 14, 2023, employees can start requesting PLO and it can be used starting September 3, 2023;
- Some positions pay higher because of overtime worked and the pay is selfreported for PLO;
  - Paystubs will also reflect the overtime worked;
  - Employees need to report wages not including overtime;
- There will be two different forms;
  - When FMLA and OFLA is requested, it will ask if PLO will be requested;
    - It can't be required to do this but there will be knowledge of who is;
    - The employment department will give notice is someone has filed;
  - If the employee wants to augment there will be a second form to say yes;
- All leaves will be done concurrently;
- The policy can require that the employees inform they are going on PLO;
- Base pay is the posted salary steps;
- The first six month of a new employee they begin to accrue sick leave and PLO can be requested if \$1,000 was earned elsewhere;
  - The employee will receive the accrued sick leave pay and PLO;
  - For this period there will be a cap for 100 percent;
  - Sick leave accrual and a paycheck from the state that is 60 percent of the pay can be received at the same time;
  - Current employees will not have this problem; and
  - The amount will be low.

- Put together various scenarios of what can happen;
- The notice will be sent to all unions at the same time;
- Want to ensure that the language is clear;
- Augmentation will happen only to their base salary;
  - If more money is made, then the base augmentation can't happen;
- When the policy is sent out a draft of the form to be signed should be included;
- Augmentation will not happen beyond the base pay;
- Augmentation will not happen if an employee is just on PLO;
  - They are entitled to accrue sick leave;
- Worker's Compensation can be looked at another time; and
- The process for new employees will not be corrected as the accrual amount is low.

Chad Ball – Tax Statements;

 The assessor's office stated that tax statements will be going out and they would like to know if the board wants to include an insert;

- In the past it has been a white 1/3 of a page document; and
- This needs to be ready and printed by September 20, 2023.

- The flyer should have general information;
- What does the aggregate breakdown of the tax revenue look like;
- If possible, have the wildfire recovery areas have the grant information;

#### Jane Vetto - Salem Payroll Tax;

- Salem was fighting with petitioners on which election the tax would go on;
- The position is if everything is done by August 9, it will be on the November ballot;
- There are over 10,600 signatures;
  - There have been those not from Salem that have signed the petition;
- The city of Salem is stating that it should be on the May election;
- If signatures are verified within 15 days this will be on the November election;
  - $\circ$   $\;$  This will be done on time; and
  - This is being verified by the Clerk's Office.
