# **Legislative Update:**

-Alvin Klausen

- List of bills that were passed or died with notes to clarify summaries/impacts on the County;
  - Bills that the County was following closely are highlighted;
- Update on Timber and Behavior Health from Pac/West laying out a strategy on how to move forward with the Oregon Department of Forestry regarding the Habitat Conservation Plan (HCP);
  - This will dramatically affect timber sales and revenues;
- Large summary of behavioral health bills and where they ended up from Pac/West;
- Mosman letter was sent to the Governor and Oregon Health Authority's (OHA) director Baden;
  - o Commissioner Willis gave a physical copy of the letter to the Governor;
    - Small dinner with 6 attendees with the Governor;
    - Mosman was brought up at the end of the conversation;
    - Let the Governor know there seems to be movement to a resolution;
    - Concerned with Community Mental Health Programs (CMHP) contract with OHA;
      - If people are diverted from the State Hospital, there needs to be an objective standard as to who would be in community restoration;
        - The State Hospital thought there are those who are safe in the community that the County disagreed with;
        - Medication and keeping people in can't be forced;
      - Community restoration docket has increased from 20 to 60. On pace to get 80 and already funding a position to monitor people in parole and probation.
        - Contract could cut funding, and the OHA does not seem willing to negotiate reasonable allocation of risk;

- If it isn't funded and the risk managed the program will end, and people will be harmed;
- The Governor was receptive and was briefed on the negotiations;
  - The two asks were helpful as she moves forward;
- The letter has been sent but sign-ons are still being taken for future reference;
- Kirby will in Oregon July 10<sup>th</sup> to the 14<sup>th</sup>;
  - Commissioner Cameron suggested a canyon tour on July 11<sup>th</sup>;
  - Chris Eppley (Community Services Director) and Brian Nicholas (Public Works Director) are willing to give updates on projects in the Canyon;
  - Will ask the federal delegation if they would like to be part of this;
- Received email from Madison Moskowitz from Senator Wyden's office;
  - Setting up a call on Housing and Urban Development (HUD) vouchers and Fair Market Rates within the County;
  - Commissioner Bethell requested this call;
- Reached out to Annaliese Dolph in the Governor's office to schedule a meeting on behavior health issues and community restoration;
  - Trying to set something up before Commissioner Willis leaves;
    - If not, will push out to August;
- Letter to the City of Salem regarding the complaint about Salem Campground and RV;
  - Health and Human Services found discrepancies in the previous letter;
  - Would like signatures for the new letter today.

• The Board of Commissioners (BOC) is good with the update.

# Oregon Land Use Board of Appeals (LUBA) remand of Legislative Amendment 22-003 / Home Occupation Events Code

**-**Lindsey King, Cody Walterman

- April 2022 met with citizens and the BOC to discuss creating an event code under the Home Occupations section;
  - Would allow for certain things;
    - Weddings;
    - Family reunions;
    - And other larger events;
- June 2022 BOC initiated the consideration of the amendment to the zoning code;
- August 2022 adopted the amendment;
- September 2022 the decision was appealed through LUBA;
- February 16, 2023 LUBA issued final opinion remanding decision to the County;
- Need to consider the 5-employee limit and the 750-person maximum allowed at each event;
- There are 4 assignments of error at LUBA, and one was remanded;
  - Maximum guests available for businesses;
  - o The code is written as 750 maximum. Anything over is a mass gathering;
    - A different type of permit would be required;
  - LUBA stated though there is no limitation in the statute, that this was modeled after, there is not substantial evidence on how the 5-employee criteria can feasibly serve 750 people;
- There are a few options to resolve the assignment of error;

- Remove the 750-person maximum, adopt the criteria the statute does, and the applicant would produce evidence on how their employees will serve;
- The statute states you can have 5 employees, this has been interpreted by the courts that there can be more than 5 but only 5 on the property at a time;
  - o The courts did not decide how many people 5 employees can serve;
- If the limit is removed each person will state how many guests and can be supported by how many employees through the permit application;
  - They will also show how it will be done;
  - This will then be reviewed and decide if it is reasonable;
  - Will be based off;
    - Building codes;
    - Different locations;
    - How many people can actually be served at the location;
  - The change is removing the 750-person limit and minor changes in the language of the maximum quest limit;
    - There is no express limit, the criteria is the 5-employee limit at one time and adopting different provisions stating the fire code is being followed regarding quest limits;
- Remand stated there was not substantial evidence to support the decision;
- If public hearing is open to the issue and the BOC's decision is to go forward and adopt the evidence and findings;
  - This would likely be a path forward to resolve the issue;
- There will be no significant impact on staff review;
  - The applicant is required to provide evidence on how the 5-employees will support the number of guests;
    - Relies on building occupancy as there is an 80% indoor requirement;
  - The number of guests is dictated by the Fire Marshall and building codes;
  - Evidence will need to be provided;
    - Number of employees;
    - What employees are doing;
    - How many people are allowed for every event;
  - This will be simple and will not add difficulties to workload and review time;
- 5 employee limit is already in the amendment;
- The state statute is an expressed limit, and it can't be modified;
  - o The courts have interpreted it as there are 5 employees on the property;
    - Additional employees can be on the payroll but only 5 can be present at the event;
    - You cannot contract for services without including contracted staff in the employee limit.
- Building occupancy analysis needs to be done, as it is in statute;
- 750 is the maximum is if there was a building that could host the amount and meet the building/Fire Marshall codes;
  - Events larger than 750 would trigger a mass gathering;
- Occupancy and the number of guests is dictated outside of planning code;
- Clackamas county has a maximum limit of 350;
  - o Another path is picking a new number and defend it with findings and;
- Staff recommends removing the limit and adopt the criteria like State statute.

• Look more into if someone was hired, like a catering company, plus your 5 employees and how that would work;

- The BOC wants to know the most successful route to get this done and;
- The BOC would like staff to amend the code and come back for a public hearing.

# Summary of presentation:

- Nathaniel Kravitz Psychiatric Health Nurse Practitioner;
  - Has been with Marion County over 10 years;
  - o In the Adult Behavioral Health Program;
  - o Primarily sees clients on the Psychiatric Security Review Board (PSRB);
    - Manages medications;
    - Attends PSRB meetings;
    - Clients have been convicted of crimes;
    - Superuser of the Electronic Health Record;
  - Works part-time, up to 21 hours per week;
  - \$155 per hour;
  - Contract is for two years;
  - Not to exceed the amount of \$400,000 for a two-year period;
- Dr. James Miller Psychiatrist;
  - In the Adult Behavioral Health Program;
  - Primarily is responsible for the treatment plans;
  - Has been with Marion County for over 10 years;
  - o \$196 per hour;
  - Works 36 hours per week;
  - Not to exceed \$500,000 for a two-year period;
  - He specializes in medications and;
    - He is the go-to for questions relating to medications.

# **Board Direction:**

- The BOC would like to see this on consent at Board Session and;
- The BOC is good to proceed.

# Oregon Health Authority 2023-2025 Intergovernmental Agreement (IGA) #180023 for Financing of Public Health

-Katrina Griffith

- The new Public Health IGA includes bridge and one year funding;
  - o The program element number is related to the contract program element;
  - There is a description of what the program element is;
  - Service code;
  - Period of awards;
    - First quarter, 7 months, or the full award;
  - Annual budget;
    - How much the County budgeted;
  - Bridge contract amount;
  - o Forecast to see if it's in alignment with what was budgeted;
    - Close to what was budgeted compared to what is received from OHA;
  - Things can change slightly because of the end of the legislative session;

- Do not know all of the carry-overs;
- Some things will carry over into the next fiscal year;
- Have a new line item. 51-05 Public Health Infrastructure Funding;
  - New funding from the Center for Disease Control (CDC);
  - Can be spent on public health workforce;
  - Flexible and can be spent through 2027;
- Received \$1,500 that can be used for training;
- May have more funding;
- This is bridge funding to get through September 30<sup>th</sup>;
- Regional partnership implementation is the regional modernization work with Polk County;
  - o Commissioner Craig Pope asked for Katrina to call him directly;
- The template was reviewed and worked through by Legal Counsels, who review IGA's for counties;
  - They had some concerning cost allocation language included;
    - It was removed as the County is able to do their own methodology;
      - The State was to cap at 10% as it was confusing for the counties;
    - There is work with OHA on cost allocation through the next biennium to get understanding among the counties on how to allocate costs.

- Commissioner Bethell will look through the information and;
- Commissioner Cameron stated the Commissioner Craig Pope of Polk County asked Katrina to call him directly.

# **Salem Fire Franchise Agreement & Map Amendment**

-Katrina Griffith, Matthew Neuvenheim

- Plan was approved with boundary and response time changes;
- The ordinance went into effective 90 days after the public hearing;
- Everyone was notified;
  - Heard that there were concerns;
- Boundary change that Turner requested;
- Fire and Emergency Medical Services (EMS) would be out of two dispatches;
  - This causes delay and rerouting;
- Met with Turner and let them know that if Salem felt the same way;
  - Salem agreed that this is an issue;
- Looking to revert back to what it was;
- Willamette Valley Communications Center (WVCC) would dispatch Salem Fire and EMS;
  - There would be no delay;
- Turner is dispatched out of Metcom;
- Turner Fire handles Turner;
- The area would have had Turner for EMS and Salem Fire for fire;
- Turner cannot have the fire and ambulance service as fire district boundaries would need to be changed;
  - This is not defined by the County;
- North of Aurora will be monitored to be possibly changed to rural 1 instead of 2;
  - Aurora Fire stated it was 1 and changed to 2;
    - This is not the case it has always been 2;

- It was marked incorrectly on maps in 2012;
- Aurora Fire is the responding agency for fire;
- Had meeting with Salem Fire to go over the new franchise agreement;
  - Offered/Sent several proposed language;
    - Most of it can't be agreed to;
      - Only the date of when they report to the County is agreed to;
  - They had issue that the County wants to know their fines and liquidated damages;
    - Can be known through public record request;
  - Stated if the County wants them to do something everyone needs to do the same;
    - Let them know the contract is the same for everyone;
  - Stated if they intentionally withheld information the County could revoke their Ambulance Service Area (ASA) franchise;
    - The County can already do this;
      - Changed from a list of monetary damages to revocation of franchise;
  - The intention is not taking money but to understand what is going on;
    - The same thing is done with all the others;
    - Would like and need visibility;
  - o Public hearing and application are needed for renewal of agreements;
  - Would like new agreements effective January 1, 2024;
  - Application process opens July 6, 2023;
    - Timeline ordinances of when applications can be submitted;
  - Recommendation will be brought to board session for the renewal;
  - o There will be a public hearing;
  - o It would be brought back to board session;
  - The County signs first;
  - o There is a timeline in place and there needs to be a response in 30 days;
  - Application timeline for submittal is July 6<sup>th</sup> to August 4<sup>th</sup>;
  - There is not much room for movement in the language they requested;
    - Will propose back the date change in which they report their information as the last day of the month;
  - o Did not like the fact that Katrina would be part of the selection process;
    - Want language that states ASA Plan Administrator and not Marion County;
    - Marion County has jurisdictional authority;
  - Greg Hadley is a spokesperson for the group;
  - o There will be communication through email only at this point;
    - The meeting was not conducted in a professional manner;
  - Would like to know what the amount of the fine that the County takes;
    - Let them know that it was 50% to 100% and;
    - Stated they sometimes do not fine in a particular month.

- Keegan Murphy need clear articulation of the differences of the contract lines wanted and contract lines Salem Fire is asking for;
  - o Outline for public hearing for the purpose of easy response to the public;
- Let them know that the County is not interested in pulling an ASA from a highly functioning and great organization;
  - Language needs to be consistent across all the franchisees;

- Would like to continue work with Falck;
- Make sure that the project is worked through backwards;
  - Public hearing should happen in late September;
- Let them know that the County is excited to continue to work with them;
- The BOC would like to leave in fines language goes into the agreement;
  - Amount of the fine can be negotiated and;
  - Agree to find out what they think is a reasonable amount to be fined.

# Review the Price Agreement with Union Gospel Mission (UGM) for Subsidy Housing at the Restoration House for Sheriff's Offices Clients

-Commander Jay Bergmann

- This is a continuation of an agreement;
  - Had a price agreement the last biennium;
- Asking for, a not to exceed amount of, \$140,000 for the 2023-2025 biennium;
  - \$450 a month;
  - The amount has not changed since the last biennium;
- Have been working with this location for about 20 years or more;
- The house has changed hands;
  - It went to UGM about 7 to 8 years ago;
- Purchase agreements were previously used to pay for subsidy housing;
  - Went to price agreement last biennium;
- Contract states that subsidy housing will be provided to clients;
  - Does not state what Parole and Probation officers can do with the clients housed;
  - There were concerns of drug use in the homes;
  - Since the contract is vague it's difficult to have a dog search for paraphernalia and hold people accountable;
- Every house the County has an agreement with has their rules and requirements;
- The substance that the County has is not approving the subsidy;
  - Each individual subsidy is approved one on one;
    - \$450 for one client;
  - Generally, approve for 30 days sometimes 60 or 90 days;
  - If the appropriate results are not achieved the program will stop being subsidized, if needed;
- There is a program where communication with the house manager is going well;
- There are issues;
  - The house has beds for 47 clients;
    - With that many clients there will be some issues;
- Not aware of any major issues but can address with the house manager;
- The goal for the housing is that it is a good place for the clients;
- Request for Procurement (RFP) process for subsidy housing began several months ago;
  - This is an ongoing process;
  - It requires a site visit to the house;
    - Approved if the house is acceptable or not;
- The agreement is for two years, and it can be stopped at any time after that point;
- This is the only home where sex offenders can be housed;
  - Not many places allow this;
  - This is the primary location for this;

- Accept individuals straight from prison;
- Accept individuals in the community;
- Do not want people going where it will not work to help them;
- This is a system that works with a direct line of communication with the house managers;
  - If things are not working, they are informed that it will not continue being subsidized if they are not fixed;
- Each individual probation officer (PO) makes a request to the office manager for housing for a client;
  - o Clients state where they would like to go, or suggestions can be made;
  - o If the PO agrees with a subsidy it goes to the office manager, Peggy Lowry;
    - She keeps track of financials;
  - Have two Program Coordinators that maintain regular contact with all the programs;
    - Including the subsidy housing and;
    - There is contact every 60 days.

- The contract has no substance in what can be expected of UGM, the clients, how the clients are managed or the cases they have;
- There needs to be accountability and the contracts need to be the same for every person interacted with;
- Not interested in subsidizing an organization that helps people continue bad behaviors;
- The BOC is good to proceed but believes there can be a better process and;
- Matt Lawyer will set up a meeting to go through the process in more detail.

# Dr. Solanky Adult in Custody Dental Services, Contract Amendment

-Lieutenant Kate Abraham

- Amendment in contract between Sheriff's Office Jail and Dr. Solanky;
  - Provides services to adults in custody;
- Current contract runs through June 30, 2024;
- Proposal is to add \$150,000 to the contract;
  - The grand total would be \$360,000;
- This would cover;
  - o Diagnosis;
  - Consultations;
  - Treatments;
  - o Referrals;
- Dr. Solanky recently became the jail Dental Director;
  - This is required for the jail;
- Dentists governing agency would be the Oregon State Dental Board;
  - Contact the Board;
    - Have a 4-year contract;
    - Have had two- and four-year contracts in the past;
      - Have also had 2 dentists in the past;
- Dr. Solanky has been a good provider and is consistent;
- Secondary dentist had some difficulty and ran into some problems;
  - Had to check in with the Oregon State Dental Board;
- Make sure that they are in good standings;

- For nurses as they are Marion County employees all the background checks are done by the County;
- Dr. Solanky is an outside provider;
- · The regulatory Board makes sure credentials are in order and there no complaints;
- There are treatments outside the scope of emergent dental procedures;
  - o Patients go to outside offices that specialize in specific work;
  - Dr. Solanky does;
    - X-rays;
    - Fillings;
    - Extractions;
    - Evaluations;
- Board of Nursing does check on nurses;
- There is, at least, an annual check of pharmacies;
- The Nursing Board has contacted the Sheriff's office to check in and review;
  - There is a Nurse Practitioner and doctor that oversees the nurses and comes in several times a week;
  - Supervisor is also a registered nurse and;
- This is paid for out of the General Fund as Medicaid does not pay for any services inside the jail.

- The BOC is good to proceed and;
- Alvin Klausen to see if there is a waiver, through Medicaid, that can help pay for this.

# Fair Event Coordination and Marketing/Sponsorship Request for Proposals -Kelli Weese

# Summary of presentation:

- Potential next steps for the two contracts for the fair;
- Preliminary review of the RFP's to be presented August 1<sup>st</sup> Management Update;
- In the Fall the Fair Board recommended not to do a year extension and to go out for procurement;
  - That are held by Ingalls and Associates;
  - o The BOC recommended to postpone this decision until after the 2023 Fair;
- Have two RFPs drafted and reviewed by the Fair Board;
  - Put together by a sub-committee of the Fair Board;
  - This was done last week;
- Extend the Ingalls for one year or to issue the two RFP's;
  - This will be done after the fair and;
  - There will be preliminary numbers after the fair.

# **Board of Commissioners Office Paid Internship**

- The packet includes an issue brief and a timeline until May 2023;
  - What the pay is;
  - The contract with Corban University;
  - What the process is;
  - What the duties are;

- Who will supervise the intern;
- Chad Ball County Operations Manager;
  - Should be the supervisor, in addition to Jan;
- The intern will work directly with the policy analysts at the direction of the BOC;
  - Assisting policy analysts and commissioners;
    - Projects;
    - Meeting coordination;
    - Administrative clerical function;
- Jan Fritz reached out to Human Resources (HR) to see discuss the rate;
  - The rate is \$16.54 per hour;
  - Typically, a higher rate than Clackamas County is not done;
  - New rate schedule depends on their educational experience;
- Professional internship is someone who is licensed but in school;
- New classification was created defining;
  - College intern;
  - Graduate intern;
  - Professional intern;
- The BOC office would be the lowest level as normally it would be college level;
- The graduate piece is for the health department;
- The pay is set for the July 1<sup>st</sup> minimum wage increase;
- This route will be temporary employees and a contract with the university is not needed;
  - They will be treated as a temporary employee and go through the HR hiring process;
- Working with Sherry Linter;
  - o There is a database that universities use where the position can be posted;
- The internship will be based on the length of their terms;
- An intern can do the maximum of 10 hours during a school semester;
  - During breaks can go up to 20 hours and;
- Someone can come in and shadow for a week, without pay.

- Do not raise the base pay by two to three dollars above minimum wage;
- Do not compare this internship to the health department internship;
- Remove the professional pay step and;
- The BOC is good to proceed.

  - Speak to AJ and get a list from him and then speak to the BOC;
  - o The BOC to see what bills had what impact on the County, good or bad;
- Alvin Klausen to give a list of bills that passed and, on the Governor's desk and;
- The BOC is good to proceed with the write up.

- Call from resident last night;
  - Further discussed in the other section under "Max Hepburn and Lani Radtke";
- Lunch last week with Director Bell from OHCS;

- Council of Governments meeting;
- Missed East Salem Service District (ESSD) meeting;
  - Heard it was not the most positive meeting;
  - o Per Commissioner Cameron and Commissioner Willis was good;
    - Further discussed in the other section under "ESSD Meeting";
- Met with Ryan Flynn at the Canyon;
  - Further discussed in the other section under "Met with Ryan Flynn at the Canyon";
- Toured Oriole House two homes for women in Keizer that were funded by the County;
  - Meet exactly what the expectations are;
- Matt had meeting on Friday on the ordinance for roadside fruit sellers;
  - There is an ordinance in place already and;

- Travel Salem Board of Directors;
  - They are disappointed;
- Detroit City Hall meeting;
  - With the Governor;
    - Why she is upset is further discussed in other under "Commissioner Bethell";
  - The word is the meeting was positive;
  - o Got an email from the Governor's wildfire spokesperson;
    - Has not followed up yet;
- New Employee Orientation (NEO);
  - Full, many temps and;
  - o Very impressed how Public Works is doing recruitment for potential engineers;

- Ride-A-Long with David Black;
  - Full time building inspector after the fires;
  - Up the Canyon the little North Fork;
  - Went on roads that have never been on;
  - o Knew all the stories about the homes and the people in the homes;
  - o For 2 years, worked 10-hour days to get everything done for the wildfires;
    - Had to stop because of the emotional toll;
  - Most educated on all the homes there;
  - Sat and listened to the people's stories;
  - Did a few inspections and;
  - Mentioned that the team needs to be thought of when calling in sick.

### **Commissioner Colm Willis**

- Attended Jobs Council via Zoom
- · Meeting on Business Impact Study with Rich Duncan;
  - Pleasantly impressed;
  - Hungry for what the County is doing;
- · Radio Interview with Ken Cartwright;
  - Wanted to know about the money being spent;
  - When the North Fork Park will be open;
- Tea with the commissioners;
  - Felt real and engaged;
  - Professional meeting;
  - Many civil enforcement officers were there;
  - Good conversation:
    - Measure 110;
      - Further discussed in the other section under "Clackamas County
        Measure 110";
    - How to deal with drugs and;
    - Enthusiastic about new ordinance.

#### **OTHER**

Sam Brentano - Treasurer;

- There is problem with credit card processing in certain locations;
  - Transfer stations;
  - Health areas;
- The processing company takes monies in and holds them and then distributes them;
  - In the hold it is being done in a non-collateralized bank;
- Under State statute, losses held are directly attributed to the County Treasurer;
  - The \$1,000 a month that is brought home will break even in 6.5 years;
- Point and Pay (system used) has looked at it and states it should not be a worry;
  - o It is a worry to the Treasurer and should be to the County;
  - What if the banks fail first, or at least the non-collateralized ones;
    - It will be a write off and it will be gone;
- Spoke to US Bank who offers services with modern techniques and higher fees;
- It is a minimal transition, a one-day process;
- Treasurer cannot take a personal liability on something that can be changed easily;
- The current system is the one that was used by all the counties in Oregon;
  - Seeing something better;
- Not sure what the process is and if there is contract for the current process;
- Letting the BOC know this will be pursued and does not think it will be a problem;
- Sounds like an easy conversion;

- Bring on the new system for half a day;
- Go through any bugs;
- Turn the switch and it is done;
- Before 2017 only had to use collateralized banks for funds that could be controlled;
  - o The legislature changed the statute to include the word direct and;
  - o The funds can be directed, and this is where the exposure is.

• The BOC is good to proceed.

# Alvin Klausen - Covanta Bill;

- The bill was watered down in Covanta's favor;
- 18,000 tons of medical waste;
- Continuously testing for 15 elements;
  - States technology feasible which is only 5 elements;
  - Currently Covanta tests for 4;
  - The other 9 are not technologically feasible;
    - As they become feasible, they will need to be tested for and;
- The only impact is if they wanted to grow the facility which is something the BOC did not want.

# Commissioner Bethell - spoke to citizens in Sublimity;

- They were upset that the BOC agrees with the facility;
- They are upset that the air is being polluted;
  - If it doesn't end up in the facility it goes into a landfill and still gets in the air;
  - The public needs to be educated on what actually happens;

# Jane Vetto - Humane Society meeting;

- Chris Eppley and Jane attended;
- The Humane Society stated their legislation was dead and nothing can be done to support it;
  - There were too many detractors;
  - They believe they can get it passes next year;
  - Jane and Chris agreed both can support;
- Would look at what the Humane Society would submit next legislative session;
  - May be fine with it if it was similar to what it was before;
- What can be done in the interim;
  - They are currently accepting;
    - Baby kittens;
    - Old, sick cats that are euthanized;
  - They are not taking a vast majority of adult cats;
    - Local shelters are upset;
- Asked what can be done to support them;
  - Vet care;
  - Some sort of grant;
  - Small amount of money to help take in and foster the cats;
- They do not foster but spay and neuter;
  - o The BOC should give \$390,000 to the Humane Society;
- Polk County does not run a dog shelter;

- Would not take dogs if the Memorandum of Understanding (MOU) was not signed;
- Would the BOC like to do a small grant for the Human Society;
- The Humane Society has changed their mission;
  - They do not keep animals;
  - They are currently about education;
  - Spaying and neutering and;
- Multnomah County has many organizations to step in and close the gap;
  - Marion County does not have this, so the pressure is felt;
- Can foster cats or help in that aspect.

- This is not a taxpayer issue millions of dollars in donations come to the organization;
- What is the cost of spaying and neutering dogs on an annual basis;
- · Are there are organizations that can be partnered with;
  - Commission Bethell can speak to Sarah at Salem Friends of Feline;
  - Aumsville Animal;
  - Silverton;
- This is not the County's problem. Everything that could have been done has been;
- Let the shelters/rescues know the County is statutorily required to take on dogs;
  - The County cannot take on another thing and;
- The BOC does not agree with giving \$390,000.

#### Commissioner Kevin Cameron

- Salem Keizer Area Transportation Study (SKATS) today;
- 2 things on the agenda;
  - o Keizer needs money for Verda Lane, everyone agrees;
    - Because of inflation costs;
    - Marion County received money for its project;
  - Aumsville needs to come into SKATS;
    - The process is the governance structure of SKATS;
      - Who is a member;
      - Who is represented and;
  - o A vote should be added for Aumsville.

#### Commissioner Bethell

- The Governor was upset with Jackson County concerning the wildfire recovery;
  - Bruce Wood and Tom bought 144 units of housing;
  - Ryan from OHCS is returning every unit;
    - \$26 million loss;
    - They are not livable;
      - Walls are not straight;
      - Pipes don't align to ground connects;
      - Electrical is off;
      - Roof is wrong;
  - The Governor is very upset;
  - The \$422 million is not being impacted;
    - Money is being pulled from another program to cover the costs;
  - All the units must be reordered;
    - Many people are still in motels;

- Max Hepburn and Lani Radtke were in talking about changes in procedures regarding driveways;
  - Received call from resident in Keizer off Perkins Road;
  - Max has visited the home, twice;
  - Steve Johnson is the builder;
  - His home is being expanded;
  - Long time resident and homeowner with a concrete driveway since 2012;
  - Informed his permit will not be processed until he rips out his driveway and turns it into asphalt because the BOC is passing some new rules;
    - The BOC was under the impression that the opposite would happen;
    - The builder had a follow up yesterday;
  - Call was received last night from resident stating this is very costly to him;
    - Unless there is a new driveway everything will be grandfathered in.
      Asphalt and gravel are the preference, going forward but there are exceptions;
    - There is a condition that a waiver needs to be signed stating that the County it not liable if there is damage to your driveway along the right-a-way;
  - The road has been paved twice since the concrete has been in place and there have been no issues;
  - It needs to be clarified that they waiver was signed;
  - The waiver has not been read by the BOC;
  - He was also told to move his mailbox, which has been in place for 40 years;
    - The right-a-way was measured, and the mailbox is not in the way based on the 21 feet from the center of the road;
  - An email will be sent to Max with the BOC included;
- Lunch last week with Director Bell from OHCS;
  - A bill that passed in 2021;
    - Stops the sole allocation of specific dollars to community action agencies going forward;
  - There is a work group;
  - The 2023-2025 biennium priority focus is the redirection of funding to other resources in the communities, specifically in regions;
    - Deal with what historically community action agencies have done;
  - o Commissioner Bethell stated she would like to have a seat at that table;
- ESSD Meeting;
  - She was told she would be kept in the loop;
  - When ESSD began there was 32 road deputies and had 28 of them;
    - Down a few positions;
    - Added 10 more deputies;
    - 60% of the calls were coming into ESSD;
    - Would have 2 Full Time Equivalents, all the time;
    - The 10 deputies would be there to help;
  - Instead, the 10 deputies are going out as there is not enough staff;
  - Costs are rising faster than revenue;
  - Per Glenn there are vacancy savings;
  - There is no need to be billed more as there has not been payment for 40 deputies but only 22;
  - o There are questions about the savings, but they should be accounted for;
  - Fees should not be raised as savings should be accounted for;

- Let them know that they would rather have 40 deputies and raise rates;
- Train deputies do engage with the public and say hello;
  - They stated they are short staffed, and this is difficult to do;
  - Some deputies may feel that others are not doing their job if they are driving around saying hello;
- o The Sheriff needs to know it is good for a deputy to wave, and help cats;
  - But this is easier to do with 42 deputies than 25;
- Staff can be reassigned and out in the community;
  - These things can be given for brainstorming and ideas and;
- Can work in their cars out in the community and be seen;
- Met with Ryan Flynn at the Canyon;
  - Oregon Housing and Community Services (OHSC) Disaster Recovery Wildfire Manager;
  - The \$422 million will be released within the next 6 weeks if not sooner;
  - There are two primary programs;
    - HARP
    - Homeownership Opportunities Program (HOP);
  - The focus has been shifted;
    - Would like to give the County the HOP money;
  - HARP landowner owner, to owner occupied housing;
  - HOP renter to owner occupied housing;
    - Can take renters and make them home-owners;
    - Buy the land, build the home, buy the home, and place them there;
  - o Analyzing allotments will know in two weeks what the allotments are;
  - This will create major capacity issue;
    - Will need to become case managers;
    - Can't give to Service Integration Teams (SIT) they don't have the qualifications;
      - Per OHCS;
  - Maybe able to subcontract some of the work;
    - Home Builders association;
    - Long Term Recovery Grant (LTRG);
  - Will need to decide in 6 weeks;
  - Figured out how to get access for all the date with Jeff Gilbert with ODHS;
    - Will be sending their Release of Information (ROI) language to put in the application for everyone that is currently case managed;
    - This must be opened up to every wildfire survivor;
  - There are two hurdles:
    - Send a letter inviting all eligible individual to enter into the case management system;
      - Or reopen the case for evaluation for access to HARP/HOP;
    - Have Legal Counsel work with the hospital to go to the system and have the hospital get an ROI from everyone in their system;
  - Market making sure that everyone who can have access to this is captured;
  - The money is all income restricted and there are many federal requirements;
  - The Housing Authority seems the most competent to do this;
    - It is the County's decision;
    - Federal requirements of Area Median Income (AMI) must be followed;
    - People must be placed into owned homes;
  - With the HOP, the \$18 million that is for Santiam Meadows;

- Jason Icenbice liked the idea;
- Not sure if it can be \$30 million;
- There are two concepts he would like it to be diligent about;
  - He gives money and the focus is Santiam Meadows;
    - Everyone is goes to Mill City even if they are from Detroit or Gates;
  - Scatter site development;
    - Will need to evaluate what will be done at Santiam Meadows;
- PEER Money funds previously allocated
- There is \$12 million that has been difficult to get going;
- May take the HOP/HARP access and place people into the HARP program;
  - If they prequalify;
  - If entered the way the County's system is done there should be no delay;
- Can look at infrastructure investments with \$12 million;
  - As long as it leads to housing there would be more money;
- o Got into the education of grants versus loans;
- This is a healthy thing for the community;
  - Needs to be thought out;
  - Do not want this assigned to Public Works;
  - Jason Icenbice does not have the relationships;
    - Takes direction from the BOC;
- This has been worked on for three years;
- Need to be clear what the BOC's direction is;
  - Community partners need to do the work and;
- Will go after the data to validate any allocation received.

### Clackamas County - Measure 110

- Being worked on by Commissioner Ben West of Clackamas County;
- An analysis needs to be done on what they are doing;
- Putting two advisory questions to the voters;
  - Would they like Measure 110 repealed;
  - Is it good to legalize drugs;
- There is no impact of this;
- Cost \$400,000;
- Have a conversational session with Clackamas County BOC to see if there is any work that could be partnered with or duplicated;
- They are doing other things regarding homelessness;
- They are doing actionable things;
  - Expending money;
  - Community work and;
- The board session was on June 7<sup>th</sup>.

• Alvin Klausen to look in further what is being done and talk to Commissioner West.

### Commissioner Willis - The City of Portland;

- · Looking to ban open drug use;
- Interested in seeing the ordinance and;
- Is this something Marion County can do.
