## **Water Update**

#### **Board Presentation:**

- Chad attended the GSI, Council of Water Leaders, meeting quarterly. Gives information to take back to leaders. The reservoir is a full pool, not anticipating it going to lower levels;
- Snowpack is better than most years;
- Dam Study should be completed by 2025. With outcomes and resolutions to be completed in 10 to 15 years. The study is on if a seismic event were to occur how to prevent the devastation of a dam breach;
- EIS looked at all 13 dams in the Willamette Valley, BIOP reported (study will be completed by 2023) that procedures needed to be done to protect fish, Recent studies show that procedure like draining the dam by October has no benefit to mixing;
- The Army Corp does not anticipate having to drain the dam again, specifically to save fish;
- Reallocation of the stored water behind the dam has a new person in charge;
- ODFW is coming up with an operations plan, looking for allocation contracting;
- There is a lot of information coming up with water rights, that may need legislative action; and

#### Tanisha Bush:

- Attended first Community Action Agency Meeting, they are excited to know that the Commissioners will be more in the know;
- CAA would have higher numbers if UGM and Family Promise do not count their beds/people in the continuum of care program to count them they have to log a lot of information. According to Mr. Jones, they are not ok with doing that yet;
- Went over the strategic planning update, and how they are going to monitor and track their goals;
- They have a COLA;
- They need bus drivers, and would like to implement an exemption to allow them to offer bonuses to help fill positions;
- 3.8% of their staff is administrative, they may want to change their structure of finding more administrative help;

### **Commissioner Danielle Bethel**

- Toured Hope Pregnancy Clinic, with Katrina and Ryan. Terry Morgan did follow up and worked out a plan to help pregnant moms that are potentially in crisis for addictions:
- Looked to see if there was funding for a caseworker;
- Toured HIS Place, may need to hold an open house, and welcome neighbors and open dialog about the services;
- Had a conversation with Ryan Flynn and John Wright, from OHCS, about the Mill City sewer project;
- They also discussed that the CDGBDR infrastructure money will be going to the county to decide what to do with it;

- Meeting with Ryan Matthew, Josh, and Jill from CCS, to share about CCS, to potentially become a community partner for housing funds;
- Commissioner Bethell and Cameron went to Silverton to meet with the Police Chief. Had lunch with officers, and then went on a hospital tour; and
- Commissioner Bethell will be testifying to the Housing Stability Council, asking them to fully fund the Gate Tiny Home Project.
