INFORMATIONAL:

Review the Incoming Funds IGA with the Oregon Department of Corrections for Expenses Related to Community Corrections Supervision/Services

-Mike Hartford

Summary of presentation:

- This is for the 2023-2025 biennium;
- The creation of local control through SB 145 in 1995 gave local county's control and responsibility to supervise those on parole, post-prison supervision, and probation;
- County's commissioners and public safety coordinating councils must approve community corrections biennial state plan;
 - A letter of support will be asked for and attached to the plan;
- Funding for community corrections comes from the state, administered by the Department of Corrections;
- The plan shows how funding will be spent over the two years;
- Funding comes from a formula based on a rate of the following;
 - Per client, per day on supervision;
 - An allocation is received based on percentage of clients under supervision in the county;
- The last biennium 2021-2023 there was 2,800 funded clients representing 10 percent of the statewide allocation;
 - This was about \$27.5 million;
- During the last biennium population trended down, significantly reducing the state budget;
- Marion County's population dropped down to 2,500 clients but the allocation went to 11 percent which is due;
 - The county continuing to process cases during Covid;
- The county will receive \$26.6 million in funding as well as a one-time supplemental funding of \$622,000 for personnel costs;
 - This makes the total \$27.2 million;
 - The shortfall will be made up in a position not being renewed and vacancies savings;

- The Oregon Association of Community Corrections directors are going to legislature to discuss funding;
 - Funding has always been a challenge over the years;
- Based on population forecast probation trends are going up making the budget increase;
- The funding provides court services for the county, including;
 - Supervision of 2,800 clients on parole or post-prison supervision;
 - Program supports and services for the 2,800 clients;
 - Sanctions including jails beds;
 - Debt service to the public safety building;
- The goal is to reduce criminal behavior, hold offenders accountable, and assist offenders to change;
- Approval will help fund the benchmarks, retain staff, and hire good staff;
- Commissioner Bethell and Jane Vetto stated;
 - The IGA is not complete on the state's side, if the county signs then no extension is needed, and the completed contract will be sent after it is signed;
 - The contract states anything collected on prior supervision fees will offset what is received from the state;
- The state is removing the repealed ORS and adding any previous collected funds as funds can not be collected going forward to the contract;
- The updated contract should be uploaded into the system soon; and
- It was not noticed that the repealed ORS was in the contract until it was sent out and some counties signed it.

Board Direction:

- Need to discuss the allocation of the one-time personnel costs funding;
- Update the organizational chart to reflect the appropriate changes;
- Request an extension;
- Forward the finalized contract after the language has been updated;
- There is no need to come back to management update; and
- Bring a breakdown of the other category in the budget breakdown.

Implementation of HB 3955 (2023) Emergency Shelter Siting

Summary of presentation:

- The last two legislative sessions added into the statute;
 - There is a requirement that the county approves an emergency shelter when requested;
- The statute states the following;
 - Local government shall approve an application for the development of an emergency shelter including a youth, winter warming, day, family violence shelters;
 - If requested by an organization that has experience to do so;
- Certain criteria need to be met such as;
 - o It needs to be an entity with experience providing this type of service;
 - Must have sleeping and restroom facilities;
 - Meets building codes;
 - It may be in a urban growth boundary, a acreage residential or rural residential zones;
- This is not a land use decision;

- The county can hold a hearing but there is no requirement to do so;
- Any decision is appealable to the local circuit court;
- Salem responds when an application is determined to meet criteria;
 - The decision is not noticed and there is no hearing;
- Church at the Park's tiny shelters can be placed in unincorporated areas of Marion County if it is applied for under the statute;
 - It can be denied if criteria are not met;
- There are a few options Marion County can take;
 - o The board or hearings officer can make a decision on the matter;
 - Mr. Reich can be authorized to do so as well;
 - There can be a hearing;
 - This is not required;
 - This would be noticed like land use hearings are;
- The options are broken down as such;
 - The hearings officer can have a noticed hearing and make a decision;
 - The decision can get appealed to circuit court;
 - The hearings officer can make a recommendation to the board;
 - The board has a hearing, and make a final decision for the county;
- Per Jane Vetto the current process if a recommendation comes in is as follows;
 - There is an action item deciding if it is adopted, accepted or a public hearing scheduled;
- There is no timeframe involved in this process;
- There are building codes for sheds that individuals live in;
 - They need to meet dimension minimums;
- Not every proposal will meet the requirements for an emergency shelter;
- The current unsheltered population needs to be .18 percent of the state's population;
- Staff recommends the hearings officer makes a recommendation and the BOC holds a hearing;
 - This process can be changed later on;
- If the hearings officer makes a decision it won't get to the BOC as there is no appeals process; and
- Church at the Park micro-shelter location depends on negotiations.

Board Direction:

- When an application comes in a public hearing needs to be held;
- The process taken should be the following;
 - The hearings officer holds a noticed hearing;
 - A recommendation is made by the officer;
 - The BOC has a hearing and makes a decision;
 - The BOC's decision can be appealed to the circuit court;
 - o The BOC will be able to express the view of the community; and
- The building codes will be looked further into.

Participation in the Community Rating System (CRS) of Federal Emergency Management Agency (FEMA)

Summary of presentation:

- Marion County has participated in CRS since 1999;
- Residents have a 20 percent discount on flood insurance as CRS reviews county activities;

- Depending on credit amount given the discount rate is different;
- The program is comprehensive and there are tradeoffs to participate;
- The benefit is the discount, but a downside is development;
- Previously, the participation amount of flood insurance was increasing with savings of \$50,000 a year for all policies;
- This year, the amount insured dropped by a third and savings dropped by half;
- Maps are based on information from the 1960s;
 - Map amendments with individuals leaving the floodplain;
- If the loan is not federally backed no flood insurance is needed;
- A significant portion of individuals do not have flood insurance;
- The program is designed for a city to participate in the program;
 - o It is harder for a county to participate and get additional points;
 - Less dense, outreach hardship and layout;
- Clackamas County left the program in 2018 as it was difficult to participate;
- CRS grades on a curve and there are no guarantees;
 - Things change and there are seven reviewers;
- · Participating impacts customers;
 - o Previously, what was wrong was stated and asked to correct moving on;
 - o Currently, every year it needs to be shown that everything is done perfectly;
 - o A single error on a certificate leads to the removal from the program;
 - This causes many elevation certificates being needed throughout a single project for a final certificate to be ready;
 - FEMA, the state and CRS do not agree on how the process needs to be causing different feedback;
 - CRS is followed as they are most restrictive;
 - o Training is needed but a full training has not been offered for a few years;
 - Not all staff is trained;
- Significant staff resources are used;
 - Training to implement the program;
 - The county is involved in various work to get more points including;
 - Stormwater standards;
 - Natural hazard plans;
 - Outreach;
 - Significant Full Time Equivalent (FTE) is used every week;
 - Every five years all divisions of Public Works are involved;
 - Yearly renewal;
- Previously there was more savings compared to the staff time used;
 - Currently it has dropped and the return on the investment is not there;
- There is a potential savings of 10 to 20 percent on top with CRS;
 - The savings is \$300 to \$400;
- If the county leaves CRS individuals would need to pay an extra up to amount of \$50:
- There is large impact on new development as it takes longer and costs more;
- It is easier to do the FEMA program than FEMA and CRS;
 - Employees trained on the floodplain program and not CRS then there would be more employees available to help;
- If there is one error on a certificate there is one chance to fix if not the county is kicked out of the program;
 - The homeowner's insurance rating will be adjusted;
- FEMA can process errors with individuals on their flood insurance rates;

- Marion County has a few homes every year, so mistakes are not allowed;
- The county has succeeded for the last 20 years;
- The recommendation of the staff is the following;
 - Train more employees to work more efficiently; and
 - o Remove more individuals from the floodplain.

Board Direction:

- The BOC approves exiting the program; and
- This can go on consent next week.

Criminal Justice Commission (CJC) Grant Agreement

Summary of presentation:

- Every biennium Marion County circuit courts receive CJC grants to support the five specialty courts;
- The grant application goes through the Coordinating Public Safety Council and is approved by the BOC;
- Marion County Health and Human Services (MCHHS) is the fiscal agent and grant administrator on behalf of the courts;
- Bridgeway is the service provider;
- The total amount is about \$800,000;
 - There are administrative fees which are \$62,590 that are retained as MCHHS is the grant administrator; and
- MCHHS is responsible for contracting, Request for Procurements (RFP's), accounts payable, reimbursements, financial reporting, and other administrative duties.

Board Direction:

• The BOC is good to proceed.

Ordinance Amending the Marion County Personnel Rules

-Salvador Llerenas

Summary of presentation:

- A team of department heads met over several months and came up with considerations;
- The following changes were made;
 - The unclassified service list of positions;
 - Removed the deputy district attorneys;
 - Authorizes department heads to have alternative work schedules if it works for the business;
 - Between the hours of 6 am and 7 pm employees can work;
 - An employee can work four ten-hour days;
 - Work location was updated with remote work not being authorized as a regular option;
 - In isolated instances this can be approved;
 - Juneteenth is added to the list of holidays;
 - Sick leave conversion was added allowing classified unrepresented with at least 110 hours to convert into 24 hours of personal time off;
 - May be requested once a year and used in the year requested;
- This will come to board session September 20, 2023; and
- Notification was sent to all department heads.

Board Direction:

- Commissioner Bethell needs information on converting unused time off into a check; and
 - The order regarding this will be sought out.

Legislative Update:

-Alvin Klausen

Summary of presentation:

- Letter of support of the Payments in Lieu of Taxes (PILT) program;
 - Drafted to the entire delegation;
 - Emphasized long-term and reliable funding;
 - There is bipartisan support;
 - Pays for federal land in Marion County that is not taxed;
 - This is renewed every year;
- Legislative committee emailed about the house behavioral health committee meeting;
 - The topic will have 75 minutes of time;
 - County to use 30 minutes;
- Opal Creek Promise;
 - Agreements between Business Oregon and United States Forest Service (USFS) are signed; and
 - Senator Jeff Merkley wants to do a press release.

Board Direction:

- Letter of Support for PILT;
 - Change last sentence of letter;
 - The letter needs to have more substance and reflect the needs;
 - The BOC can then support the letter;
- Behavioral Health Committee meeting;
 - Ask for agenda order;
- · Opal Creek Promise; and
 - Commissioner Cameron will give a quote for the press release.

OTHER

Brian Nicholas Fire Update;

- There is an active fire at House Mountain north of the North Fork Road;
- One of two new generators caught on fire;
 - They were installed this summer;
 - It may have been installed incorrectly;
- The source of the fire is unknown;
- The generators were placed in a conic boxes of steel shipping containers;
 - Modifications were done to give proper ventilation;
- The fire has not spread beyond the conic box;
- It will take a number of days to get the site running again;
- METCOM 9-1-1 is operating without radio dispatch;
 - Dispatch is using cell phones, which is the backup plan;
 - The back up plan has been used before but there are no details; and
- Silverton Fire was the first to respond, potentially.

Board Direction:

Continue to update the BOC.

Matt Lawyer - Grant Program;

- There have been a little over \$600,000 in total requested funds;
 - The BOC upheld an appeal of \$185,000;
- An allocation of \$411,000 in grant funds;
 - Through five applications;
- Three of the applicants would like to accept the grant;
- There are no grants to review at this time;
- The committee recommended \$97,500 for the home;
 - After the home is built then furniture can be sought;
- Guideline comments and materials were sent to the Long-Term Recovery Group (LTRG);
 - The group is commenting on program;
- Checks are not being written but based on the work done; and
- Housing Inventory will be done next week.

Board Direction:

- The BOC approved furniture and appliances up to a threshold;
 - Not through checks but Purchasing (P) Card; and
- It needs to be clear that furniture can be asked for later in the process.

Brian Nicholas - Park Supervisor Position Update;

- Second round interviews for Park Supervisor are done;
- Well qualified candidate is Kevin Thompson;
 - o Currently Park Supervisor in Oxnard, California;
 - Worked from Field Maintenance to Direct Project Manager;
 - Previous job for 20 years at the Channel Islands Restoration in California;
- Met with candidate one-on-one yesterday;
 - Let him know of the challenges and opportunities;
- The right fit personality-wise;
- Matt Lawyer was part of the first-round interview;
- Chad Ball was part of the second-round interview; and
- Public Work staff spoke highly of the candidate.

Board Direction:

• The BOC does not need to meet the candidate before being hired.

Brian Nicholas - METCOM 911 Monthly Board Meeting;

- METCOM 911 has an intended funding and would like to know if Marion County would give them the dollars to build their own radio system;
- The project is four weeks out from being advertised if the board approves;
- Need to sit down with Chief Kyle McMann, the Sheriff, and Mark Spross of METCOM 911; and
- METCOM 911 stated they do not have the money to pay for user fees.

Board Direction:

• The BOC is good with the update.

Commissioner Danielle Bethell – Mayor Brian Gander of Gates;

- Met with Mayor Gander last week;
- Various topics were discussed;
- Mayor is concerned about residents being educated on costs of the sewer system;
 - Would like to see more effort on the county's part;
 - Host a service at the Firehall with various departments, specifically what is available right now and what's to come;
- There is \$600,000 for a curb/sidewalk, it is not done and there is a timeline;
- The previous city council wanted to develop a business district near city hall;
 - The county tried to get sources to purchase the lots;
 - About \$90,000 each and there are five lots;
- It has to go through land use conditions, but it is able to be done;
- There is money set aside from the reevaluation of dollars;
- Would like the BOC to consider this; and
- Nothing was promised.

Board Direction:

The BOC would like a presentation of what this would look like.

Brian Nicholas - North Santiam Sewer Authority (NSSA) Work Session;

- Discussed outreach to the communities;
- Asked NSSA to be more active they were on board when the effort put in was seen;
- Agreed townhall meetings in November should be the start of the outreach; and

o Townhall meeting will help with understanding of the project.

Board Direction:

• The BOC is good with the update.

Commissioner Colm Willis - Public Safety Coordinating Council;

- · Garland King has been on the council;
- He began working at the Marion County Juvenile Department in 2021; and
 - o This does not prevent him from serving but it needs to be approved.

Board Direction:

- Discuss with Troy Gregg (Supervisor); and
- Needs to fill the position and bring value.

Commissioner Danielle Bethell - Met with Juan Larios;

- Interim Superintendent of the Woodburn School District;
- Spoke on the youth challenges in Woodburn;
- Sent many connection emails;
 - Mr. Larios has met with many of the connections;
- Marion County offers a system of care with social and emotional learning support systems;
 - Woodburn is trying to implement this and help student; and
- If this works juvenile system may not be needed.
