A Message from the Clerk . . .

Dear Marion County Voter,

We look forward to receiving your voted ballot. If you have not received your ballot by May 8, please call us at 503-588-5041.

I encourage everyone, who is qualified, to register and vote. Please spread the word. You are qualified to register at 16 and vote at 18. After incarceration, all ex-felons are allowed to vote in Oregon.

Check your registration status at www.oregonvotes.gov and update if necessary.

Please be sure we have both your current residential and mailing address. This helps determine which of the 245 unique ballot styles to send to you. You can check and, if necessary, update this information online at www.oregonvotes.gov. Prospective voters with an Oregon Driver License or ID card can also register online by April 30 for this May District Election. Alternately, use the registration form on page 52 or 54.

If you wait until after May 14 to return your ballot, please use an official ballot drop site instead of the mail to assure we receive your ballot in time to count it. See the list of drop sites on pages 4 and 5.

We check every signature. If notified via mail, please respond to the letter or come to the Clerk's office to resolve any missing or non-matching signature issue by June 4 so we can count your ballot.

Please sign up today at www.co.marion.or.us/co to track your ballot with text, email or voice alerts. This allows you to know where your ballot is in the process and allows us to contact you quickly if there is a signature issue. We need to match each signature before we can open the envelope to count the ballot.

The United States Postal Service is offering a new service, Informed Delivery, where you receive an email with an image of your mail pieces to be delivered that day. With this, you will know when your ballot hits your mail box. To sign up for this service, go to www.informedelivery.usps.com.

Not all candidates have chosen to submit statements in this voter pamphlet. Nevertheless, you can find their candidate filing form, including experience and contact information at www.co.marion.or.us/CO/elections and clicking on "May 21, 2019 Special District Election".

Do you know of someone who, because of reading impairment or disability, needs voting assistance? Please contact us. We offer several options to help people vote privately and independently. Some are listed on page 6. We also offer large print and tactile ballots. This voter pamphlet is available in voice and text on our website. Independent Living Resources, 503-232-7411, will mail this voter pamphlet on USB thumb drive, CD or tape on request.

Thank you for helping make democracy work by being informed and voting. You are welcome to observe our election process. Call or visit for details.

- April 30 * Last day to register to vote.
- May 1 * Ballots mailed to voters.
- May 14 * Recommended last day to mail ballot for USPS delivery by Election Day. Postmark does not count in Oregon.
- May 21 * Last day to return ballot by drop box anywhere in Oregon before 8 PM.
- June 4 * Last day to resolve a missing or non-matching signature in time for ballot to be counted.

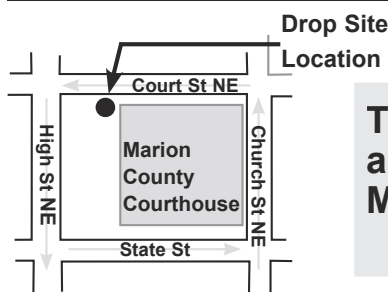

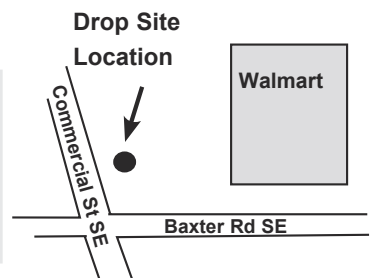

It should contain at least the following items:

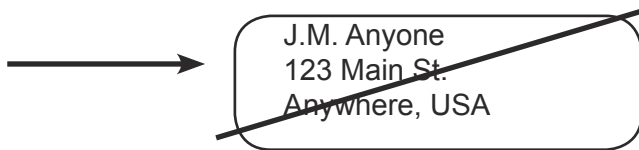
- Printed ballot

- Insert for Ballot Drop Sites

If any items are missing, contact Marion County Clerk - Elections.

Important Ballot Information:

If a ballot has been delivered to your address and it is addressed to someone who does not live at your address:

1. Mark through the address like this:



2. Return to your mailbox, post office or letter carrier.

Notify Marion County Clerk's Office Before Voting The Ballot Delivered To You If:

- Your name is different than that on the label; or
- Your residence address has changed; or
- You have added, deleted or changed a mailing address.

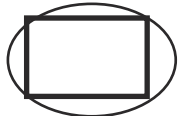
To make sure your vote counts:

- Use a **black or blue ink pen**.
- Completely fill in the box to the left of your choice.
- To vote on a measure, complete the box next to either the "Yes" or "No",

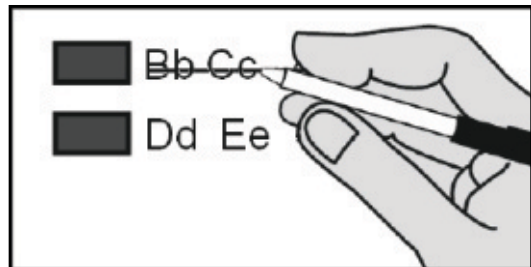
To Vote:

Use a black or blue ink pen to completely fill in the box to the left of your choice.



To Correct a Mistake:

Draw a line through the entire measure response or candidate's name. You then have the option of making another choice.



To Vote a Write-In:

To vote for a candidate not printed on the ballot, fill in the box provided to the left of "Write-In:", and print the first and last name of your choice on the line.



Important to Remember: Your Return Envelope must be Received by 8 PM Election Night or your Ballot will not be Counted.

A “random alphabet” is drawn by the Secretary of State for every election which determines the order in which the names of candidates will appear on the ballot.

To Marion County Voters: Salem Transit District Directors will no longer appear on your ballots. Senate Bill 1536, enacted and enrolled by the 2018 Oregon Legislature, changed the law so that the Salem Transit District no longer has Board of Directors elected by the citizens of the district; they will be appointed by the Governor. See the wordage from the bill below:

Per ORS 267.108 “(1) For a mass transit district formed under ORS 267.107, the Governor shall appoint members of the board of directors in accordance with ORS 267.090 and 267.095.

(2) Before making an appointment under this section, the Governor shall solicit recommendations of qualified individuals for the position from one or more local business and civic groups.

(3) Persons elected as directors of mass transit districts who are serving on the effective date of this 2018 Act shall continue to serve until the expiration of their terms of office unless discharged earlier by the Governor.”

What is Informed Delivery?

Informed Delivery is a new consumer-facing feature offered by USPS® that provides users with digital previews of their household mail arriving soon.

Informed Delivery is free and makes mail more convenient by allowing users to view what is coming to their mailbox whenever and wherever - even while traveling, on a computer, tablet or mobile device.

To automate the sortation and delivery of mail, the United States Postal Service® (USPS) digitally images the front of letter-size mailpieces that run through automation equipment. USPS is now using those images to provide digital notifications to users in advance of the delivery of physical mail.

How does Informed Delivery® work? What will I see?

Informed Delivery allows users to interact with their incoming mail and packages in one convenient, online location. Users receive emails containing images of the exterior, address side of incoming letter-size mailpieces. These images are also accessible on the Informed Delivery dashboard at informedelivery.usps.com. Some mailpieces (e.g., catalogues or magazines) may not be imaged by the automation equipment.

Users can also provide delivery instructions to USPS, manage their notifications, and schedule re-delivery from the dashboard. Users can also receive USPS Tracking updates for incoming packages via separate email or text notifications. The dashboard displays mailpiece images for a seven-day period.

What does Informed Delivery® cost consumers?

The feature is provided at no additional cost for all Informed Delivery users.

Where is Informed Delivery® currently offered?

Informed Delivery is now available to eligible residential consumers in the majority of ZIP Codes™ across the country. You can use the ZIP Code lookup tool on informedelivery.usps.com to see if Informed Delivery is offered in your area.

Who is able to use Informed Delivery® and are there limitations on participation?

The United States Postal Service® currently provides the feature for delivery points in eligible ZIP Code™ locations for which mail can be sorted on automated equipment; and where there is a unique delivery ZIP Code, down to the apartment level. Interested consumers must also complete identity verification to confirm they live at the address. As an additional security measure, a mail-based verification letter is also sent to the account address to give the customer the opportunity to remove the account if desired.

Is Informed Delivery® available to businesses?

No. The feature is available to residential customers and eligible personal P.O. Box™ addresses, but Informed Delivery is not currently available to business customers.

Signing Up

Go to informedelivery.usps.com and follow the step by step directions. You may also download or print a step-by-step **Informed Delivery Sign Up Guide**.

How soon after requesting the feature will I begin receiving notifications?

Activation time for the feature may vary, but typically you will begin to receive notifications within three business days. Notifications containing mailpiece images will be sent on days when letter-size mail is being processed and delivered to the home. Notifications are not sent on days when there is no mail to be delivered, or on Sundays or federal holidays.

Privacy/Security Concerns

How can I be sure that notification emails are from USPS® and not spam?

All emails from the Postal Service® originate from their mail system and the contents are strictly images of the mailpieces associated with the customer's delivery address. Email messages will be sent from USPSInformedDelivery@usps.gov to the email associated with an Informed Delivery user's usps.com® account.

How secure is Informed Delivery®? Should I be concerned about my privacy?

The Postal Service® takes the privacy of customers' mail very seriously and takes measures to ensure that all personal information is protected. USPS® follows industry best practices to verify your identity, including the use of a mail-based verification letter.

- The scanned mail images are of the external markings, showing only the exterior, address side of letter-size mailpieces.
- Your mail is protected by the U.S. Postal Inspection Service®, whose sole mandate is to safeguard the entire Postal Service® system, including the employees who deliver and process the mail and millions of customers who use it.
- The Postal Service adheres to the privacy requirements of the Privacy Act established by the federal government which controls when and how the USPS shares personal information and limits the conditions in which that information can be disclosed externally to outside parties.

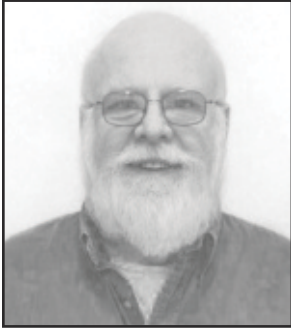

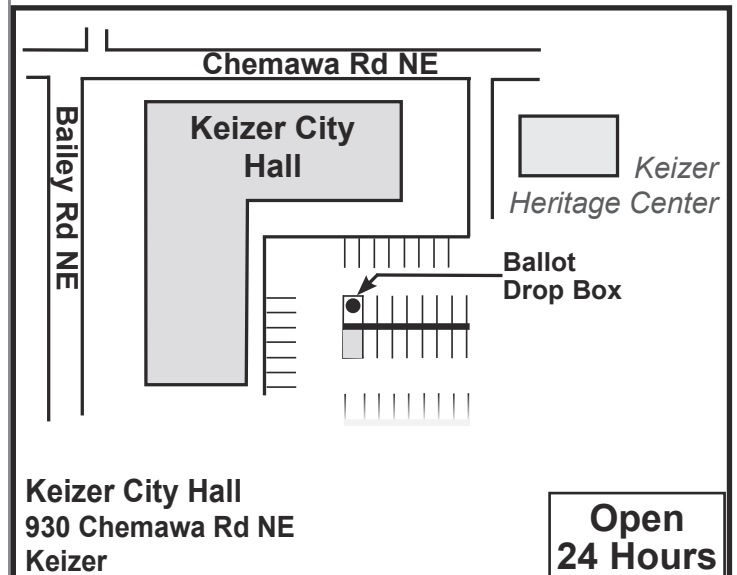

Can I Vote?

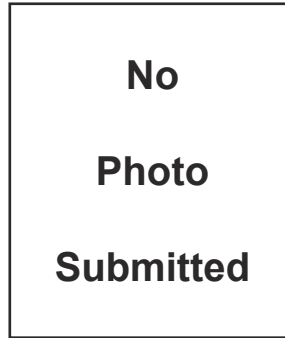

Five Year Local Levy for Hiring, General Operations and Equipment

Question: Shall AFRD replace current rate with \$0.99/ assessed value for five years beginning 2019, hiring EMT's/ Firefighters and enhancing operations? This measure may cause property taxes to increase more than three percent.

Summary: Aurora Fire District is seeking a five-year local option tax for general operations. Monies are needed maintain current staff of four and hire additional career EMTs/ Firefighters for emergencies. For the first time, this levy will allow the District to respond to calls 24 hours a day with a career Emergency Medical Technician/ Firefighters.

AFD responds to over 1000 emergencies a year, the amount of calls is stretching current resources. Volunteering is still an important aspect to the Aurora District, however times have changed and time demands on volunteers has become increasingly difficult to balance. Money will also be used to enhance current volunteer program, pay for general operating expenses such as equipment, supplies and repairs. This levy request will help ensure when you call us for an emergency, we will have a crew available to assist you. This levy does not add an additional \$0.99, it replaces the current rate of \$0.49.

The proposed rate will raise approximately \$920,945 in 2019-20; \$958,573 in 2020-21; \$977,031 in 2021-22; \$1,006,342 in 2022-23; and \$1,036,532 in 2023-24. The total estimated amount of tax to be raised is \$4,899,423

**Measure No. 24-438
Aurora Fire District**

Explanatory Statement:

Responding to over 1,000 emergencies per year, AFD provides Firefighting, Rescue and Emergency Medical Services (EMS) to residents within 64 square miles of Marion and Clackamas Counties. We protect the Cities of Aurora and Donald as well as the Aurora Airport, Champoege State Park and 20 miles of Interstate 5.

This levy is needed to maintain current operations and provide a career EMT/Firefighter as the officer in charge 24 hours a day. It will also allow us to make repairs, upgrade emergency equipment and enhance our current student and volunteer program.

Most of our calls for service occur when there are no career staff on duty. Currently, there are only 4 career employees on duty M-F during regular business hours. Once the business office has closed, volunteers and students are the primary emergency responders.

If you, or your loved one, experience a cardiac event, car crash or major emergency, a fire engine without a career EMT/Firefighter in charge is likely to respond. If your home is on fire, national mandates prohibit us from entering to extinguish the fire until a minimum of four firefighters are on scene. Between volunteers, students and career staff, the levy will allow us to quickly meet these standards and provide better service to the community.

The District has a group of well qualified volunteers who serve in all positions from Battalion Chief to our newest recruit. However, time demands on volunteer firefighters have reached a point where it is difficult to recruit, and more importantly retain, volunteers. Family life, job requirements and increased emergency calls have changed the face of the fire service both nationwide and locally.

The District recruits volunteers who live and/or work within the community and can respond to emergency calls. We also recruit "out of district" volunteers who may live anywhere throughout the Willamette Valley and sign up for shifts (generally 12-24 hours in length) in Aurora or Donald.

Our student program exists to provide staffing and a career path to college students. The District strives to maintain six student firefighters and place them on shifts (currently helping to ensure a minimum of two responders). They are among the newest and most inexperienced members.

What is the impact if the operational levy fails?

Our budget would be reduced by 37% making the current level of operations unsustainable. We would have to delay needed repairs, the purchasing of vital equipment and possibly reduce our current staff and student program. The priority of AFD will always be to serve our District and maintain timely emergency responses. However, without this levy, it would become increasingly difficult if not impossible.

Renewal of Five Year Local Option Levy for Emergency Service Operations

Question: Shall District impose \$0.68 per \$1,000 assessed value for five years beginning in 2019-2020 for general emergency service operations? This measure renews current local option taxes.

Summary: The Idanha-Detroit Rural Fire Protection District Board of Directors determined the need to requesting additional funding to provide fire and emergency service operations. The District's tax base is no longer sufficient to fund the ability to provide emergency services.

Service provision is hampered by increasing costs and increasing demands for service.

The District Board desires to be good stewards of taxpayer money while providing the best possible service for our communities. With existing revenues failing to fund adequate operations, the Board decided to ask the taxpayers to renew the 5 year option levy in order to maintain the proper level of emergency response services.

The District is contending with equipment failures due to age. The average age of our response equipment is 29 years old with one of our first out engines being over 48 years old. Replacement of this equipment is imperative, expensive, and this process will take time and money to accomplish. This levy would be a continuation of the levy approved in 2014. No tax increase is required.

The proposed rate of \$0.68 would generate approximately \$47,859.00 in 2019-2020, \$49,293.00 in 2021-2022, \$50,771.00 in 2021-2022, \$52,293.00 in 2022-2023, and \$53,861.00 in 2023-2024 for a total of \$254,077.00.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate.

Idanha-Detroit Rural Fire Protection District

Explanatory Statement:

This levy option would be a continuation of a levy option that has been place for the past five years and is not an additional tax. This levy would assist with the funding of general operations, district business, as well as bolster the 911 response.

The District regularly seeks other sources of funding such as grants but none of those sources will pay for operations in general. We have been able to purchase some personal protective equipment through the grant process as well as providing for some staffing through a grant. No operational money funded any of these programs. This levy is not designed to pay for staffing.

The Idanha Detroit fire district was established in 1954 when the timber industry was prospering. At the same time Idanha Detroit fire was just responsible for suppression of fire. Today the Idanha Detroit fire does so much more than Fire suppression. Medical response and rescue service are a majority of our mission to citizens of Idanha and Detroit. The demands for service are wide ranging and ever increasing. There is no funding mechanism other than the option levy that will help with sustaining operations.

This option levy is important due to the decline of the timber industry and the increase for service demands. The Board of Directors for the Idanha Detroit Rural Fire Protection District by resolution at the February 14th 2019 regular board of directors meeting decided to pursue the renewal of the local option levy.

Referred to the People by the Jefferson Rural Fire Board

Five Year Local Option Tax for Operations

Question: Shall the District levy taxes of \$0.38 per \$1000 of assessed value for five years beginning 2019-20 for operations? This measure may cause property taxes to increase more than three percent.

Summary: Jefferson Rural Fire Protection District provides ambulance, EMS and fire response within a 97 square mile area in Marion and Linn Counties. In 2018-19 the District experienced a significant decrease in property tax revenue after a change in the service area. The Board conducted a review of the District and identified several needs such as replacing a 2004 ambulance, a 1982 water tender, station maintenance, equipment maintenance and improve staffing.

With the reduced revenues and identified needs the Board of Director's is asking the voters for a 5-year local option levy with a tax rate of \$0.38 per \$1000 of assessed value.

Homeowners with average assessed value of \$190,000.00 at the proposed amount of \$0.38 per thousand would result in a homeowner paying \$72.20 in property taxes.

The measure would raise approximately \$260,777.00 in 2019-20, \$268,600.00 in 2020-21, \$276,658.00 in 2021-22, \$284,958.00 in 2022-23 and \$293,507.00 in 2023-24 for a total of \$1,384,500.00

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate.

Measure No. 24-440
Jefferson Rural Fire Protection District

Explanatory Statement:

Jefferson Rural Fire Protection District provides ambulance, EMS and fire response within a 97 square mile area in Marion and Linn Counties. In 2018-19 the Fire District experienced a \$275,000.00 decrease in property tax revenue after the City of Millersburg withdrew from the Fire District. In response the Board made several budget cuts to compensate for the loss of revenue which included reducing one full-time position to half-time, reducing a reserve account, and additional operational reductions.

The Board conducted a review of the facilities, apparatus, and staffing to identify the immediate and long-term needs of the Fire District. It was determined that replacing the aging facilities and equipment would require 14.5 million dollars. The Board of Director's would like to start addressing these needs of the Fire District but realizes it can't be done all at once. A 5-year local option tax provides the most flexibility to address facility maintenance, operational, apparatus and staffing needs. The Fire District wants to replace a 2004 Ambulance, purchase one new tender to replace two 1982 tenders, increase facility and apparatus maintenance, and make improvements to the part-time staffing.

The Board of Director's is asking the voters to approve a \$0.38 per thousand tax increase for the next 5 years beginning July 1, 2019 and expiring June 30, 2024. The measure would raise approximately \$260,777.00 in 2019-20, \$268,600.00 in 2020-21, \$276,658.00 in 2021-22, \$284,958.00 in 2022-23 and \$293,507.00 in 2023-24, for a total of \$1,384,500.00.

Homeowners with average assessed value of \$190,000.00 at the proposed amount of \$0.38 per thousand would pay \$72.20 in property taxes.

The revenue generated will allow the Fire District to continue providing ambulance, fire and EMS services at current levels and upgrade an ambulance and water tender. Without the increased revenue the Fire District will need to make additional reductions in services and staffing.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate.

Referred to the People by the Santiam Canyon School Board

Bonds to construct schools; improve safety and security; add classrooms.

Question: Shall Santiam Canyon School District improve safety, replace school, add vocational classrooms, issue general obligation bonds not exceeding \$17.9 million? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

Summary: If approved, this measure is expected to finance:

- Capital costs to enhance vocational and academic programs for junior high and high school students
- Security upgrades, to improve safety
- Construction of a new Junior/Senior High School to address overcrowding; replace a failing building, remove temporary portable classrooms
- New cafeteria at the Elementary School to improve instructional schedules
- Construction of office, library, core education spaces, and an auxiliary gymnasium
- Furnishing and equipping for the above projects, demolition of existing buildings, pre-project planning, site improvements, upgrades to existing high school buildings, and bond fees

The District would establish a citizen oversight committee to ensure proceeds are used for purposes indicated.

Bonds would mature in twenty-five (25) years or less from the date of issuance. Estimated levy rate is \$2.45 per \$1,000 assessed value. For the owner of a home with an assessed value of \$100,000, the estimated additional monthly cost would be \$20.42 per month, or \$245 per year. Actual rates may differ based on changes in interest rates and assessed values.

Explanatory Statement:

Santiam Canyon School District serves students from the rural communities of Mill City, Gates, Detroit, Idanha, Marion Forks, the Little North Fork and surrounding areas. Santiam Elementary School and Santiam Junior/Senior High School have a combined enrollment of 570 students. In the past two years, enrollment has increased by approximately 40 students and projections are for continued growth.

Santiam Canyon Schools face challenges:

- School safety and security needs have changed.
- Instructional space for vocational and academic programs for junior high and high school students is limited.
- Built in 1954, our Junior/Senior High School is an overcrowded, outdated facility that has failing mechanical and structural issues. It was not designed for separation of middle and high school students, does not meet current safety standards and contains old hazardous materials such as asbestos.
- Santiam Elementary School enrolls 310 students in grades K-6 and is out of classroom space for additional growth or programs.

Explanatory Statement continued:

Community identified priorities:

In 2017, the District formed a Long Range Facilities Plan Committee that represented community members and school staff. A facility analysis was conducted by outside architects, engineers and school construction professionals.

The citizens' committee proposed a bond measure supported by the school board to fund the following capital projects:

- **Enhance vocational and academic programs for junior high and high school students through expansion of hands on learning spaces.** The District has added student programming in recent years, with addition of industrial arts/shop classes, music and health occupations technical classes.
- **Improve life safety and security.**
- **Reduce overcrowding by constructing a new Junior/Senior High School to address overcrowding; replace a failing building, remove temporary portable classrooms.** This bond proposal would replace the classroom portion of the campus, leaving the Auditorium, Gym and Shop building.
- **New cafeteria at the Elementary School to improve instructional schedules; currently lunch starts as early as 10:30 a.m. to fit all K-12 students in one cafeteria.**
- **Construction of office, library, core education spaces, and an auxiliary gymnasium**

Replacement vs Repair: Expert recommendations are that the Santiam Junior/Senior High School classroom building is a better candidate for replacement compared to repair. The cost to repair this aging facility does not make sense due to the condition and educational adequacy of the building. It does not meet current safety standards and contains old hazardous materials such as asbestos. The District's innovative design and construction of the new classroom buildings is estimated to cost taxpayers 40% less than current standard school construction.

Bond funds can only be used for voter-approved projects: The principal amount cannot exceed \$17.9 million and bonds would mature in 25 years or less. Law prohibits the use of bond funds for any expense not listed on the ballot.

Citizen oversight for bond expenditures: A long-term citizen oversight committee would be appointed to ensure that all bond funds are used for the purposes approved by voters. Their role would include communicating project implementation to the public and overseeing spending.

Argument in Support:

A local committee studied an architectural report outlining the condition of our school facilities. Many recommended upgrades, repairs, or maintenance could be accomplished within the district's budget. More expensive items required an evaluation of the cost effectiveness of facility repairs or replacement.

The aging high school classroom building is in need of significant upgrades and repairs, including: roofing, asbestos abatement, earthquake reinforcements, HVAC system upgrades, electrical and plumbing upgrades, security systems, and ADA accessibility improvements. Furthermore, portable classrooms are being used to meet space requirements. Repairing the existing classroom building does not improve educational offerings or address space needs. A bond would be necessary to pay for these expensive repairs and may not be repaid before more repairs are required.

Additional facilities are also needed. Currently all students use one cafeteria, requiring student shifts. The first lunch period for elementary students begins at 10:30 am. Additionally, State-mandated changes require PE time for all students, overtaking the current gymnasium.

In the past, State Support funds financed schools with a specific dollar amount per student. Districts levied local property taxes to cover differences between State funds and the actual cost of operating schools. Local revenue sources, like the timber tax, were "extra" revenue that school boards used to fund expensive projects. When measure 5 went into effect in 1991, the State rolled timber tax money into the State Support fund equation resulting in some districts losing that "extra" revenue. Currently, when districts need money for major projects, they must go to voters with a bond measure such as this.

We believe that this bond gives our students modern facilities, improved safety, and the same advantages of an enlarged curriculum other districts provide. Several design iterations were considered to find the most cost-efficient way to provide needed facilities for our students and allow for space for future growth.
