Does not apply to candidates filling for the office of US President.					
Warning Supplying false information on this form may result in conviction of a felony with a fine of up to \$125,000 and/or prison for up to 5 years.  (ORS 260 715). A person may only file for one lucrative office or not more than one precinct committee person at the same election. Unless II filings are invalid. (ORS 249.013 and ORS 249.170)
