# Updates: Legislative Session & Case Law

# **CART: FAQs**



**Q.** Does the Juvenile DA's office accept referrals for cases involving sexualized behavior in kids under 12 (SBU12)?

A: Yes! We welcome law enforcement and DHS referrals for cases involving the sexualized behavior in kids under 12. SBU12 referrals can be sent to David Wilson at <u>DRWilson@co.marion.or.us</u> or Bobbie Cogswell at the Marion County Juvenile Department at <u>BCOGSWELL@co.marion.or.us</u>.

**Q**: I am investigating a case in which a 9-year old disclosed to her mom that she was touched by her 17-year old brother two years ago. Her brother still lives in the home. DHS responded and referred the victim to Liberty House but the interview is two weeks from now. Mom says the brother admitted the touching occurred. What should I do?

**A:** Great question! A lot depends on the facts, but here are some things to keep in mind:

• Talk to your supervisor or detective sergeant, but in this case it is probably helpful to make sure we

get a detailed statement from the mother about what the brother said occurred. Depending on the detail and the mother's cooperation, it may make sense to proceed with a suspect interview quickly.

- If you are investigating a case involving a juvenile suspect, CART protocol asks law enforcement to arrest a youth when the investigator feels they have probable cause, §XIV(C)(1)(c)(i). This is because the juvenile department can quickly implement a safety plan for the offender, which protects other children the suspect may have access to.
- Consider asking for a CART "SOC" staffing if you are concerned that a DHS, law enforcement, or Liberty House interview is going to negatively affect your investigation. To do so, contact Liberty House at KWolfer@libertyhousecenter.org.

**Q**: What are the odds that my child abuse investigation also includes domestic violence?

**A:** The odds are high. If you're investigating child abuse, you are probably investigating domestic violence as well. The overlap between child abuse and domestic violence in the same family is significant--40-60 percent of families who present with partner violence also report child abuse.\*

# Investigation Checklist



The following checklist is a helpful tool in ensuring that your case file is complete.

## **Recorded Statements by all Parties:**

- Recorded Statement by Victim
- Recorded Statement or invocation of *Miranda* by Suspect
  - · Consider a pretext phone call

# A Thorough Investigation of the Suspect:

- · Answer: who is this person?
- Prior bad acts by Suspect (charged AND uncharged)
  - Family
  - Prior DHS records/referrals
  - Prior access to children
  - Prior girlfriends

## Full Reports:

- First responders and detective follow ups.
- Liberty House (if applicable)
- DHS records (if involved)

## Technology:

- Documentation about what technology was seized and why, or if not, why not
- Warrant?

\*Remember, only trained professionals should search cell phones, computers, etc.

## Sexual Assault Exam:

- · Medical Records with the report
- Evidence sent to OSP if collected

## **Collaterals Interviewed:**

- Disclosure witness
- Corroborating witnesses
- · Grooming witnesses

## Any other corroboration (no fact is too small!)

## The Victim is Safe:

- Report contacts accurate contact information
- · Victim is connected to resources

· Victim will be safe once case is charged



# Success!

- In March, Anthony Vandekoppel (SMP) identified a homicide suspect in another agency's case merely by recognizing the phone number!
- Paul Eves (SYP) and Tim Cobos (WBP) worked together to get a victim located and interviewed for a rush GJ. The case was over 7 years old. The case was indicted.
- J Smith (SMP) worked tirelessly to help prepare a human trafficking trial. One victim was an uncooperative minor from out of state, and the other was a difficult to locate material witness.
   Case resolved short of trial with the defendant pleading guilty to 80+ months in prison.
- Thanks to a terrific investigation by Detective Ben Howden (KZP), a convicted sex offender was sentenced to 405 months for possession of recordings of child sexual assault. The defendant had over 1,000 images in his possession and was a long-time offender.

- Detective Aaron Devoe (WPD) recently received kudos from the court regarding his interviewing skills. In ruling against the defense on a motion to suppress regarding the voluntariness of a defendant's interview, the court stated that it was "as if [Devoe] had read the case law on point in this matter himself."
- Officer Andy Phelps (K2P) was recently promoted to detective. Congratulations Andy!
