## **I. Announcements and Introductions**

- Marion County is getting ready for there site review from AMH. The ITRS children's Christmas party is being planned, it is Dec 16<sup>th</sup>.
- Clear Paths announced that the adolescent group is growing and that it had to be split into two groups.
- Cary announced that the state has issued an RFP to develop an enhanced detox service. The RFP is due Dec. 2<sup>nd</sup>. Right now Bridgeway is a social detox facility and the RFP would allow for more medically complex clients. There will be 24 hr nursing and increased Doctor hours. There are 7 detox facilities in the state, but not enough funds for all 7. Services are to begin in January 1, 2012.
  - Priority will be given to the enhanced detox
  - Benzoos are the hardest to find places for.
    - Not sure this detox will he helpful for those.
  - If there is enough money Bridgeway and Marion County are looking at adding a mentor to the detox treatment.
- The state budget looks more gloomy than anticipated
  - The AMH website has a proposed budget cuts incase the state revenue is less than anticipated.

## **II. "Family" and Community Supports Systems- Everyone**

What is agency philosophy as it relates to outside support system

- We need to change the wording to access social supports
- Admissions/Data forms indicate minimal referrals to either
- Need to add a definition to the form to make it more clear
- Are forms being filled out correctly-confirm with administrative staff
- Need to double check that the people filling out the forms have enough information and definitions.

### **III. Admissions/Discharge Data Form-Everyone**

Review current form

- Trying to make it easier

Consider revisions and updates

- Need to see if the number of treatment admissions and number of criminal charges are not in the state contract before they can be taken off.
- Employment status-change a few options
- Discharge status
  - Complete (considered 2/3 or more of treatment completed)
  - Incomplete 30-89 days
  - Incomplete 90 days or more
  - Add by programs request

- To fidelity – how do we know?
