Meeting called to order at 1:00pm

I. Data Discussion - Dean/Dwight

- ❖ Dean stated we need to submit our lowest cost option in order to project the budget, primary care is the main place that we want to try and invest money. September 1st they are suppose to announce who gets what amounts of money and by October 1st then the rates and budgets are set for the next year.
- ❖ Prescription drugs are off the table because the contract to pay for them is through PBM and all the rebates have been used by the state so there is really nothing left for us to come in on.
- ❖ We are going to have to give them a budget for rate spent, so that will eliminate the surpluses we are running on in CD.
- ❖ The fall back position with the hospital is the dmap fee for service when the hospital will not accept the capitation arrangement and that will allow us to reduce the fee schedule even more than it is now
- ❖ **Deans graph hand out.....**
- ❖ The state wide average is 20 for CD access to treatment and we are about 14.66
- ❖ The more you spend in chemical dependency the more your going to save in health plan costs.
- ❖ Jim added that we have enough of a financial cushion to get things changing a little at a time so we don't have to move it so dramatically fast.
- ❖ Dean is willing to help plan ways to help engage physicians with the work we are trying to do and SBIRT, such as news letters and organizing meetings, along with other communications means he has available.

❖ Dwight on indigent CD Data.....

- ❖ Scott added that his experience has been received requests to extend funds, for various reasons, and no one has requested an extension because they have not finished their EBP.
- ❖ Scott did a UM visit last week and they are working on pulling it all together

II. MPCHP Panel

- ❖ Cary stated Detox Mentors are still in the planning stage, there might be some start up support to get it going
- ❖ Tim Murphy added that he talked to the docs from Yamhill county about detox services and they are looking forward to this happening as well
- ❖ Rod met with the Salem hospital and they did not have much information on the subject
- ❖ Cary was thinking that at a staff meeting so people could have faces and names to who is doing this work
- ❖ Dean added that there was a flyer that could be sent out, Scott created it so he will be sending it out

III. SE66 Contract 2011-2012

- ❖ Scott stated that the biggest difference is in the expectation of utilization of our system for Marion county serving 641 individuals with indigent funds
- ❖ Cary added the two primary changes are now have indigent funds we need to serve with our 66 funds, folks that come into service and don't engage, so they need to be in service for longer than 30 days to count as indigent folks
- ❖ With the first run at this we should be ok and meet our threshold
- ❖ They are needing us to insure that any clients that we provide services to under the 66 funds you are using the 65 code
- ❖ Dwight explained that on roll over he has received all the open auths for the current fiscal year and they have 2 of the 3 agencies for everybody that is rolling over at that point and they are just waiting on one agency to submit theirs

IV. Collaboration with Corrections

- ❖ Tim Murphy stated that the Marion county drug court is paid for by 2 contracts one is from Marion county drug court itself and the other is from community correction with sheriffs parole and probations and the sheriffs

parole and probation decided not to fund drug court treatment as of July 1st and that's about a 45% cut in drug court cost. There is a conversation going on with the judge there is potentially money coming through the criminal justice system to help support drug court but that is not sure yet.

- ❖ He also added that there was a treatment contract with Marion county community treatment and mentor services and that was cut from \$200,000 to \$75,000.
- ❖ Tomoko added that the drug court coordinator is writing many letters to get grants for the drug court
