II. SE66 Funding – Cary, Everyone

- Contract with AMH came out with new performance requirements that we have not had previously. Requirement for indigent services to show performance of a specific number of individuals. Cary will be looking at the calculations of each county to make sure they are correct.
- Termination CPMS Payer code 65. Payer code only on termination there is not a code on admission side. This is a 1 year contract with the state and reflects people enrolled and terminated within the contract year. You cannot count any people that carry over from the previous year.
 - o Have to be enrolled and terminated within the contract year.
 - o It will only count for people in-service for 30 days or longer. Assessment only does not count.
- They are working on some clean up through the state so that everyone reports in the same way.
- Drug Court took a big financial hit. The courts said they are trying to restore some of the money.
- Made a change in the contract for Special Condition D working on getting some clarification
- Cary is not going to change contracts as much a possible
 - o Very similar to how we ended the year
- Fee for service Open Card rate reduction will drop by 11.5%
 - o Primary care was held harmless

- Focusing more on Prevention, Access.
- Looking for better health across populations
- o Mental health side will range from no change to about a 30% rate cut
 - Based on DMAP plus 10.8%
 - This is based on current Medicare is already paying at a reduced rate.
 - Based on 80% of Medicare rate and 70% of billed charges.
- o New rates will be retro to July 1
 - Have till October to figure out what rates will be based on capitation.
 - The State is asking for feedback.
- AMH will be going through all the administrative rules to make sure there are no redundancies and inefficiencies.
- Moving the covered conditions line from 502 to between 489-493. Cary will keep checking back to see the final decision.
 - Mostly social disorders, a few kids disordered and conduct disorder were cut.
 - o Cary will send out the extracted clean list of all services

- Working with LADPC
 - o Services to seniors, rural access, helping adults transition more successfully from residential care
 - Plans to help with prescription drug abuse

 - o Applied for a 2nd chance reentry grant
 - Will work with clients in jail and help follow them into the community.
 - Working with the Bureau of justice
 - Hoping to serve 150 people over the next 2 years
