ADMINISTRATION	Subject: Lancaster Drive: Center St to Monroe Av Improvements Project
BUILDING INSPECTION	Marion County has received federal funding to improve Lancaster Drive between Center Street and Monroe Avenue. The street currently has very steep cross slopes between the travel lanes and many commercial driveways, making it difficult for
EMERGENCY MANAGEMENT	vehicles to enter and exit Lancaster Drive. These grades force vehicles to enter at an angle and/or drive very slow to avoid scraping on the pavement with their vehicle, creating additional congestion. This project will correct the steep slopes, consolidate
ENGINEERING	and rebuild accesses with acceptable grades to improve flow in and out of commercial properties, construct improved sidewalks and driveway sections,
ENVIRONMENTAL SERVICES	sidewalk ramps and pedestrian signal buttons that meet American Disabilities Act (ADA) standards, and includes pavement repairs and an asphalt overlay.
OPERATIONS	Construction is expected to begin in the summer of 2022 and be completed in the spring of 2023.
PARKS PLANNING	-Marion County Public Works will host a Virtual Open House to share information updated since our first open house as well as a Public Meeting, to provide project information and collect comments and questions regarding the upcoming project.
