Marion County will host an Open House to provide information and answer questions about the State Street Improvements and Elma Avenue Four Corners Safe Routes to School projects. Residents, business owners, and interested parties are welcome to arrive anytime between 4:30 PM and 6:00 PM.

ENVIRONMENTAL SERVICES

State Street: The project will widen the south side State Street to accommodate

three lanes consisting of one travel lane in each direction with a center turn lane, a bike lane, sidewalk, and ADA compliant sidewalk ramps. Rectangular rapid flashing beacons with pedestrian refuge islands will be installed at two crosswalk locations. Construction is expected to begin as early as spring/summer of 2026.

PARKS

Elma Avenue: The pedestrian safety improvements on Elma Avenue will include sidewalks and ADA compliant sidewalk ramps, speed cushions at Four Corners Elementary School, traffic calming measures at Durbin Avenue, new striping and signing. Construction is expected in spring/summer of 2024.
