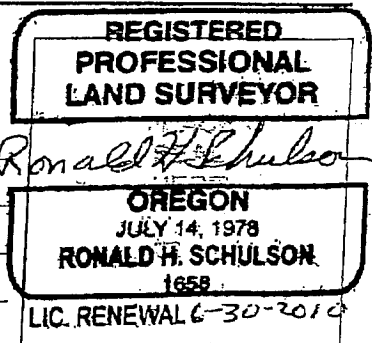

The ground elev. at garage site is 155.6 ft. The only thing in the walled corner of the crawlspace is a furnace duct at elevation 157.5 feet and some plumbing.
