<u>APPLICATION</u>: Application of Louis Gloor to divide a 5.04 acre parcel into two parcels containing 2.0 acres and 3.02 acres each in an AR (Acreage Residential) zone located at 7905 Harpole St. SE, Salem. (T8S; R2W; Section 11B; Tax Lot 300).

<u>DECISION</u>: The Planning Director for Marion County has **APPROVED** the above-described Partition application subject to certain conditions.

EXPIRATION DATE: This approval is valid only when the final partition plat is recorded by **September 17. 2023**. The effective period may be extended for an additional year subject to approval of an extension (form available from the Planning Division). **Additional extensions may not be granted if the regulations under which this decision was granted have changed since the original approval.**

<u>WARNING:</u> A decision approving the proposed division is for land use purposes only. Due to septic, well, and drain field replacement areas, these parcels may not be able to support a dwelling. To be sure the subject property can accommodate the proposed use the applicant should contact the Building Inspection Division, (503) 588-5147.

This decision does not include approval of a building permit.

<u>CONDITIONS:</u> The following conditions must be met <u>before a building permit can be obtained or the approved use</u> established:

Prior to recording the final plat:

- 1. The applicant shall submit a final partition plat to the County Surveyor's Office (5155 Silverton Road NE; (503) 588-5036) and shall contain the notation that the survey is the result of Partition Case 21-021. Following plat approval it shall be recorded with the Marion County Clerk, checking fee and recording fees required. (Plat instructions enclosed).
- 2. A current or updated title report must be submitted at the time of review. Title reports shall be no more than 15 days old at the time of approval of the plat by the Surveyor's Office, which may require additional updated reports.
- 3. Prior to submitting the final partition plat, the applicant shall obtain an approved septic site evaluation from the Marion County Building Inspection Division on all undeveloped parcels. The applicant is strongly encouraged to contact Building Inspection, (503) 588-5147, regarding septic sites <u>before</u> having the property surveyed. Septic site requirements may affect the proposed property line or lot locations.
- 4. Public Works Land Development Engineering and Permits Division (LDEP) will not approve the final plat for recordation until the following conditions have been satisfied:

ENGINEERING CONDITIONS

Condition A - On the partition plat, dedicate a 30-foot half-width public right-of-way along the subject property public right-of-way frontage.

Nexus is to meet R/W dedication requirement for partitions in accordance with Marion County Code (MCC) Sections 16.33.220 and 16.33.260 in order to provide accommodation for future public road improvements to serve the development and traveling public, and width for public utilities.

Condition B – Prior to plat approval either remove wooden fencing within the to-be-expanded Harpole Street 30-foot public right-of-way half-width, or notarize a Removal Agreement for concurrent recording with the plat.

Please contact John Rasmussen in Land Development Engineering for information regarding the Removal Agreement option.

5. The Marion County Planning Division has addressed the proposed new parcel as **7915 Harpole St SE**, **effective and valid once the final partition plat is recorded.**

Prior to issuance of building permits on the resulting parcels,

6. The partition plat shall be recorded.

ADDITIONAL CONDITIONS: Once the approved use is established the following conditions must be continually satisfied:

- 7. The resulting parcels shall significantly conform to the site plan submitted with the proposal. Minor variations are permitted upon review and approval by the Planning Director. All parcels shall be a minimum two acres in size.
- 8. After the final Partition plat has been recorded no alteration of property lines shall be permitted without first obtaining approval from the Planning Director.

OTHER PERMITS, FEES, AND RESTRICTIONS: This approval does not remove or affect covenants or restrictions imposed on the subject property by deed or other instrument. The proposed use may require permits and/or fees from other local, State or Federal agencies. This decision does not take the place of, or relieve the responsibility for, obtaining other permits or satisfying restrictions or conditions. It is recommended that the agencies mentioned in Finding #10, 11 below be contacted to identify restrictions or necessary permits. The applicant is advised of the following:

- 9. Prior to recording the plat all taxes due must be paid to the Marion County Tax Department (contact the Marion County Tax Department at 503-588-5215 for verification of payments).
- 10. The applicants should contact the Marion County Fire District to obtain a copy of the District's Recommended Building Access and Premise Identification regulations and the Marion County Fire Code Applications Guide. Fire District access standards may be more restrictive than County standards. **Paula Smith at MCFD#1** (503) 588-6513 as the contact person).
- 11. The applicants should contact Marion County Land Development and Engineering (503-584-7714) for additional Engineering Requirements and Advisories, listed in Finding #5 below, that may be required.

APPEAL PROCEDURE: The Marion Zone Code provides that certain applications be considered first by the County Planning Director. If there is any doubt that the application conforms with adopted land use policies and regulations the Director must condition or deny the application. Anyone who disagrees with the Director's decision may request that the application be considered by a Marion County hearings officer after a public hearing. The applicant may also request reconsideration (one time only and a fee of \$200) on the basis of new information subject to signing an extension of the 150 day time limit for review of zoning applications.

A public hearing is held on appeals subject to the appellant paying a \$250.00 fee. Requests for reconsideration, or consideration by a hearings officer, must be in writing (form available from the Planning Division) and received, together with the appeal fee, in the Marion County Planning Division, 5155 Silverton Rd. NE, Salem, by 5:00 p.m. on **September 17, 2021**. If you have questions about this decision contact the Planning Division at (503) 588-5038 or at the office. This decision is effective September 18, 2021 unless further consideration is requested.

FINDINGS AND CONCLUSIONS: Findings and conclusions on which the decision was based are noted below.

- 1. The property is designated Rural Residential in the Marion County Comprehensive Plan. The purpose of this designation and the corresponding AR (Acreage Residential) zone is to allow creation of acreage homesites at a density that maintains the character and environmental quality of rural residential areas.
- 2. The subject parcel is located just north of the intersection of Harpole St SE and 78th Ave SE. The property currently contains a dwelling and an accessory structure. The property has a legally established dwelling on it and is therefore, considered a legal parcel for land use purposes.
- 3. Surrounding uses are residential in all directions, with all parcels being zoned AR (Acreage Residential) and developed with small acreage home sites.
- 4. The applicant proposes to divide a 5.04 acre parcel into two parcels containing 2.0 acres and 3.02 acres each.
- 5. <u>Public Works Land Development and Engineering Permits</u> (LDEP) requested that the following be included in the land use decision.

ENGINEERING CONDITIONS

Condition A - On the partition plat, dedicate a 30-foot half-width public right-of-way along the subject property public right-of-way frontage.

Nexus is to meet R/W dedication requirement for partitions in accordance with Marion County Code (MCC) Sections 16.33.220 and 16.33.260 in order to provide accommodation for future public road improvements to serve the development and traveling public, and width for public utilities.

Condition B – Prior to plat approval either remove wooden fencing within the to-be-expanded Harpole Street 30-foot public right-of-way half-width, or notarize a Removal Agreement for concurrent recording with the plat.

ENGINEERING REQUIREMENTS

- C. Access shall be shared. At the time of application for building permits, an Access Permit will be required. Access will be inspected for meeting PW Engineering design standards. Need for vegetation trimming at the west corner of the driveway approach is anticipated to facilitate adequate vision. It is noted that the vegetation described may front the neighboring property, although it still is within the public right-of-way.
- D. Transportation System Development & Parks Charges will be assessed at the time of application for building permits.

- E. Utility permits are required for utility extension work in the public right-of-way.
- F. Show any necessary access and utility easements on the partition plat.

Marion County Surveyor commented:

- 1. Parcels ten acres and less must be surveyed.
- 2. Per ORS 92.050, plat must be submitted for review.
- 3. Checking fee and recording fees required.
- 4. A current or updated title report must be submitted at the time of review. Title reports shall be no more than 15 days old at the time of approval of the plat by the Surveyor's Office, which may require additional updated reports.

<u>Marion County Building Inspection</u> commented: "No building inspection issues. Permits are required for any proposed development."

Marion County Assessor's Office provided information related to the subject properties property taxes.

Salem-Keizer Public Schools provided comments related to the additional students this would add to the district.

All other contacted agencies either failed to comment or stated no objection to proposal.

- 6. There are no specific approval criteria for partitions in the AR zone. MCC 17.128.070 requires a minimum lot size of two acres and the new parcels are consistent with this standard. Subsequently, the proposal meets the criteria for partitioning in the AR zone.
- 7. Based on the above findings, the proposed partition complies with the applicable criteria and is, therefore **APPROVED.**
