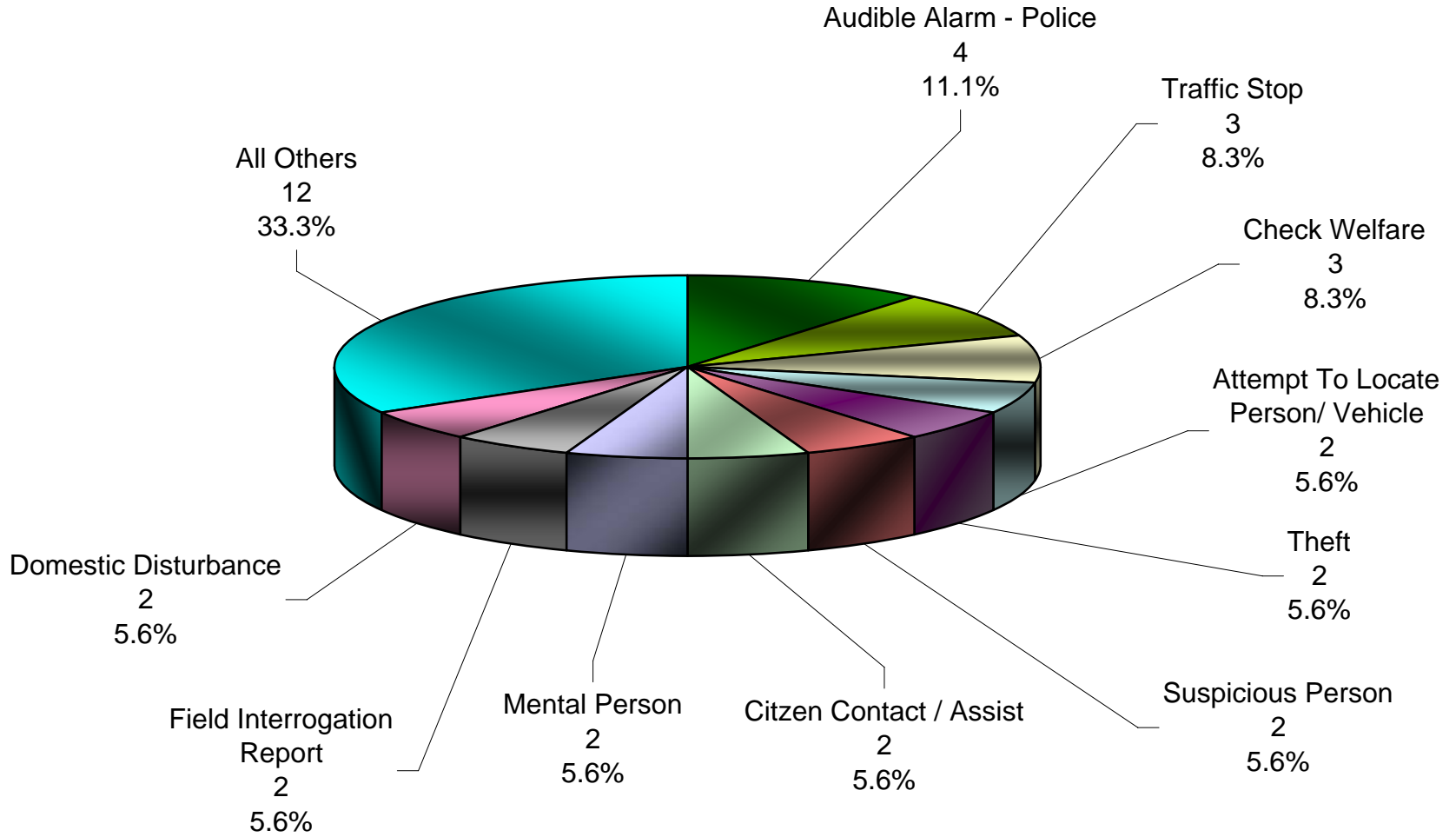

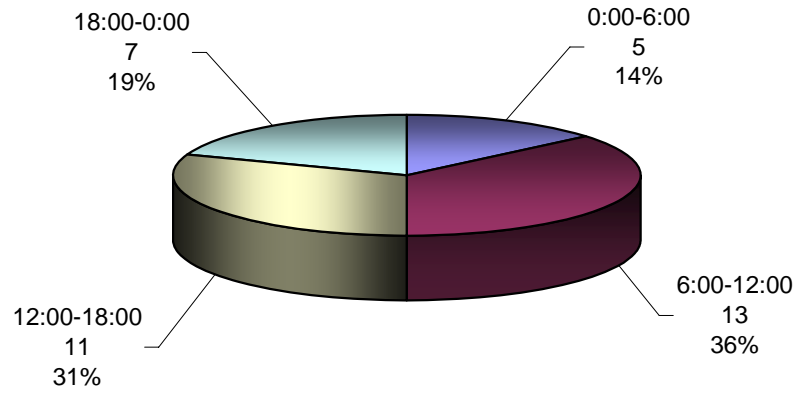

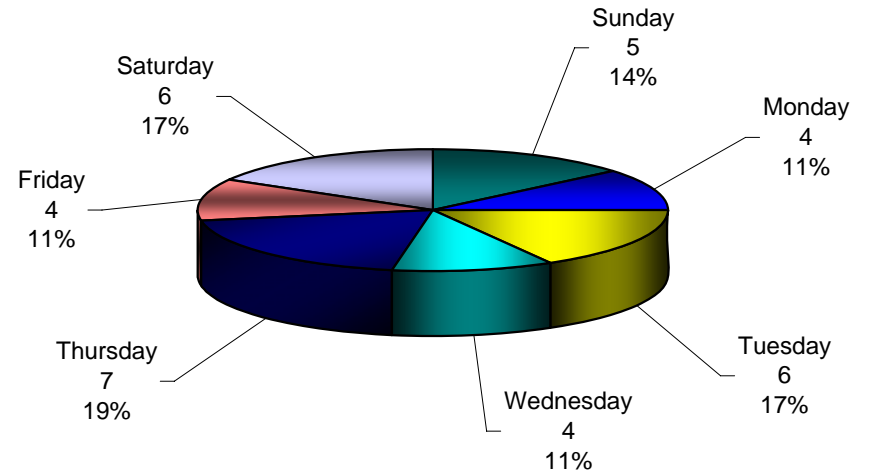
Call Type by Primary Deputy February 2012



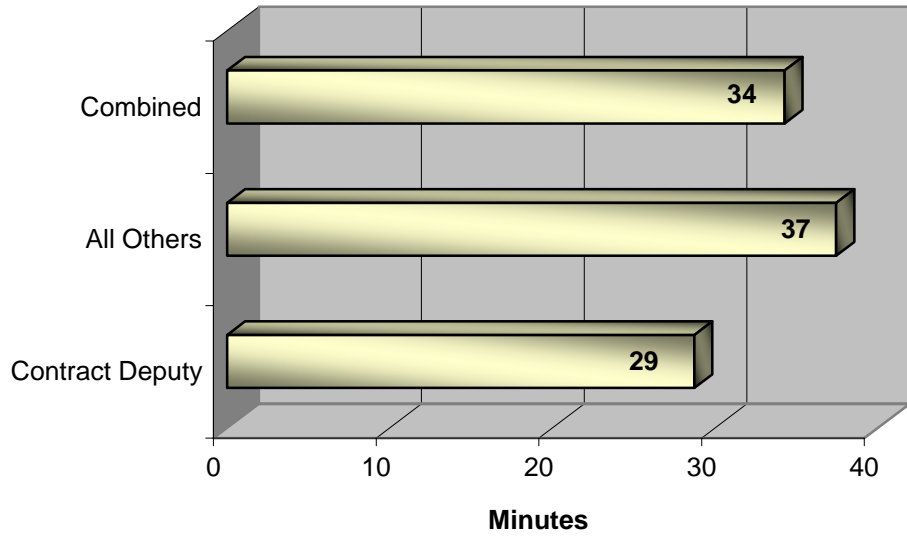
**Sublimity Calls for Service by Hours Range
February 2012**



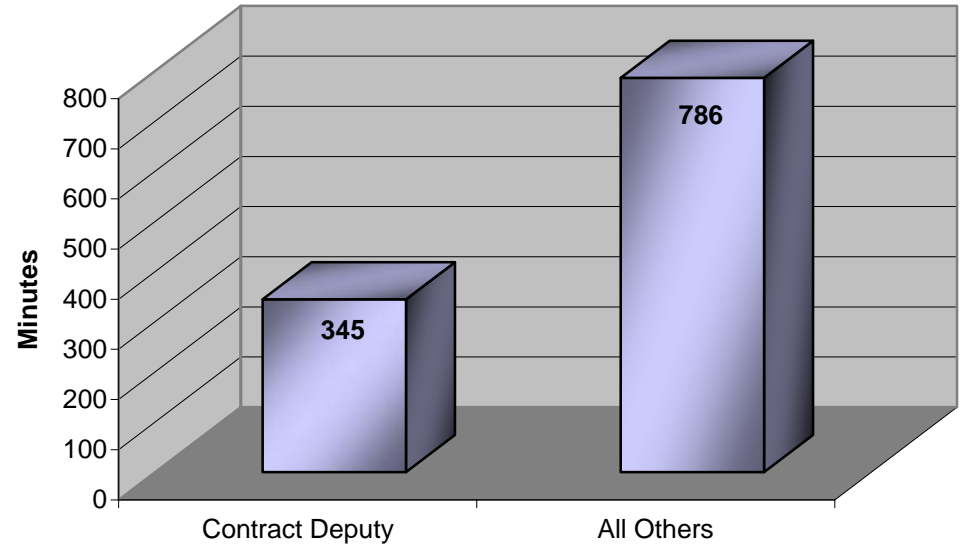
**Sublimity Calls for Service by Day of Week
February 2012**



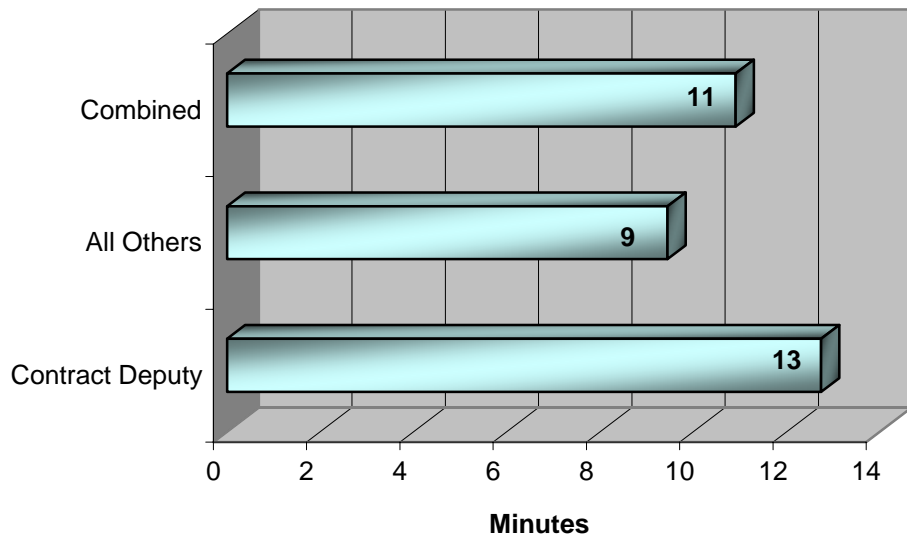
**Sublimity Calls Average Call Length
February 2012**



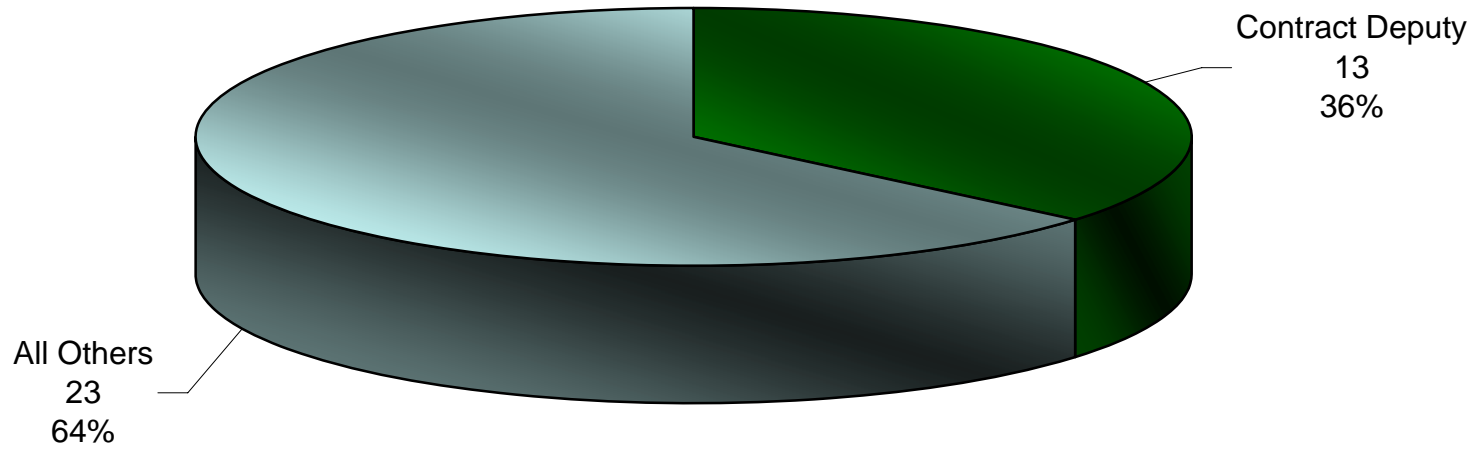
**Sublimity Calls Total Call Length
