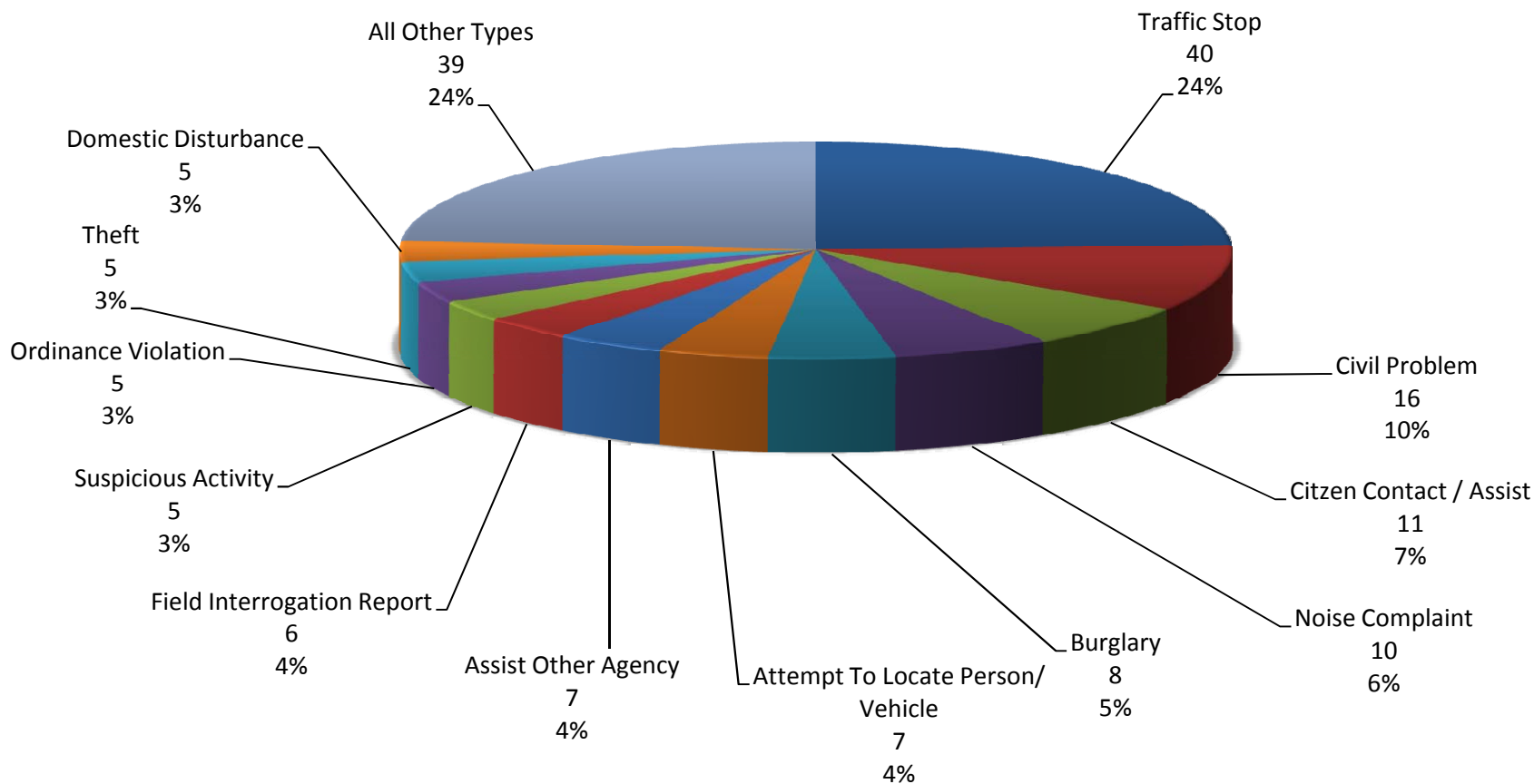

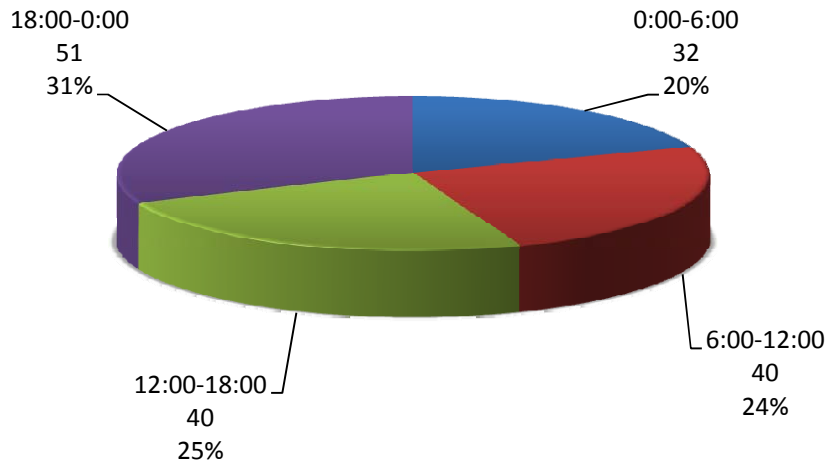

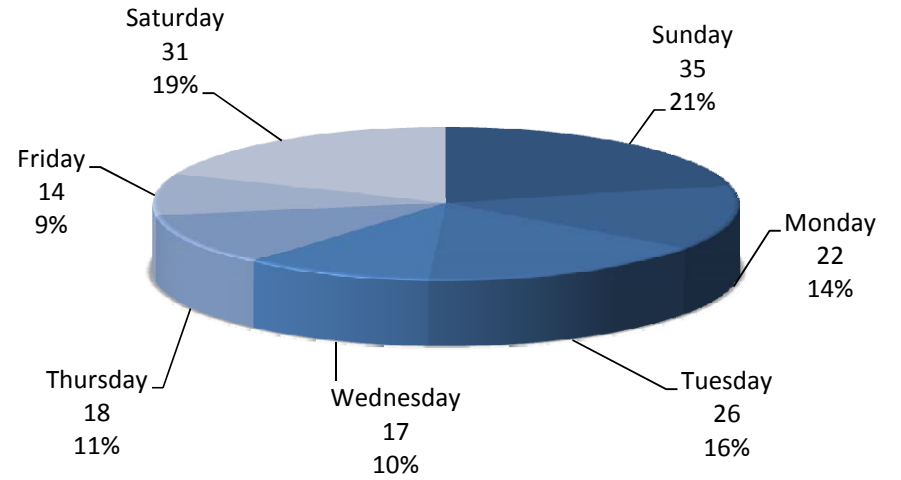
Call Type by Primary Deputy July 2012



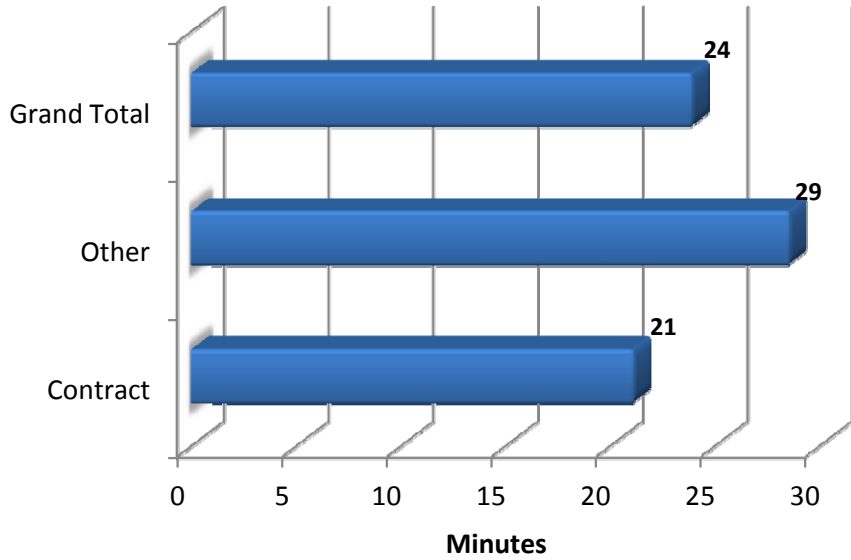
**Jefferson Calls for Service by Hours Range
July 2012**



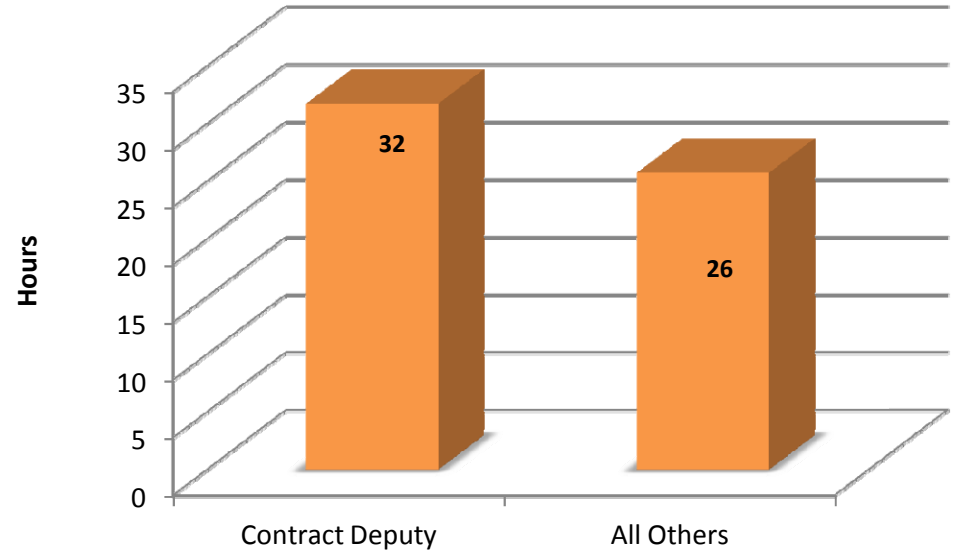
**Jefferson Calls for Service by Day of Week
July 2012**



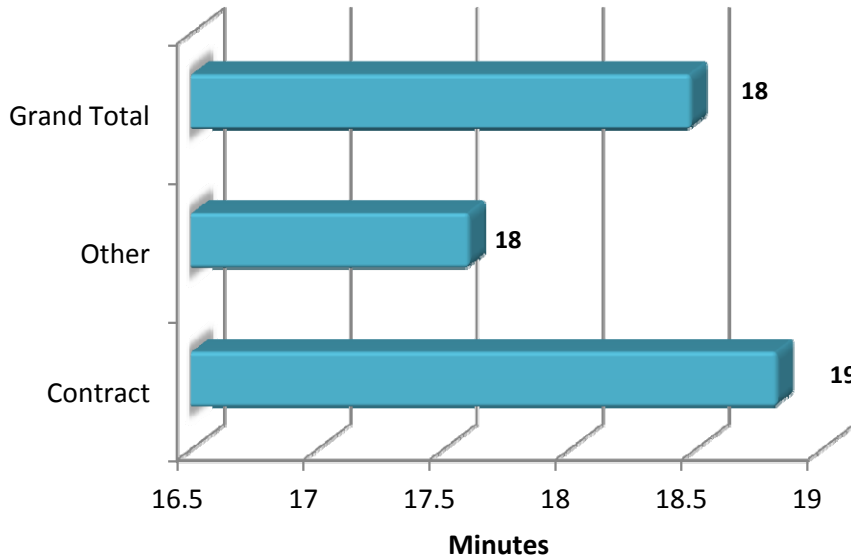
**Jefferson Calls Average Call Length
July 2012**



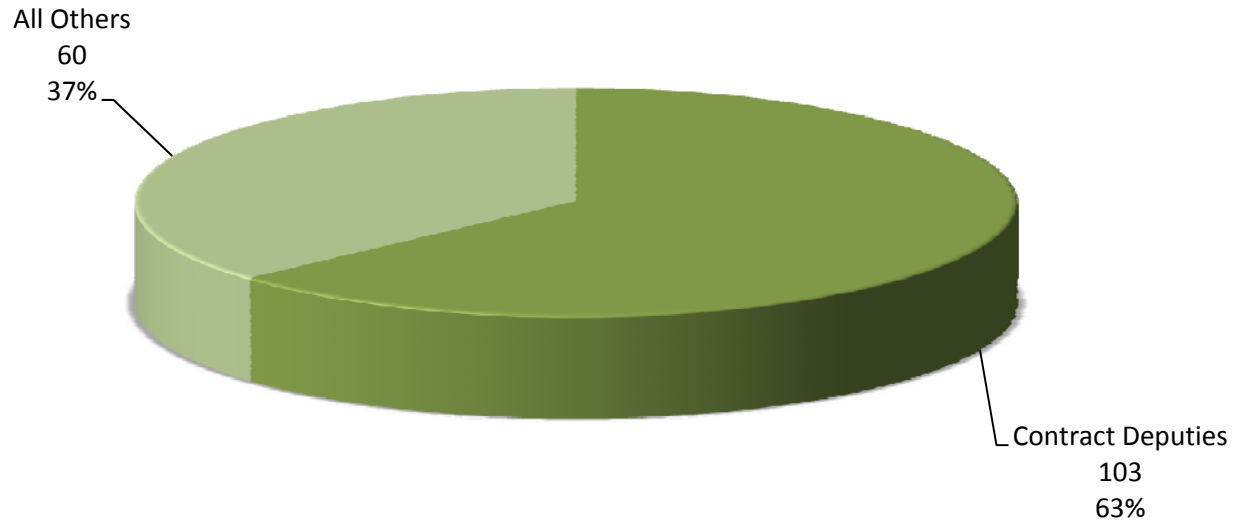
**Jefferson Calls Total Call Length
