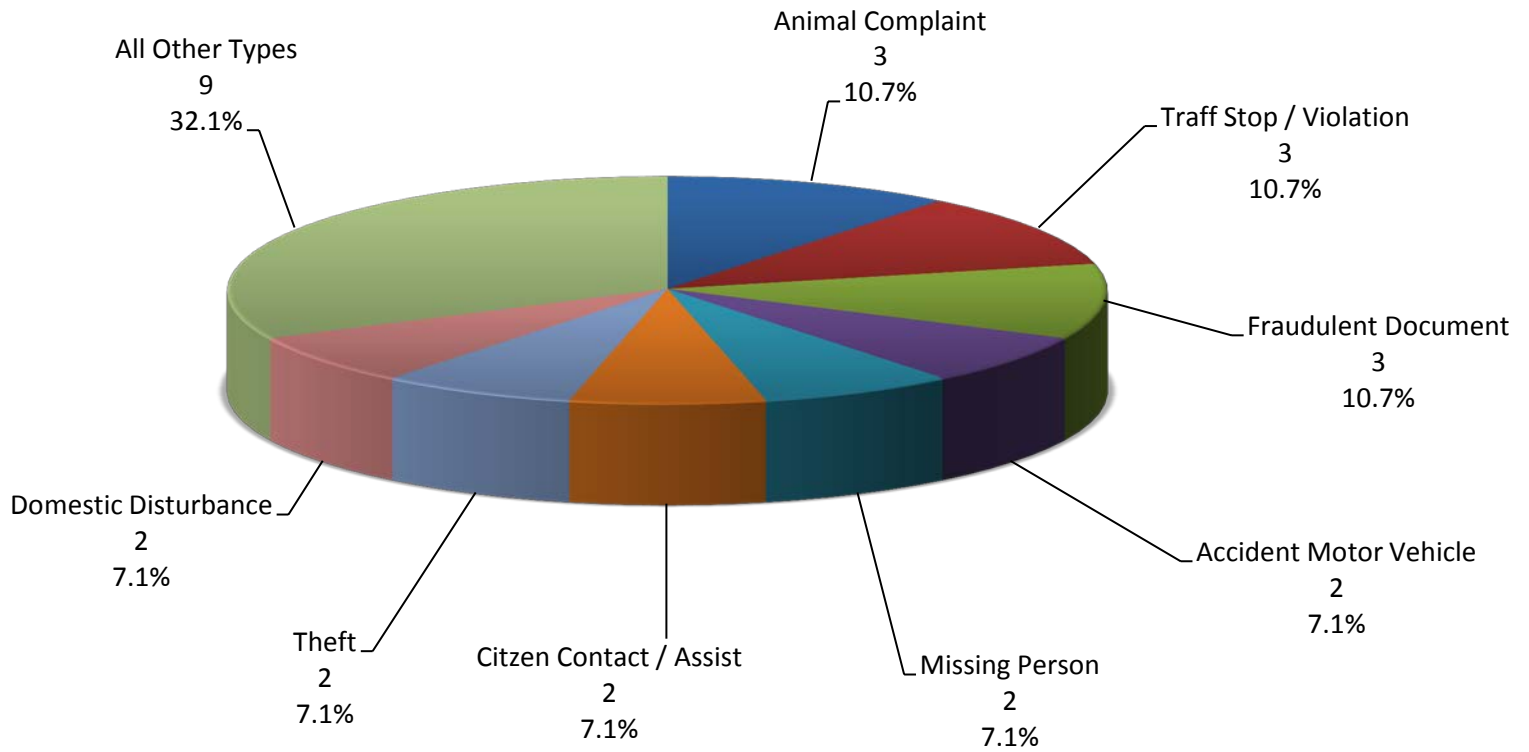

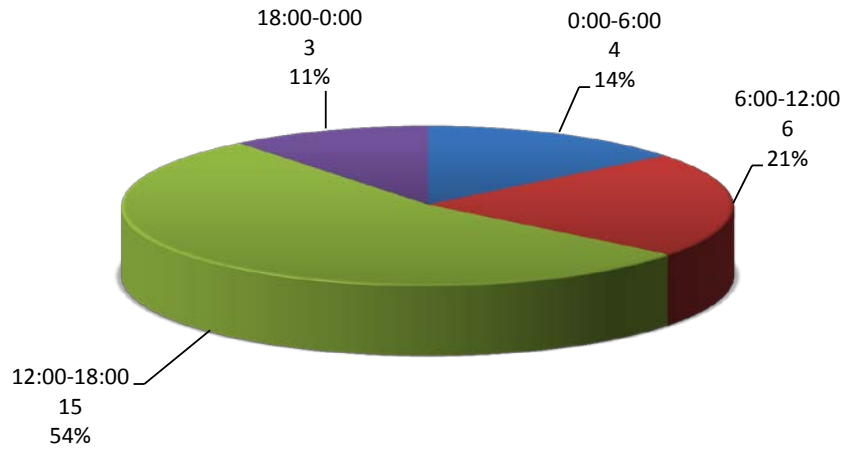

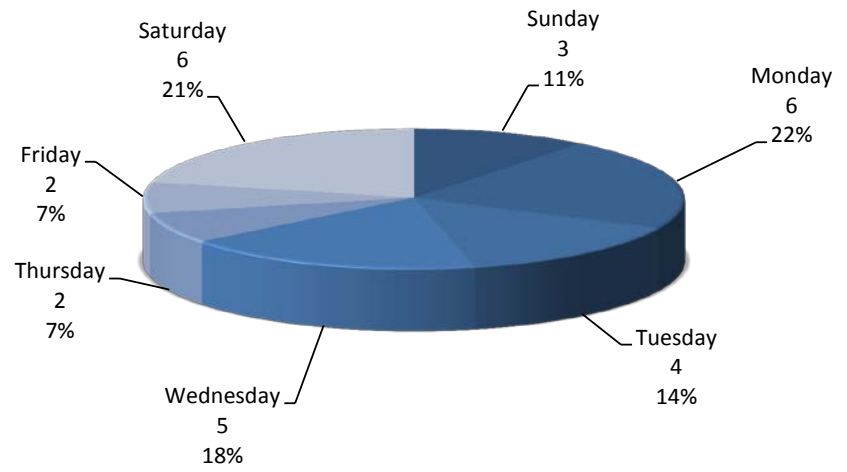
Call Type by Primary Deputy March 2014



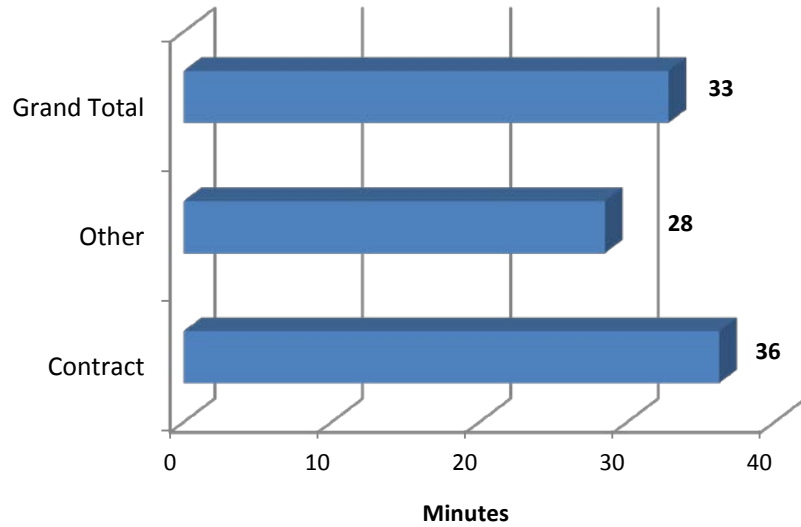
**Sublimity Calls for Service by Hours Range
March 2014**



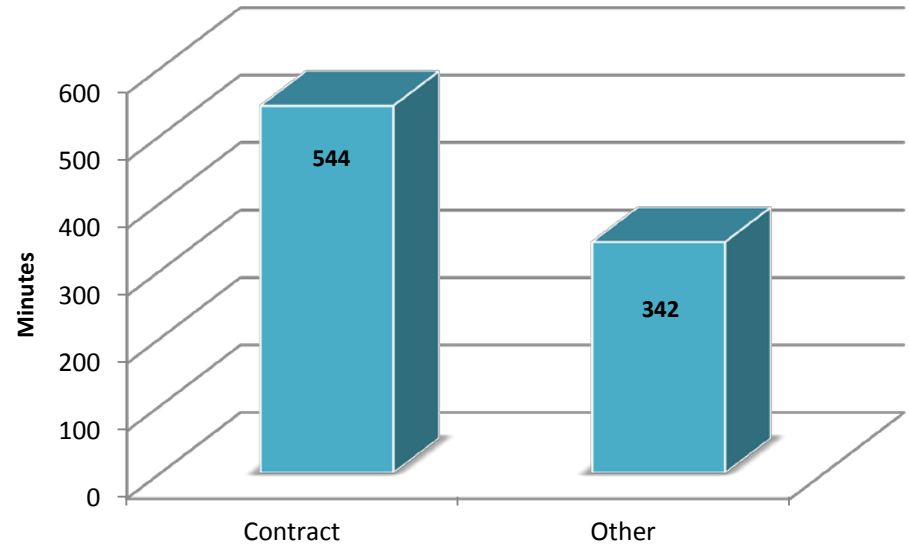
**Sublimity Calls for Service by Day of Week
March 2014**



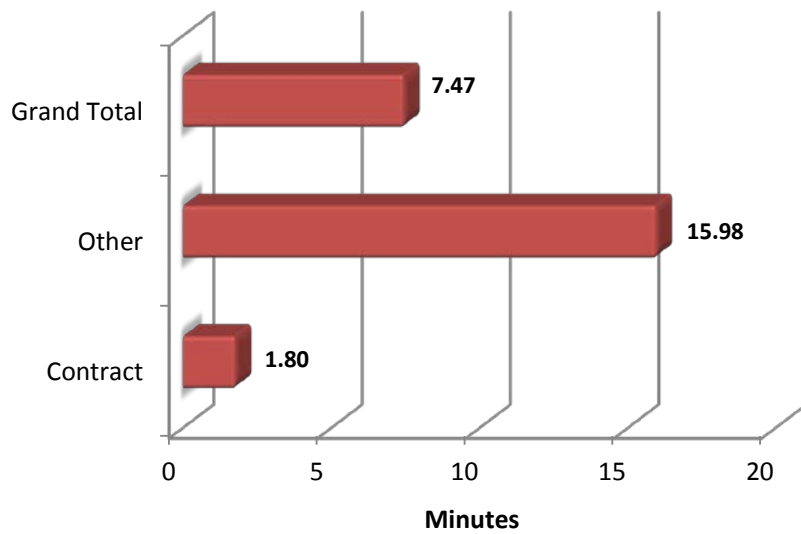
**Sublimity Calls Average Call Length
March 2014**



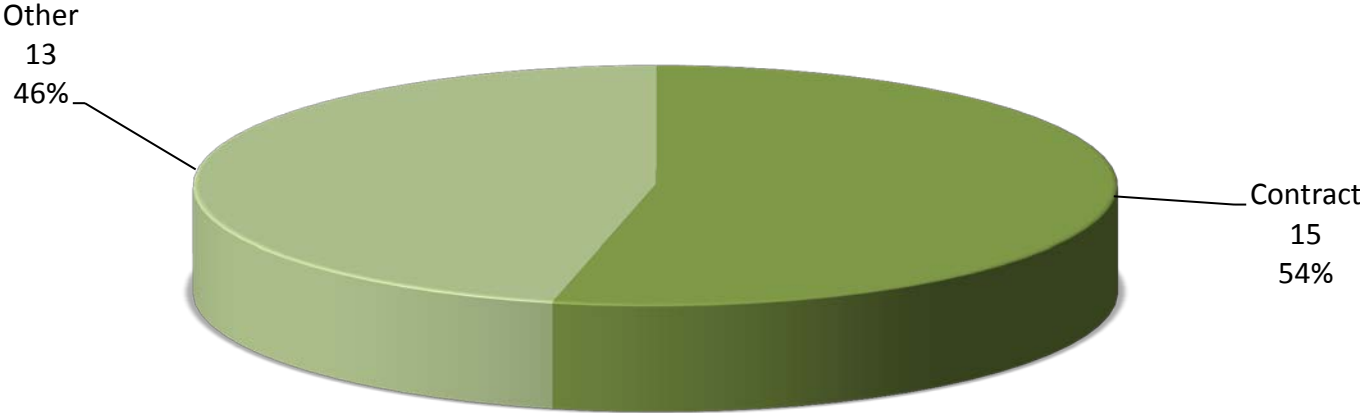
**Sublimity Calls Total Call Length
