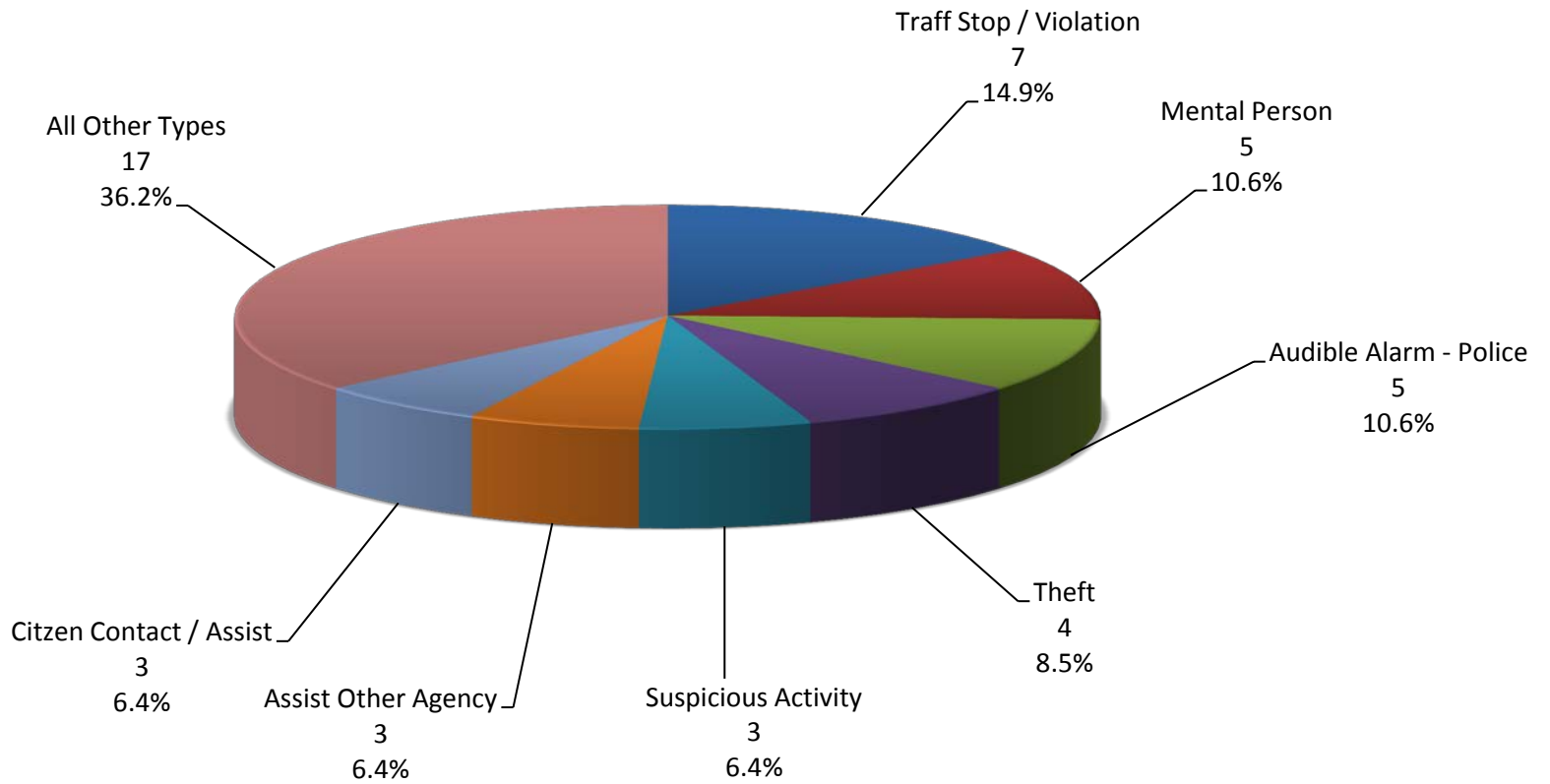
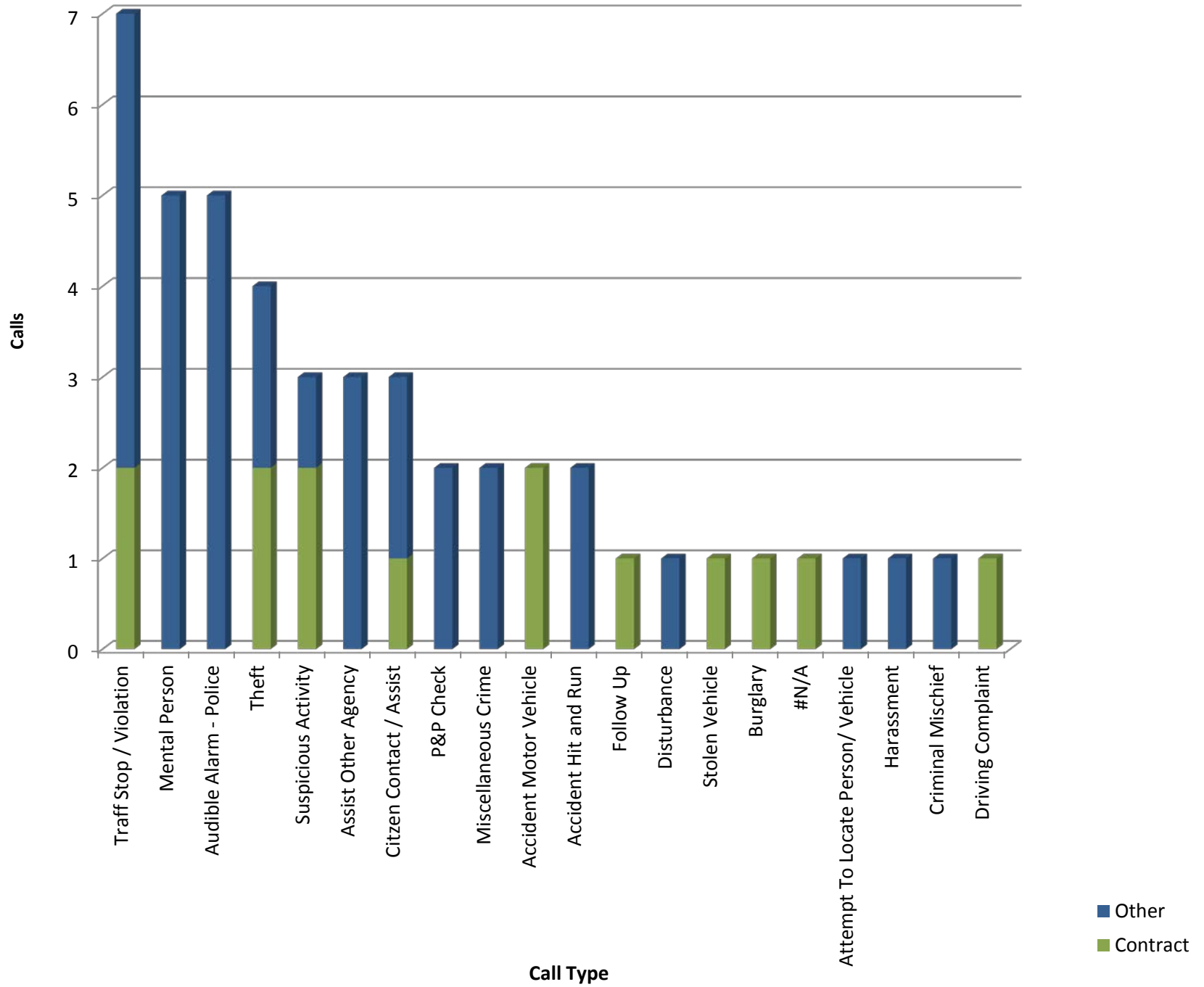


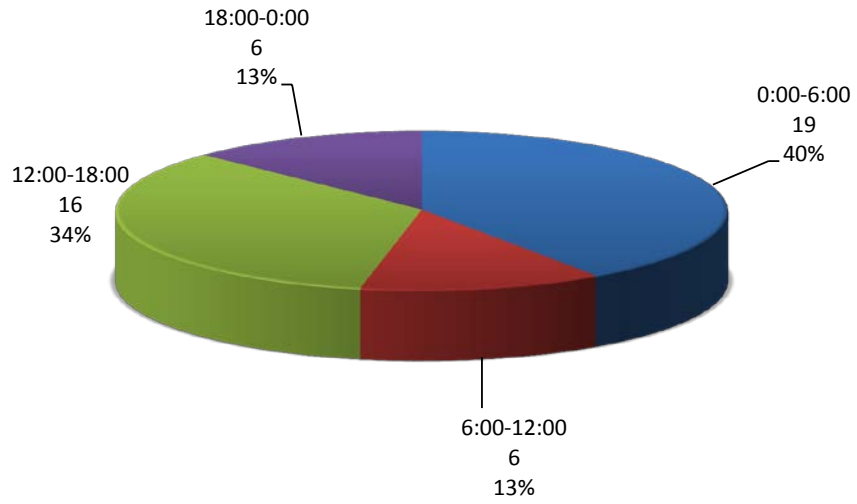

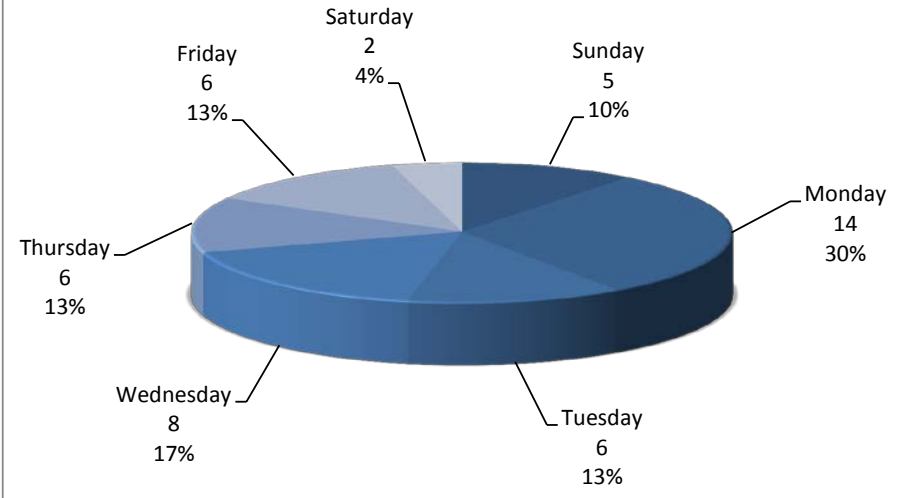
Call Type by Primary Deputy August 2014



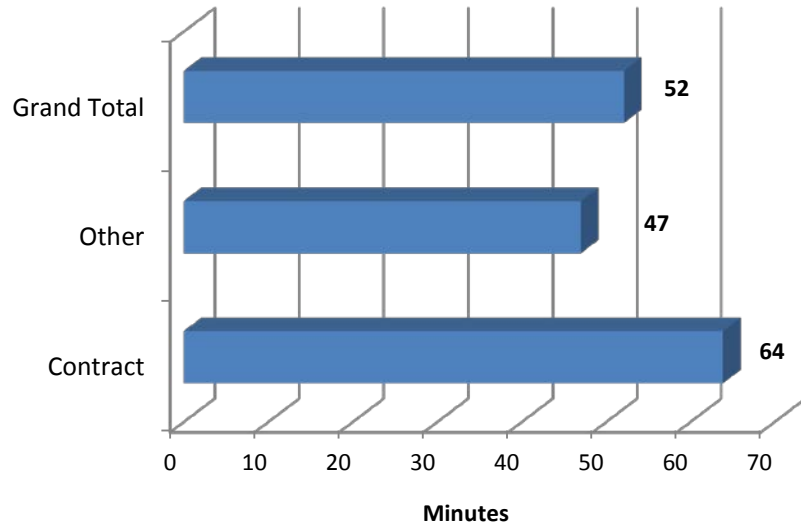
**Sublimity Calls for Service by Hours Range
August 2014**



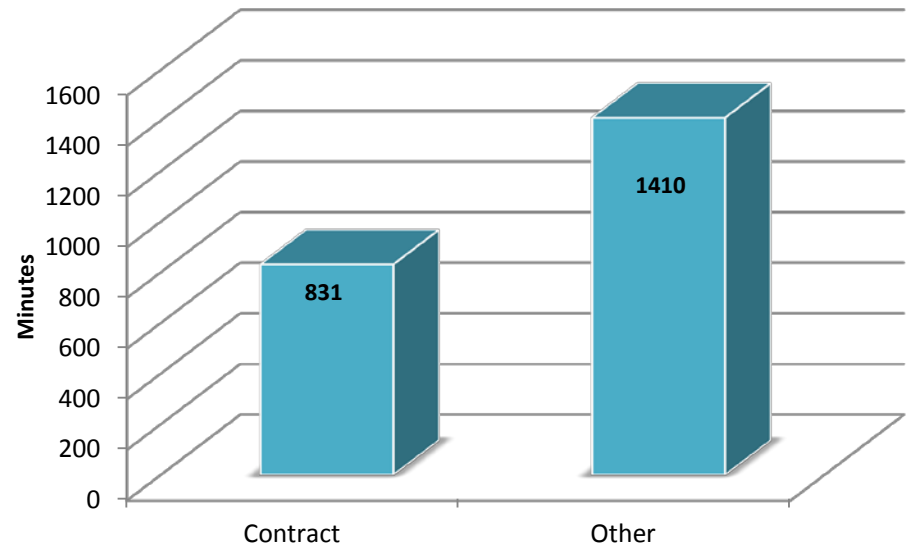
**Sublimity Calls for Service by Day of Week
August 2014**



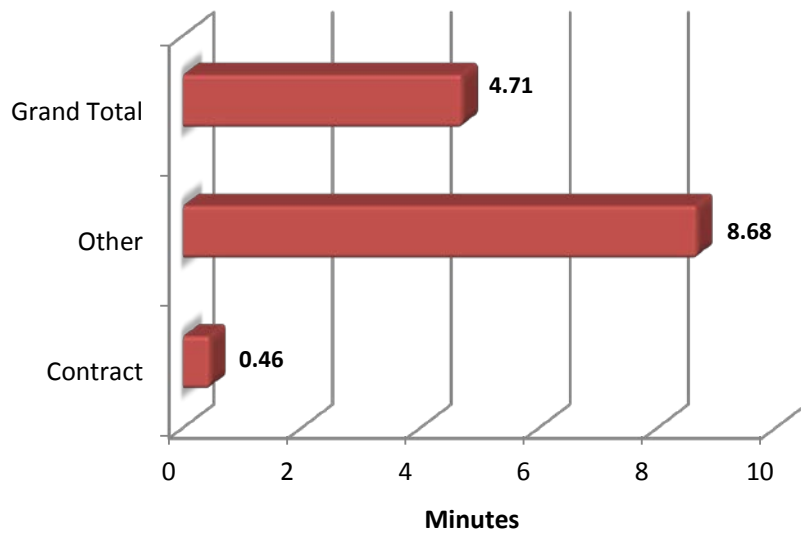
Sublimity Calls Average Call Length August 2014



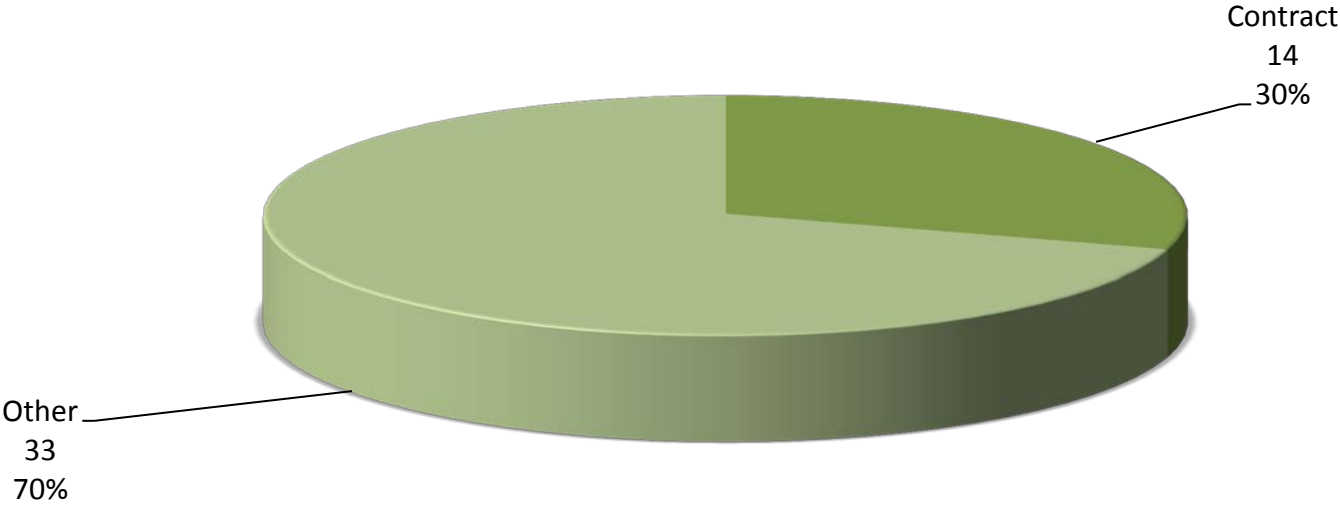
Sublimity Calls Total Call Length August 2014
