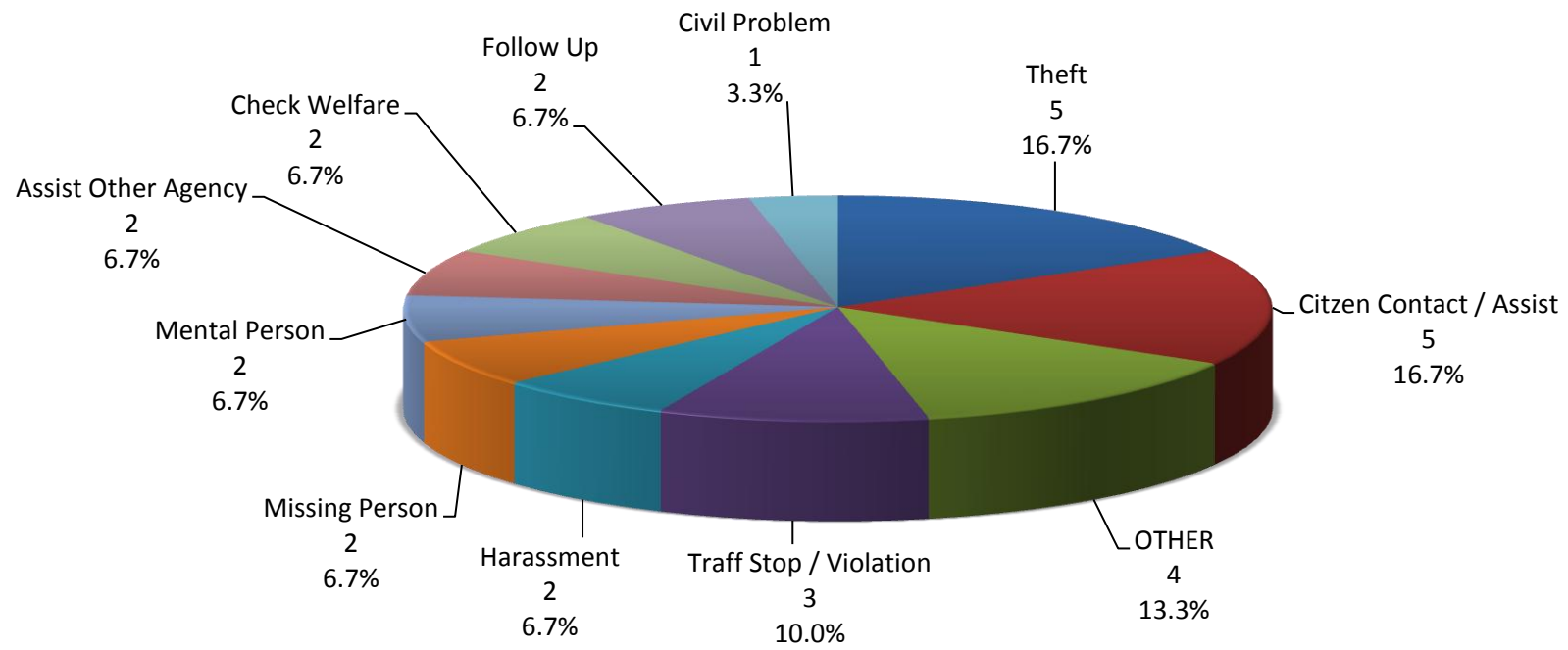

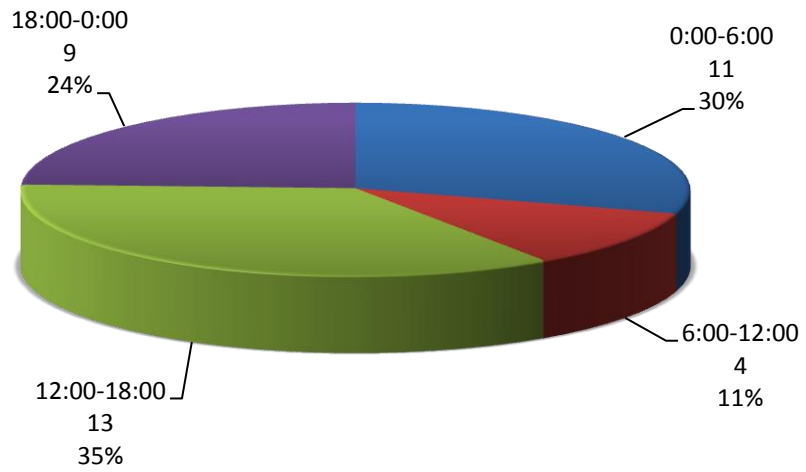

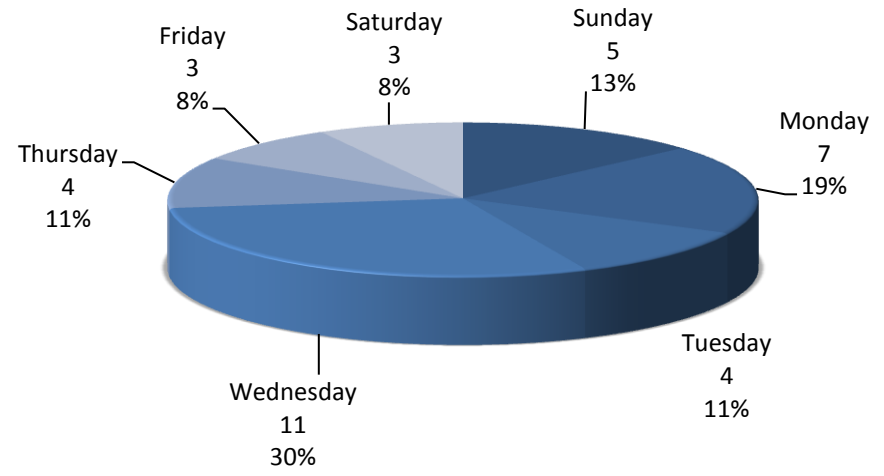
Call Type by Primary Deputy November 2014



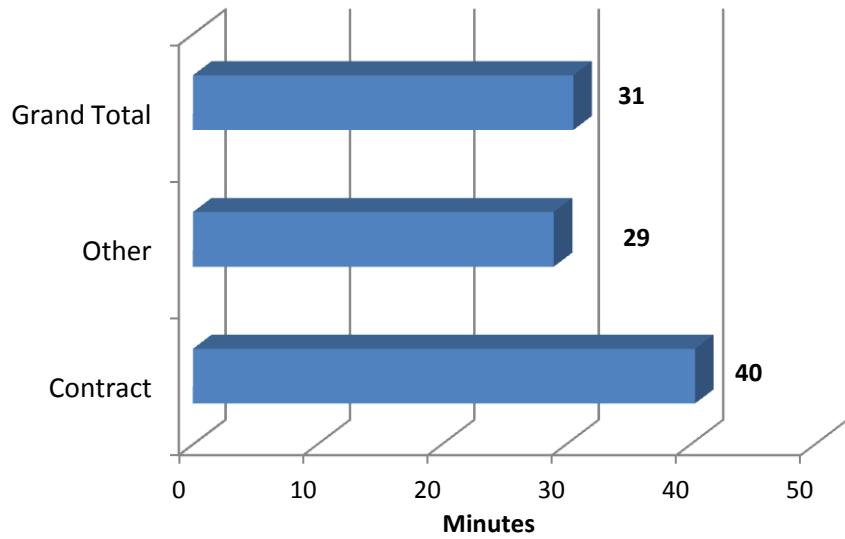
**Sublimity Calls for Service by Hours Range
November 2014**



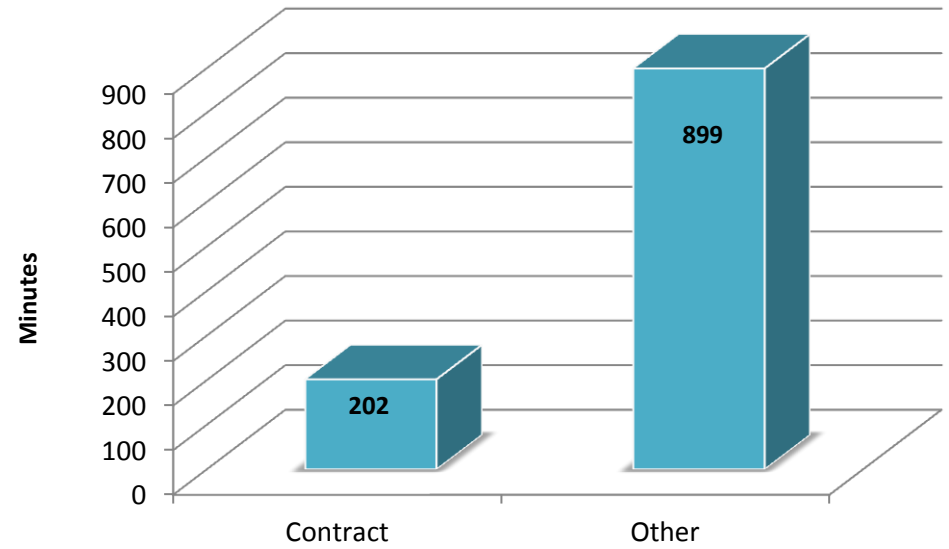
**Sublimity Calls for Service by Day of Week
November 2014**



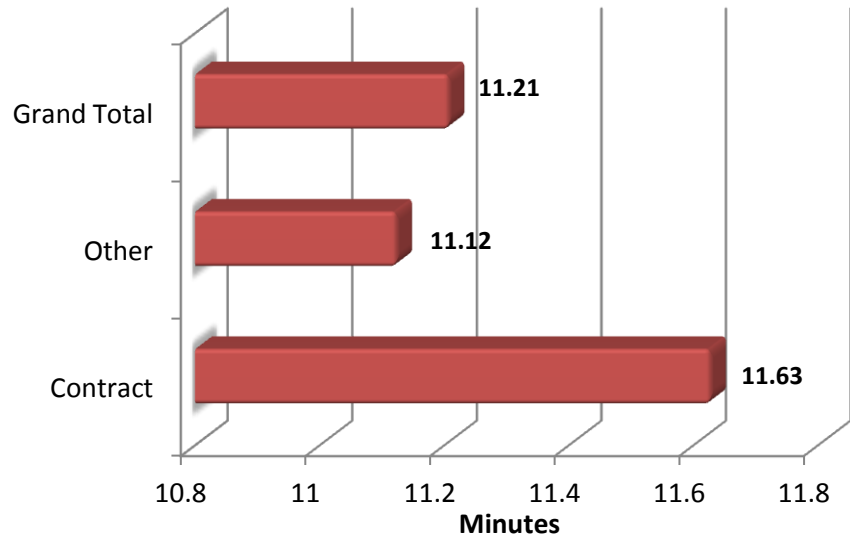
Sublimity Calls Average Call Length November 2014



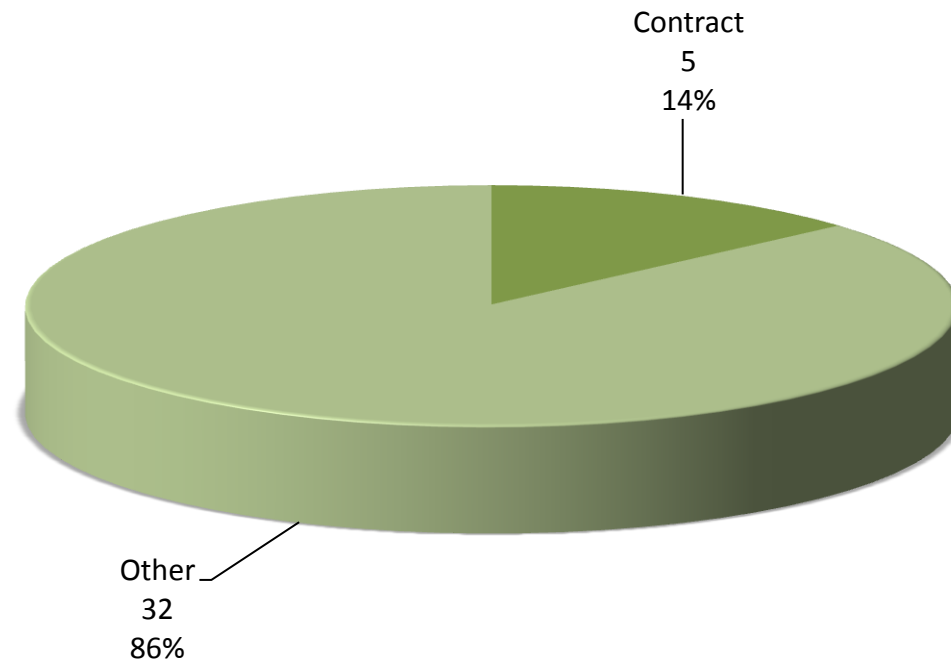
Sublimity Calls Total Call Length November 2014
