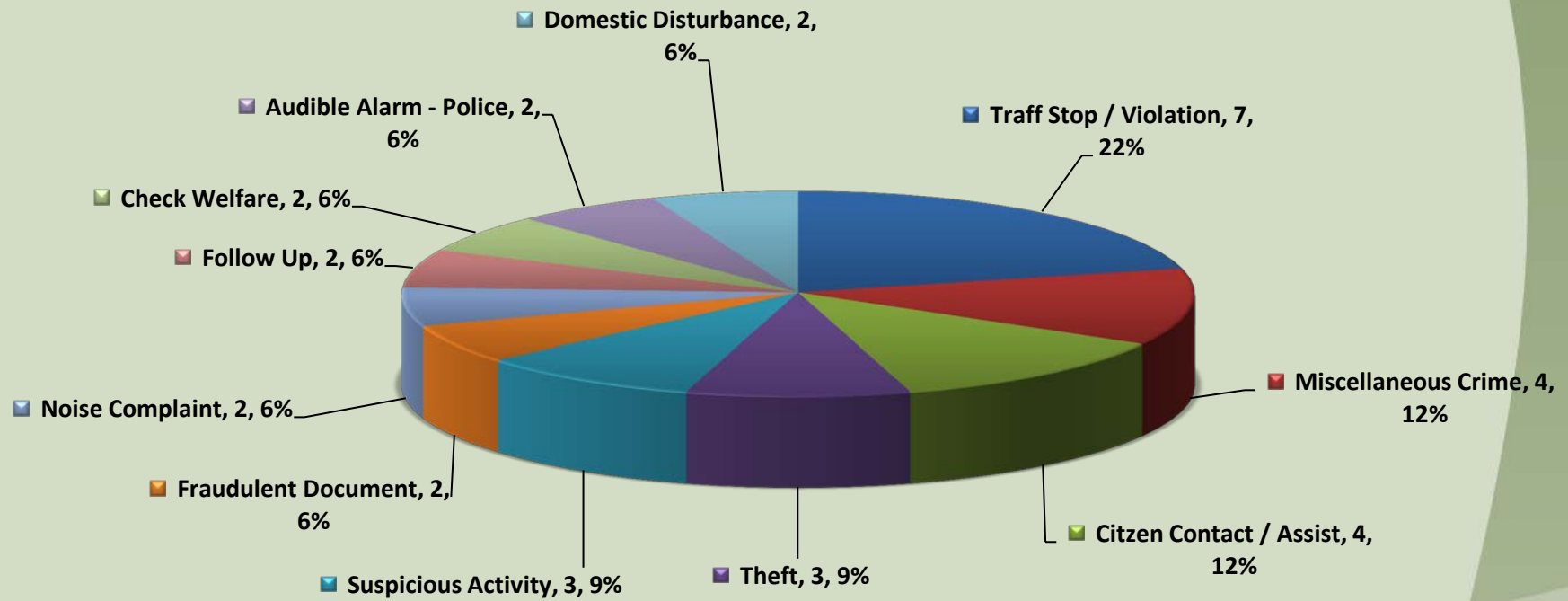
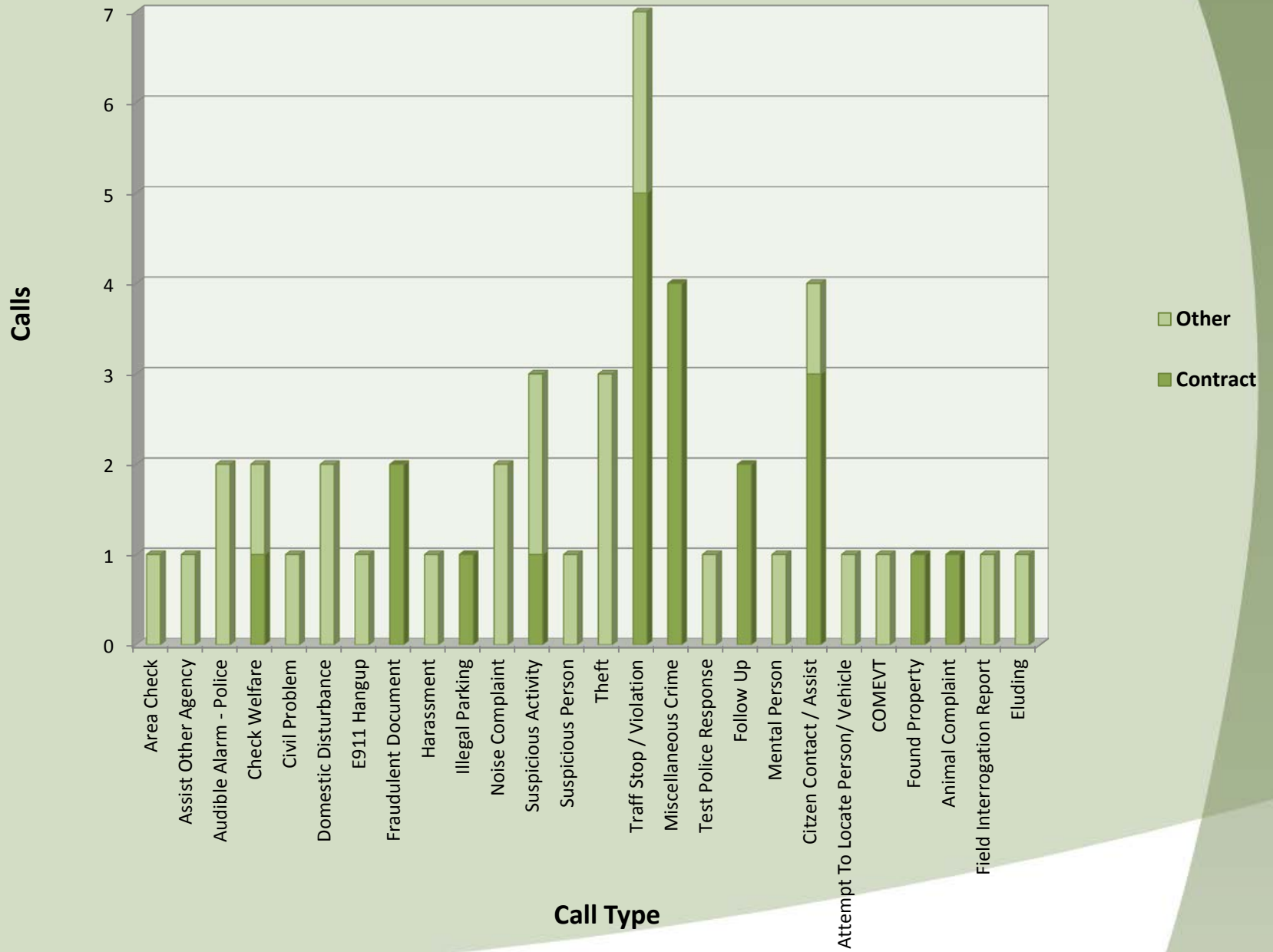


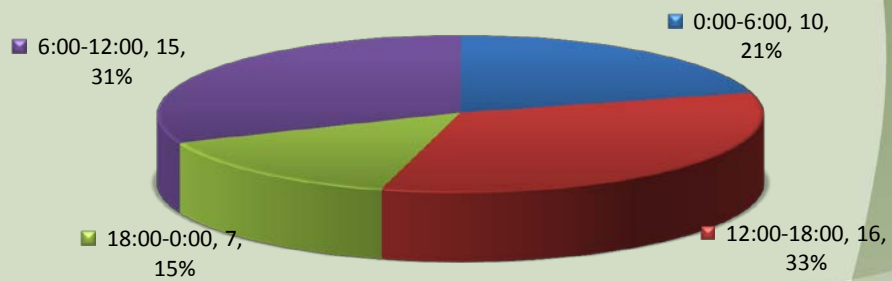

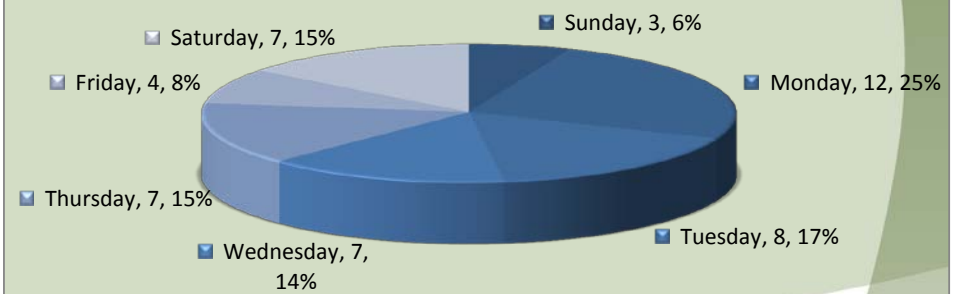
Call Type by Primary Deputy Sublimity - June 2015



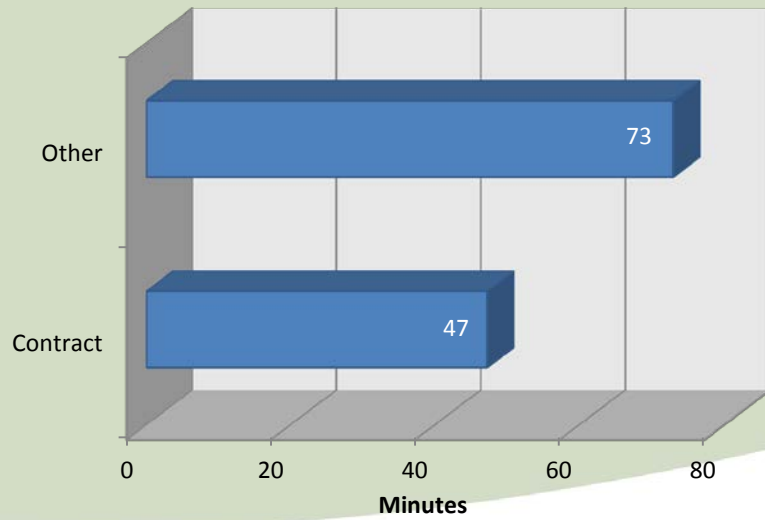
**Calls for Service by Hours Range
Sublimity - June 2015**



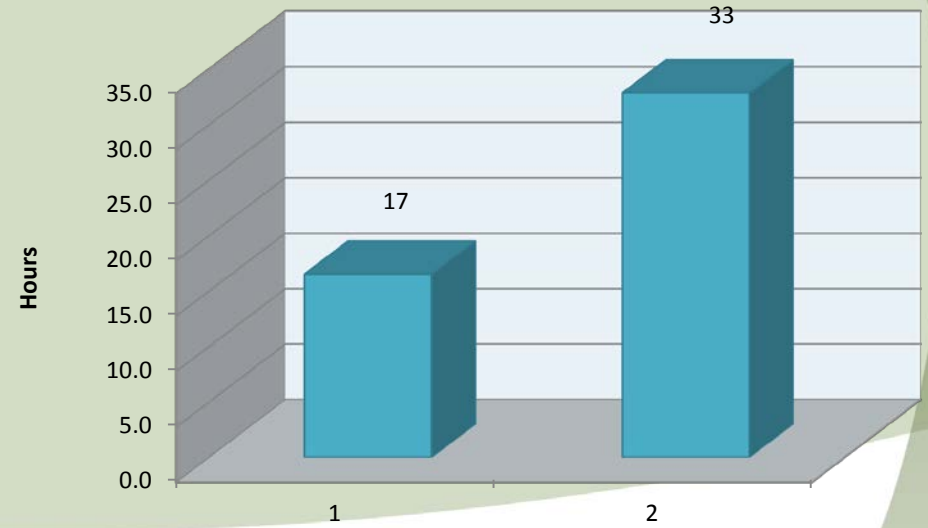
**Calls for Service by Day of Week
Sublimity - June 2015**



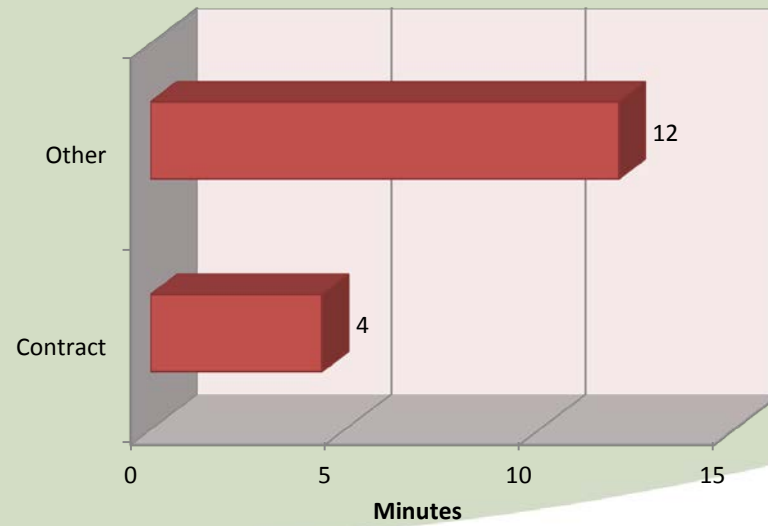
Average Call Length Sublimity - June 2015



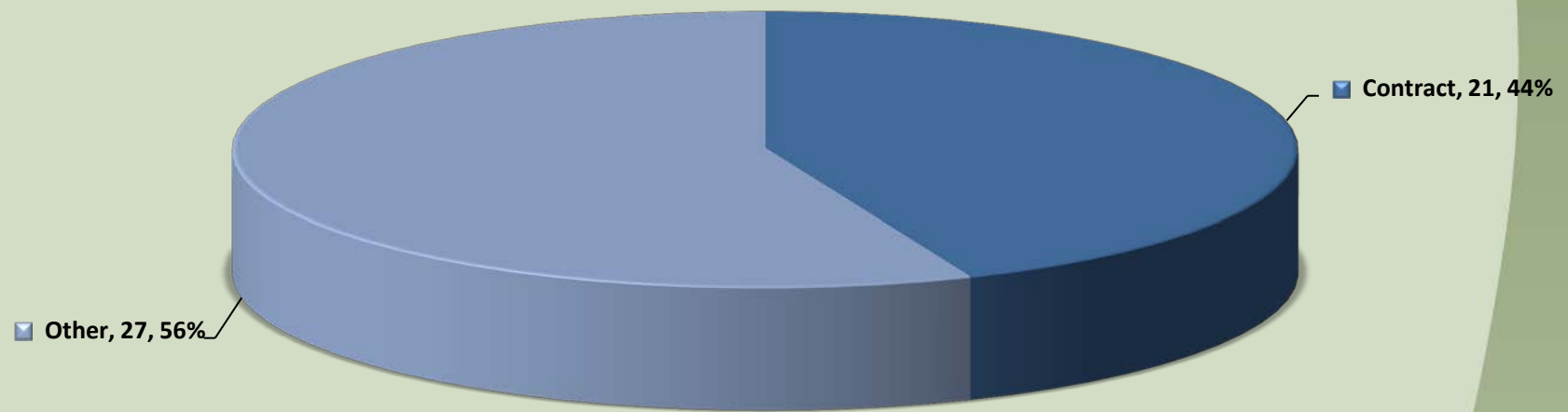
Total Call Length Sublimity - June 2015



Average Call Arrival Time Sublimity - June 2015

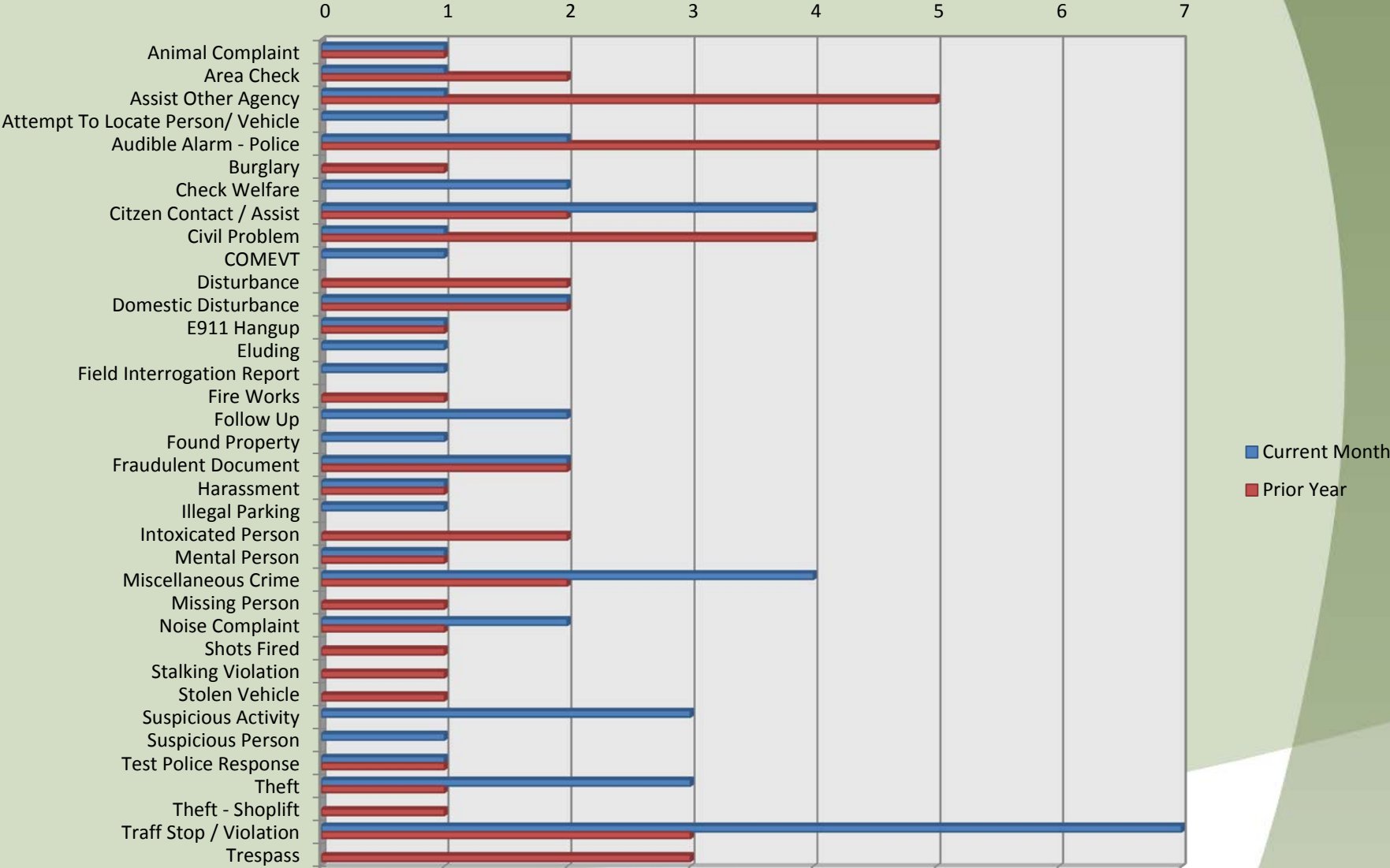
