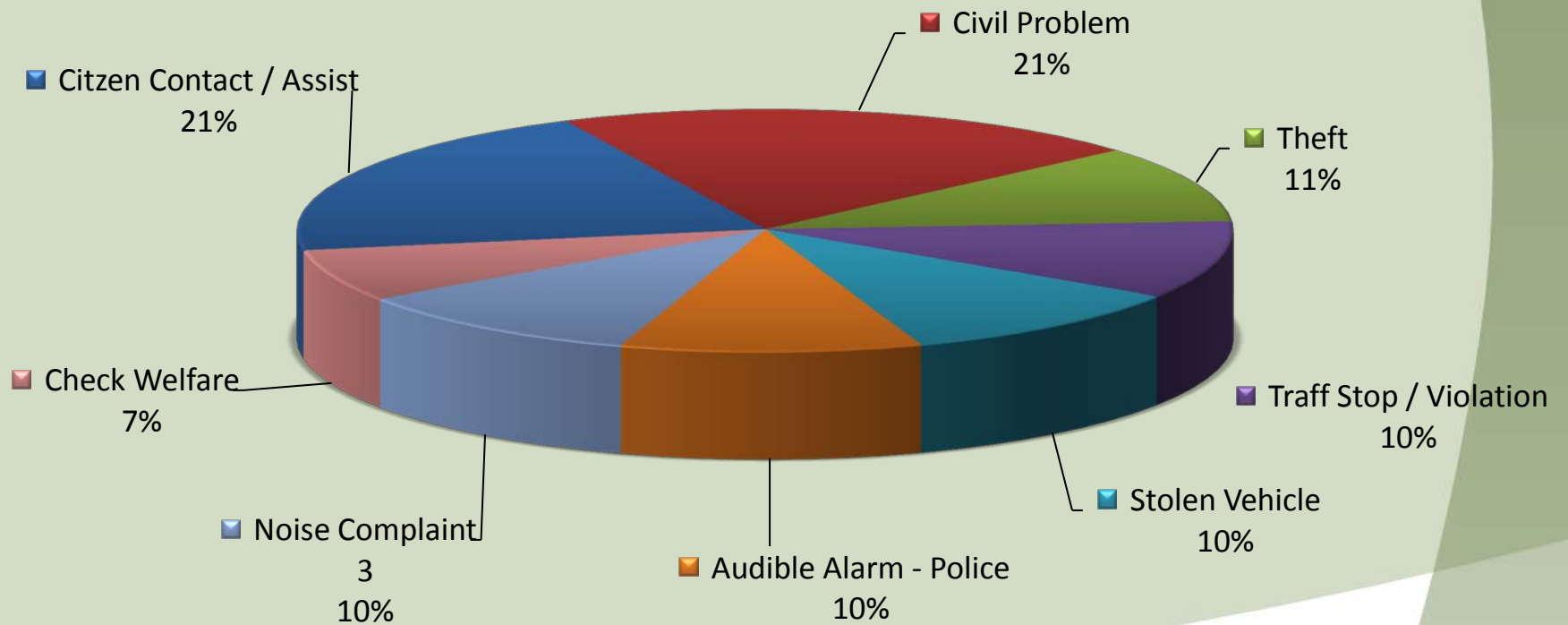
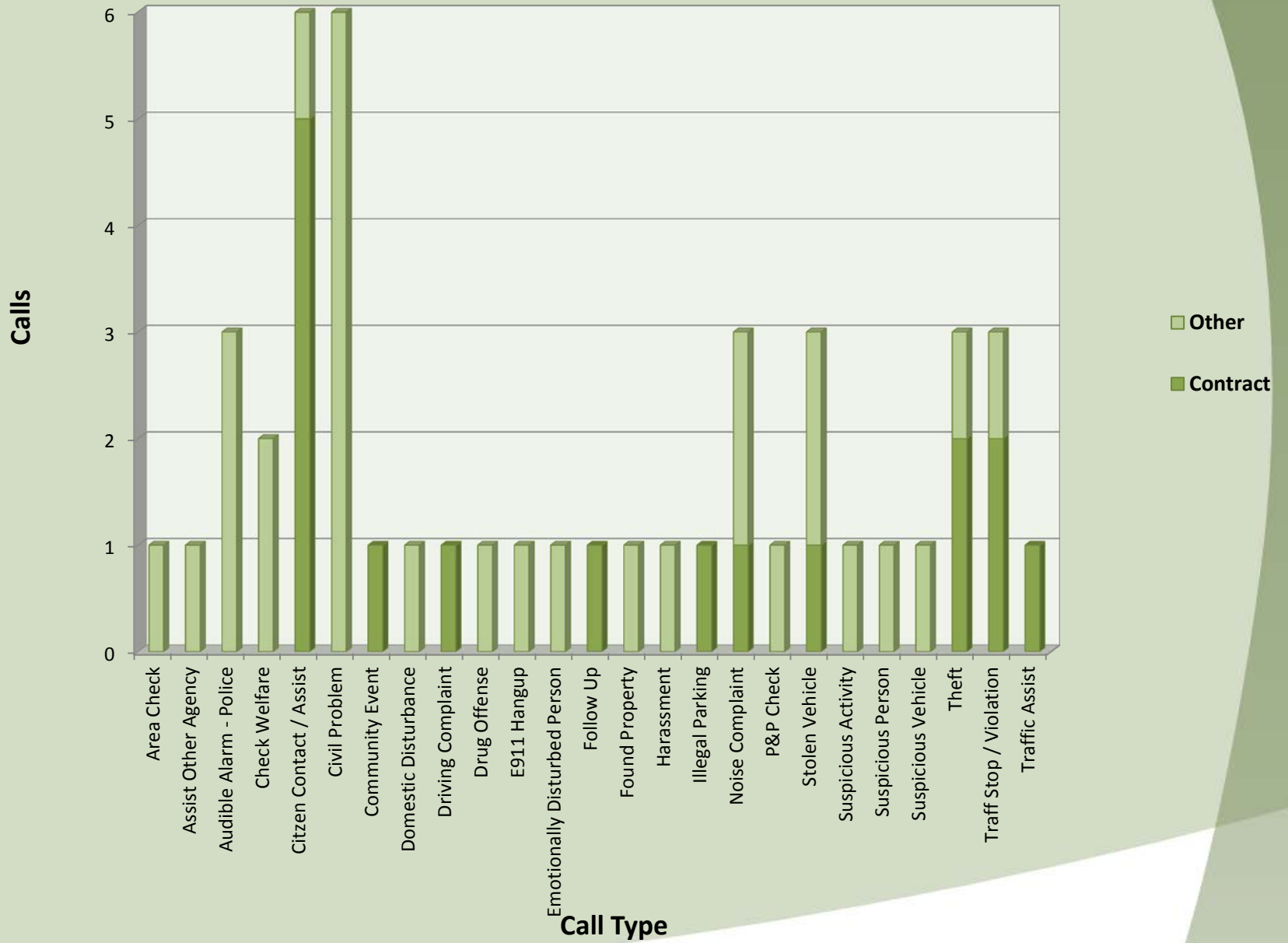


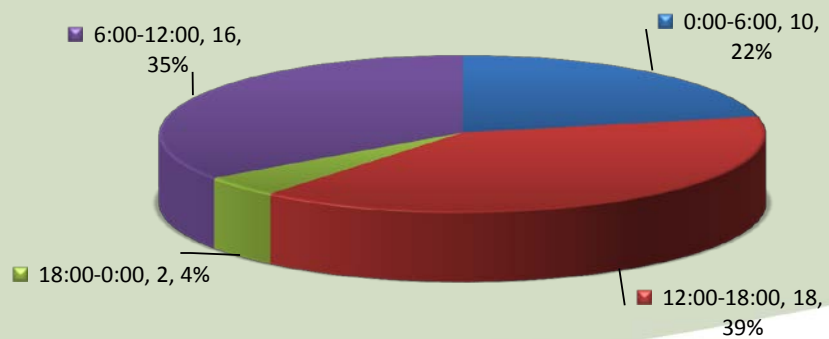

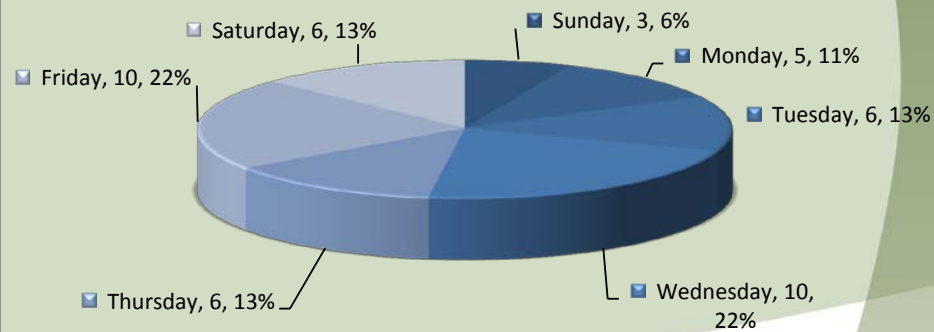
Call Type by Primary Deputy Sublimity - March 2018



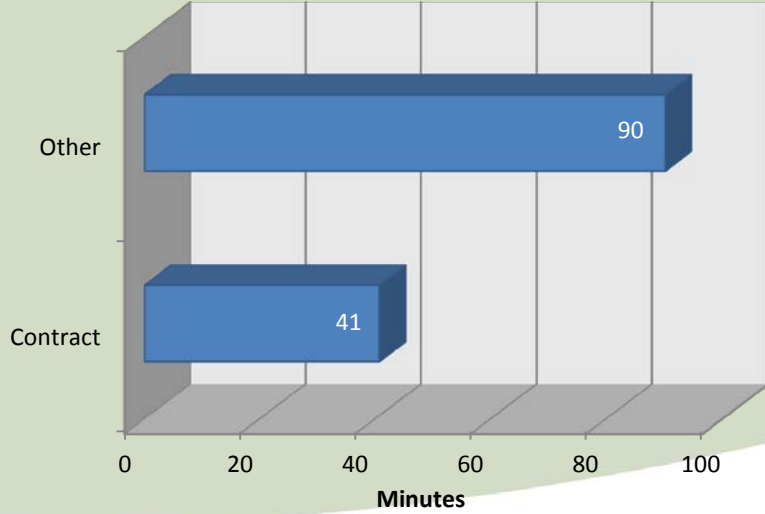
Calls for Service by Hours Range Sublimity - March 2018



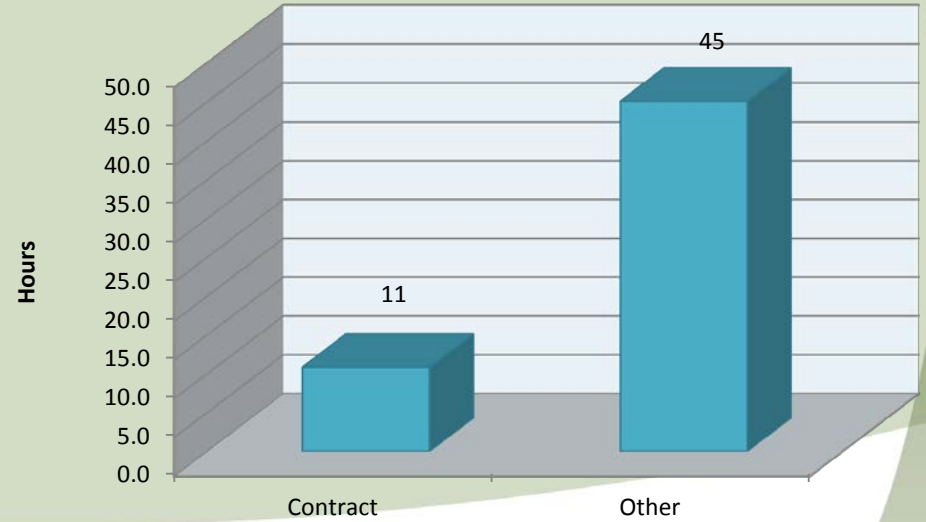
Calls for Service by Day of Week Sublimity - March 2018



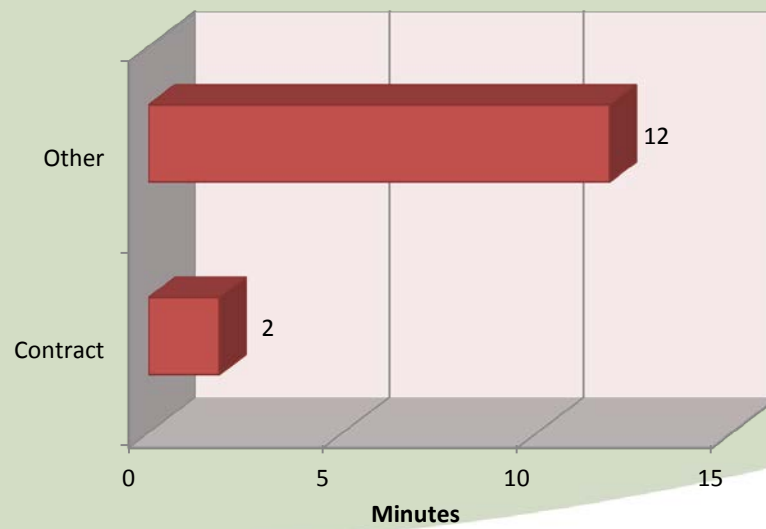

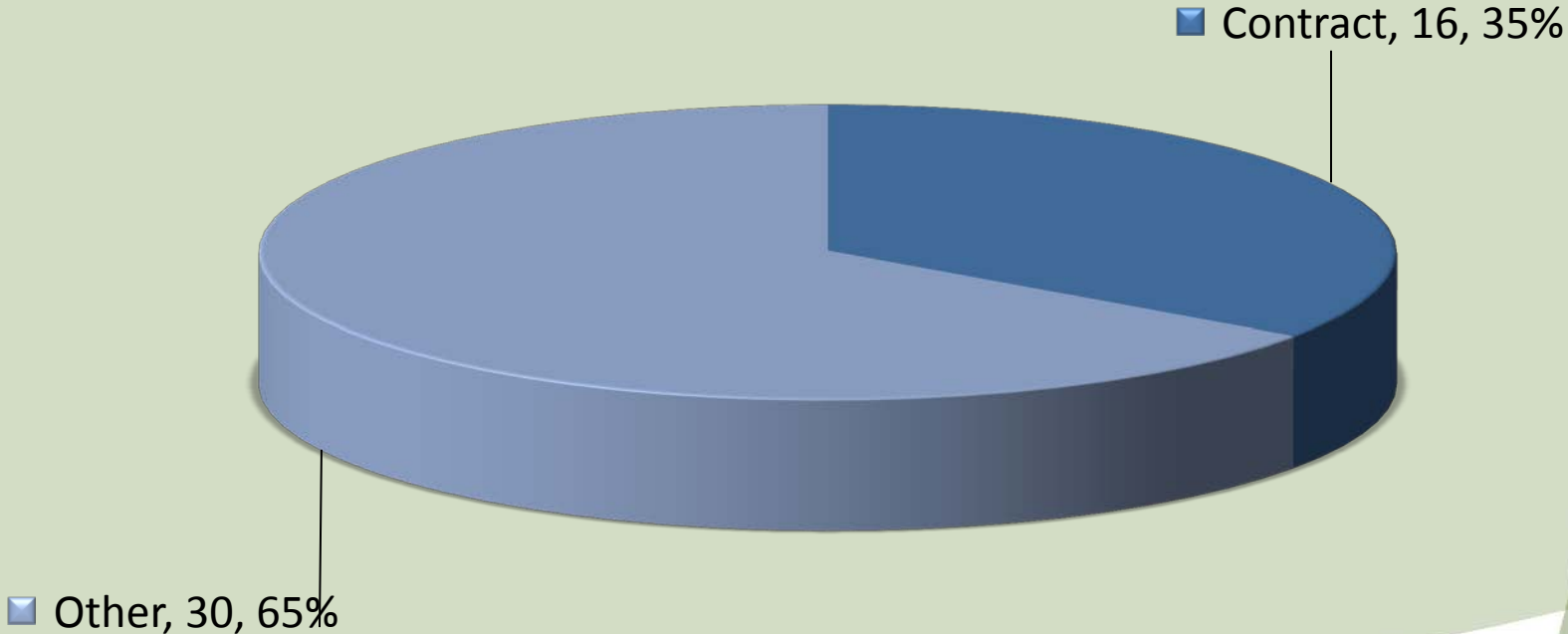
