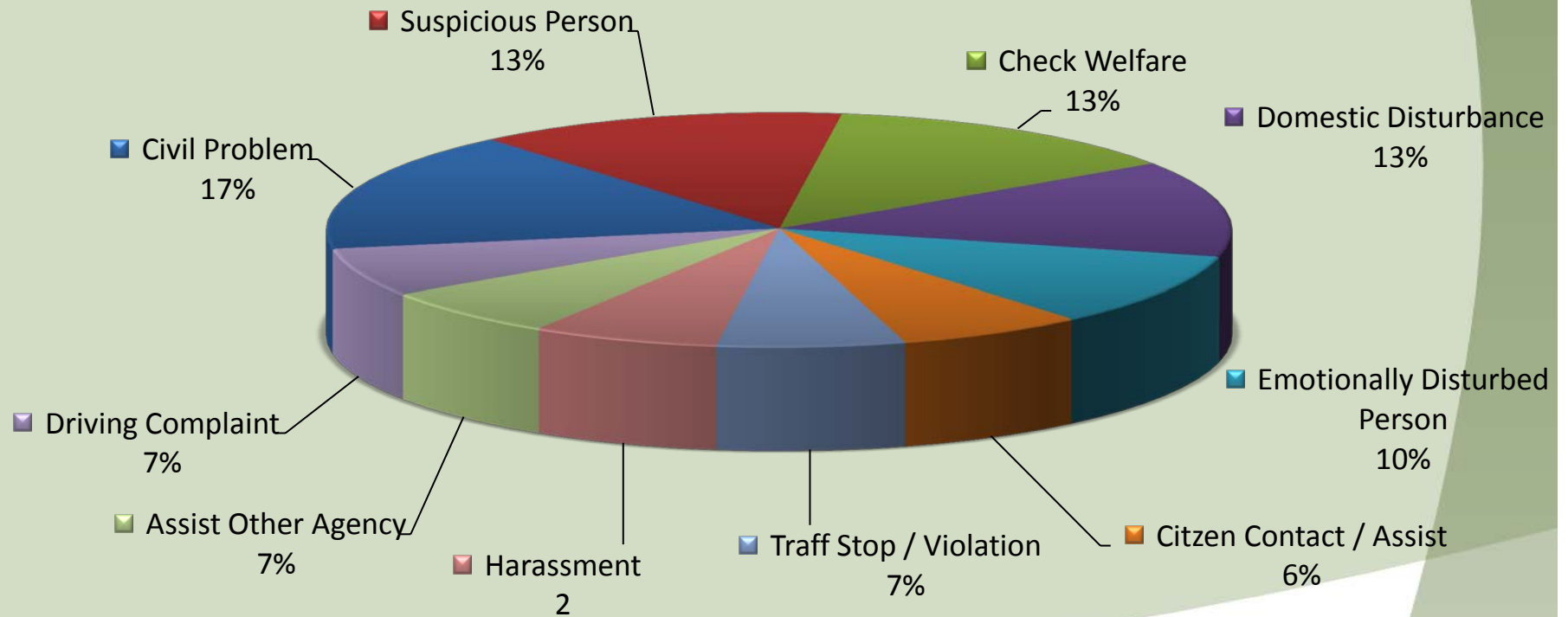
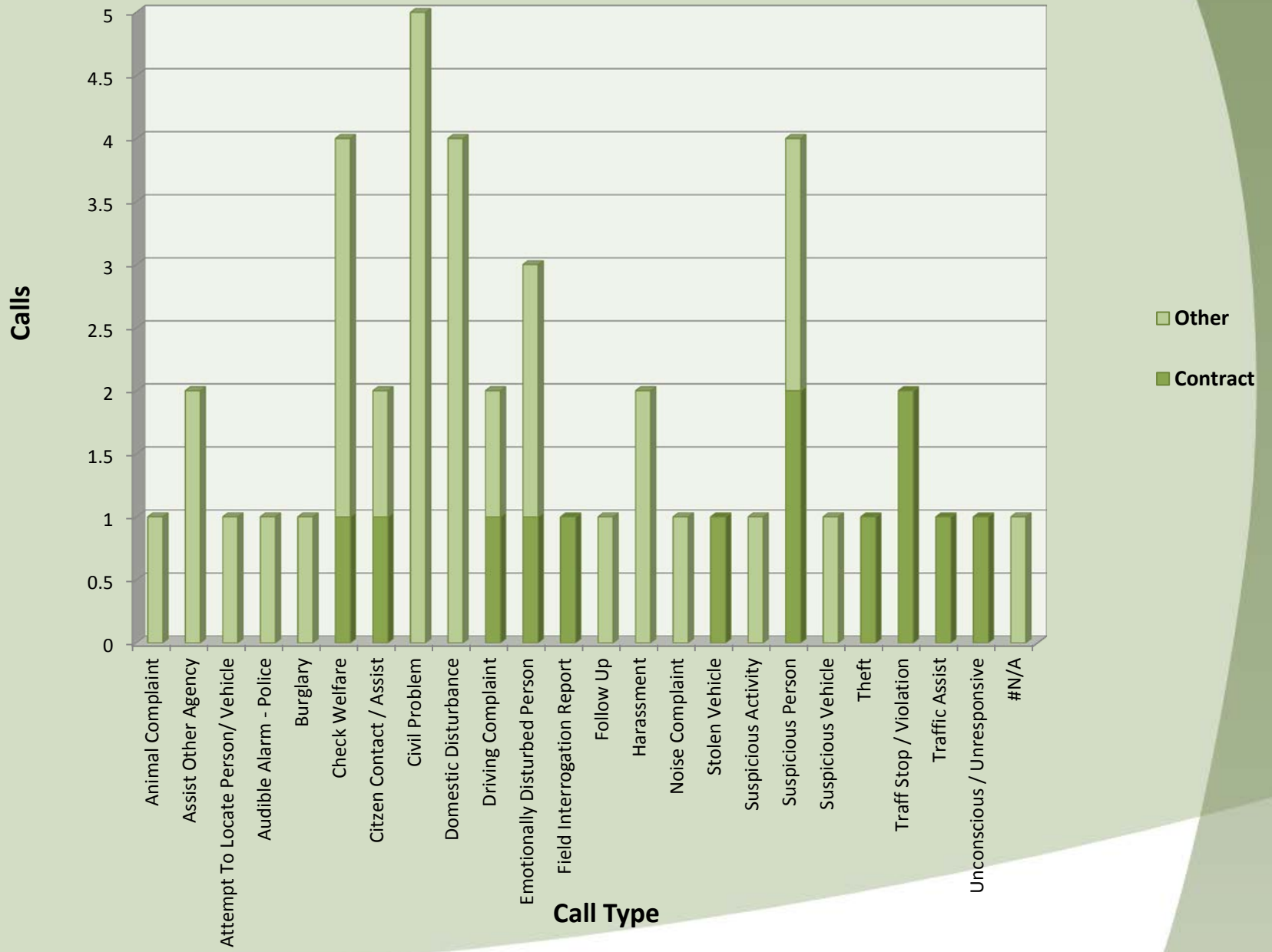


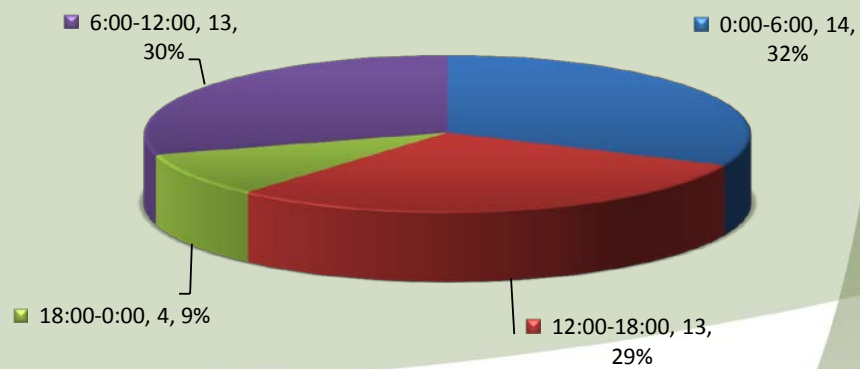

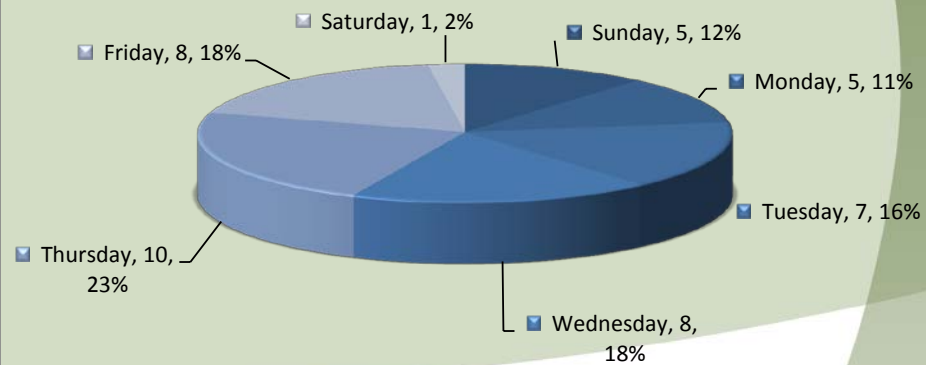
Call Type by Primary Deputy Sublimity - June 2018



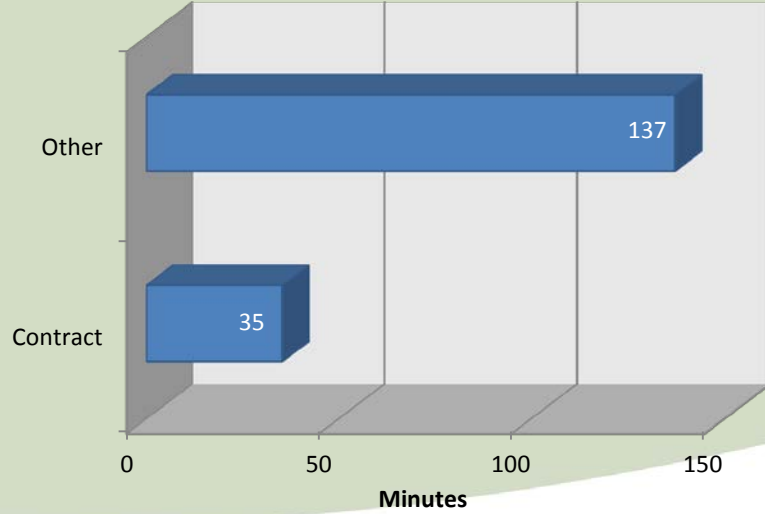
Calls for Service by Hours Range Sublimity - June 2018



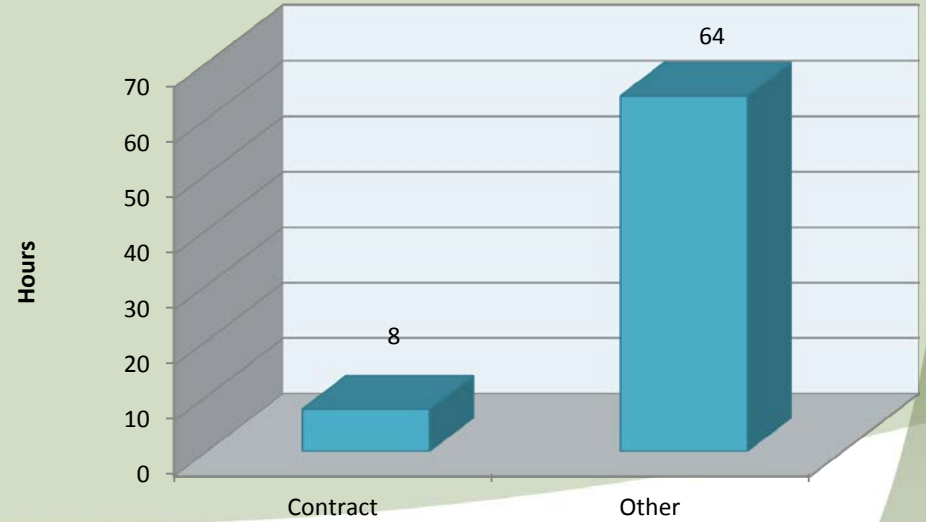
Calls for Service by Day of Week Sublimity - June 2018



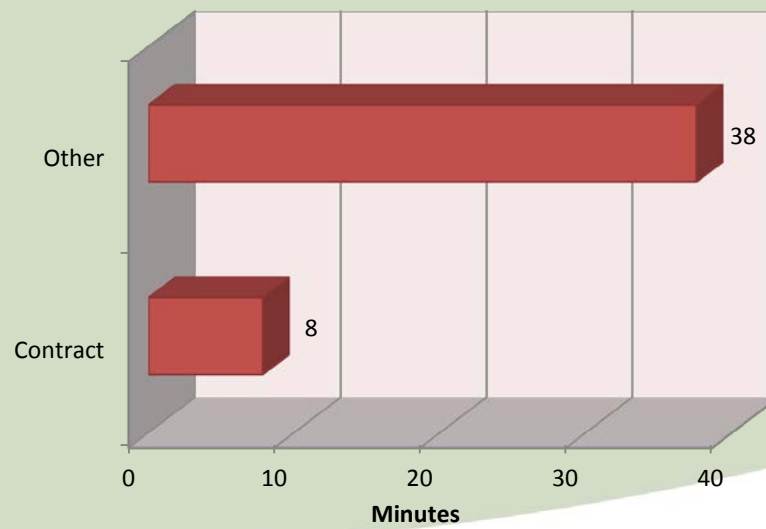

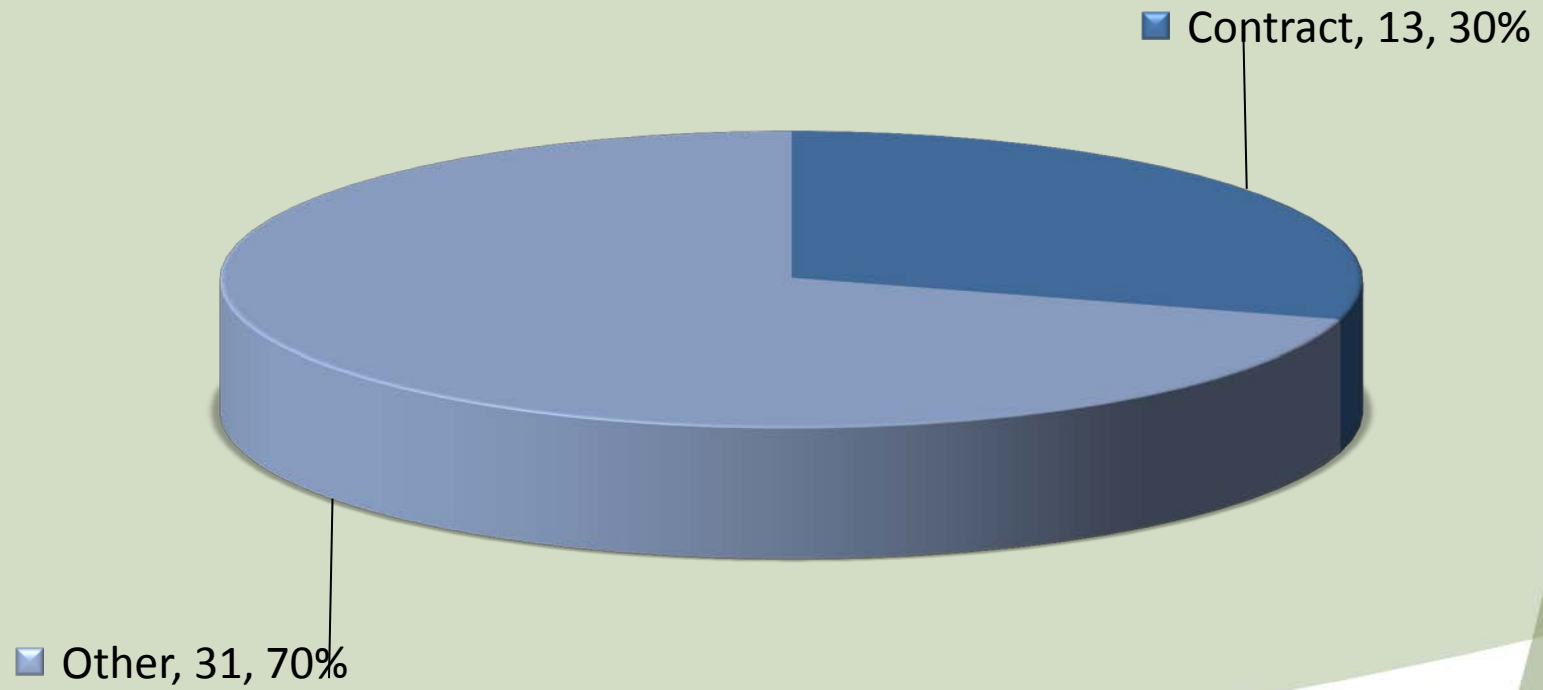
