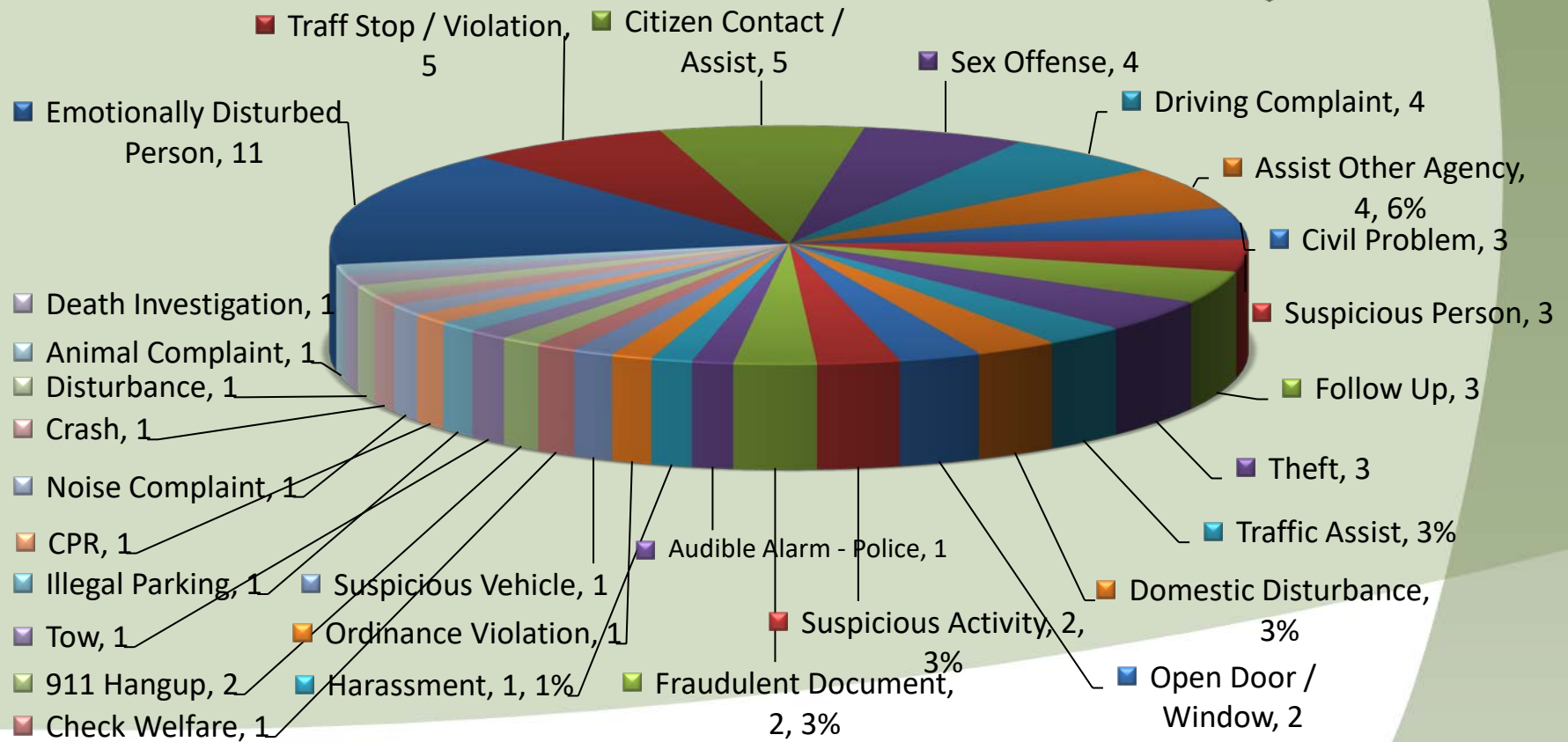

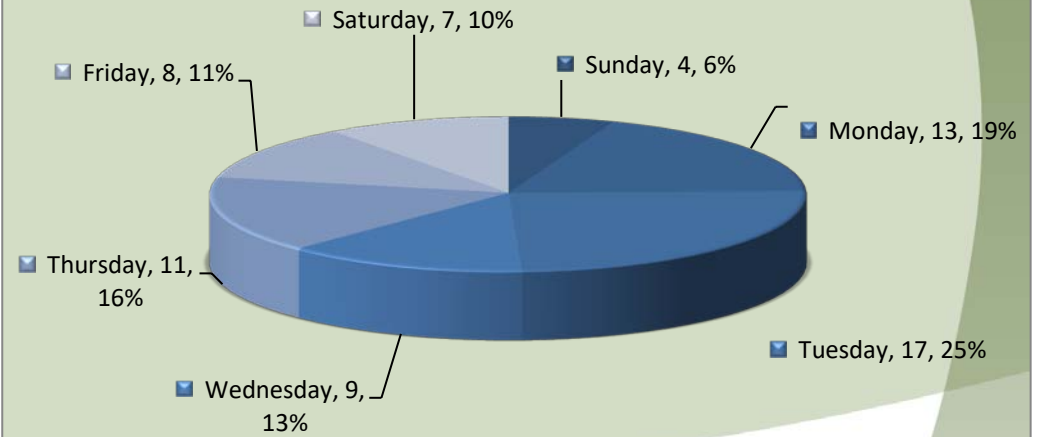
## Call Type by Primary Deputy Sublimity - June 2020



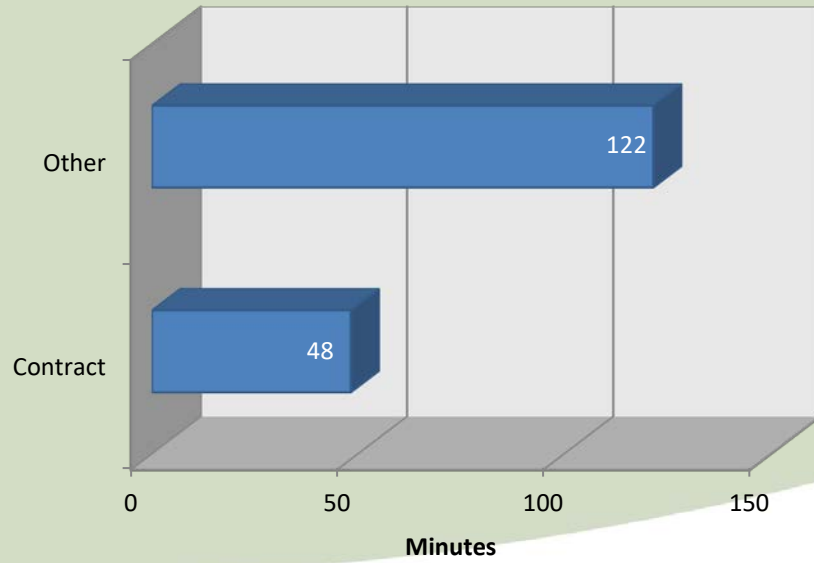
**Calls for Service by Hours Range  
Sublimity - June 2020**



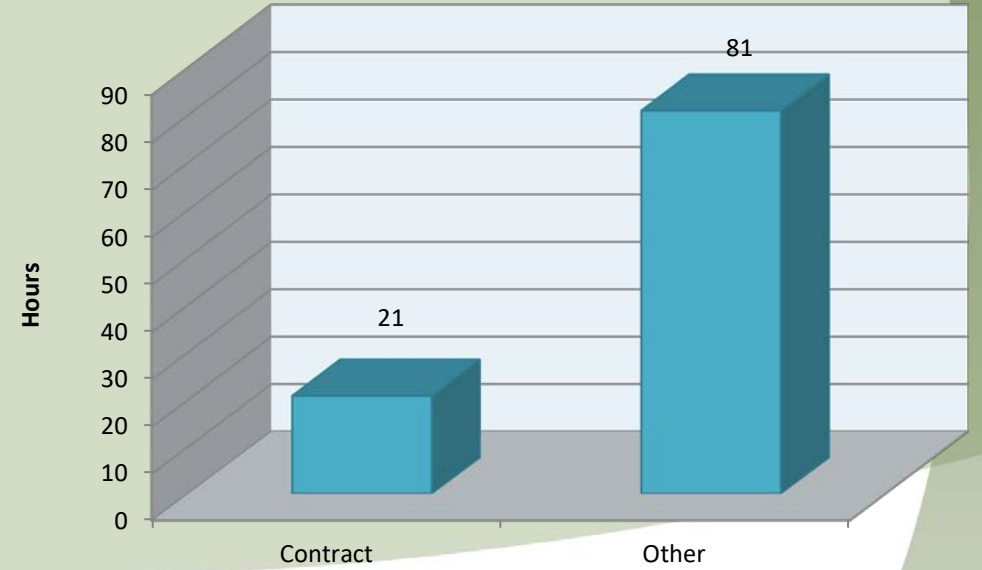
**Calls for Service by Day of Week  
Sublimity - June 2020**



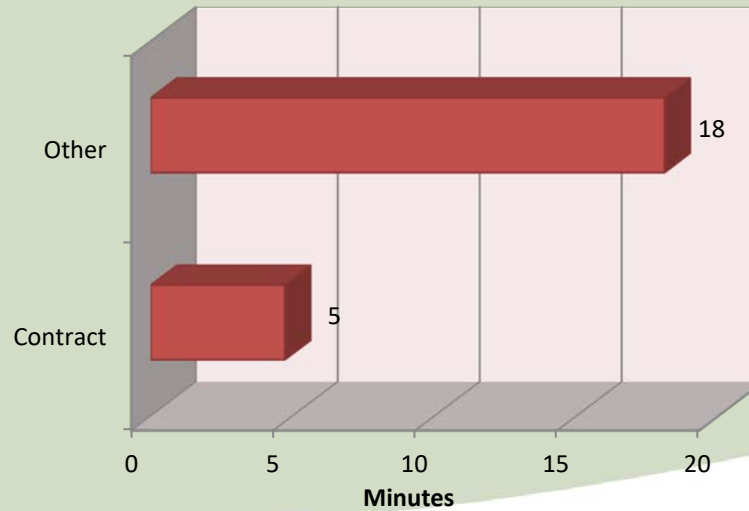
**City of Sublimity

June 2020**



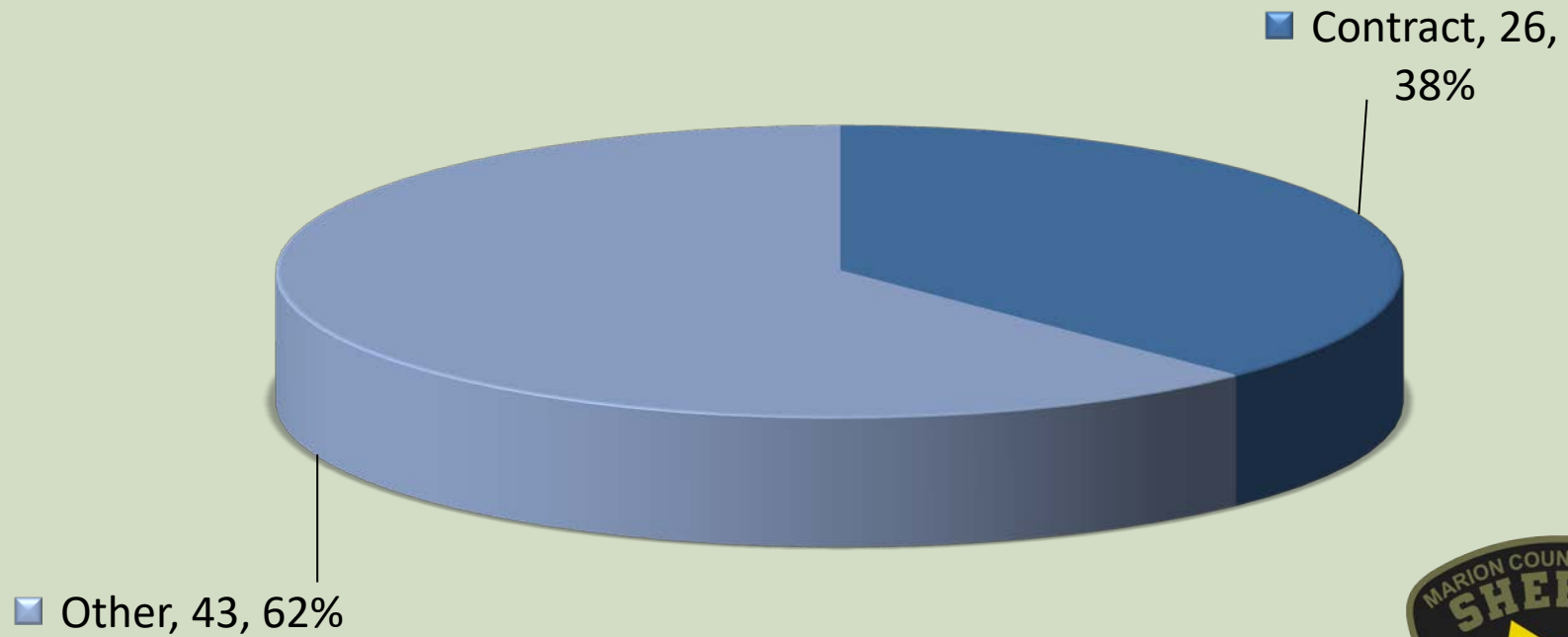
**City of Sublimity

June 2020**



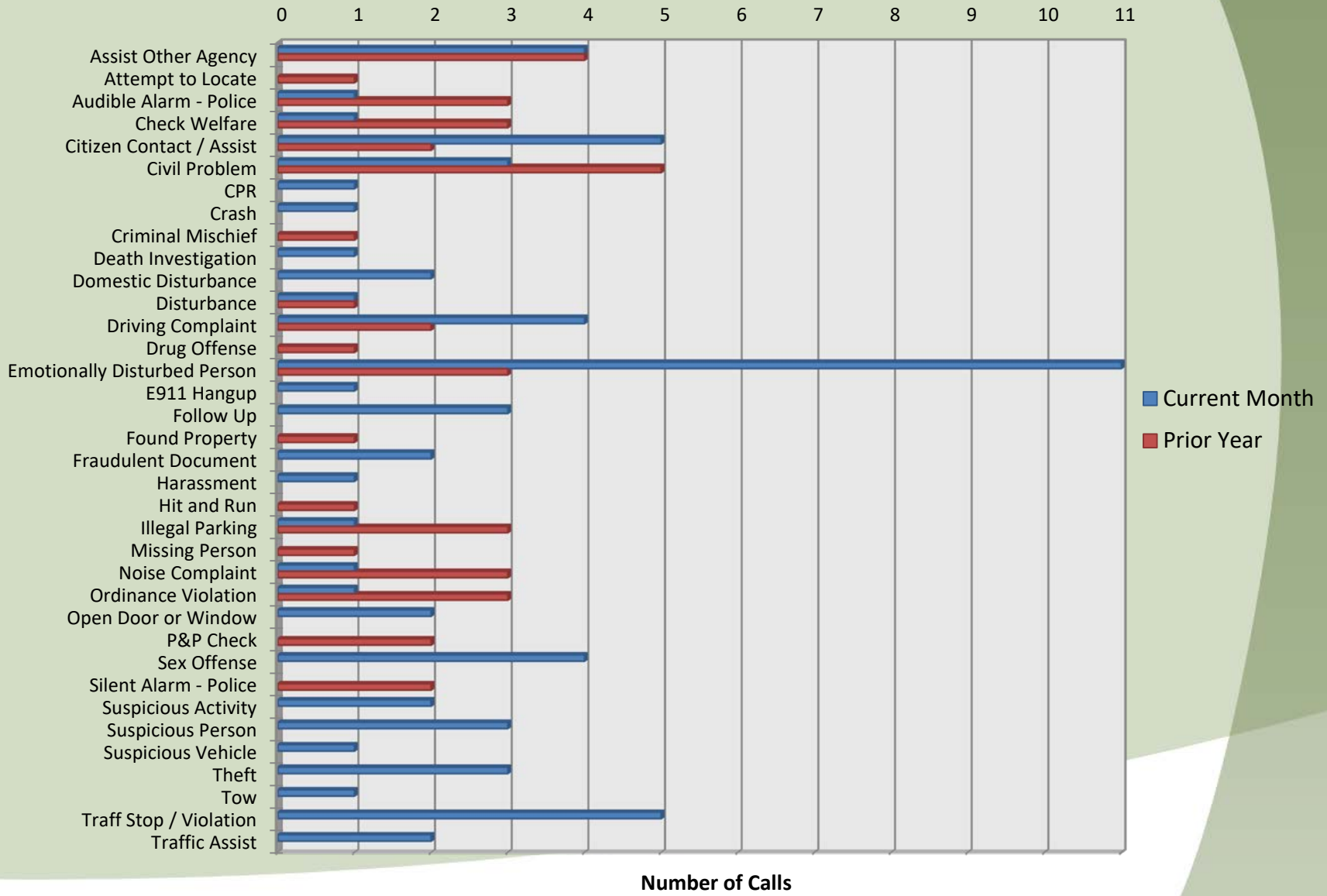
