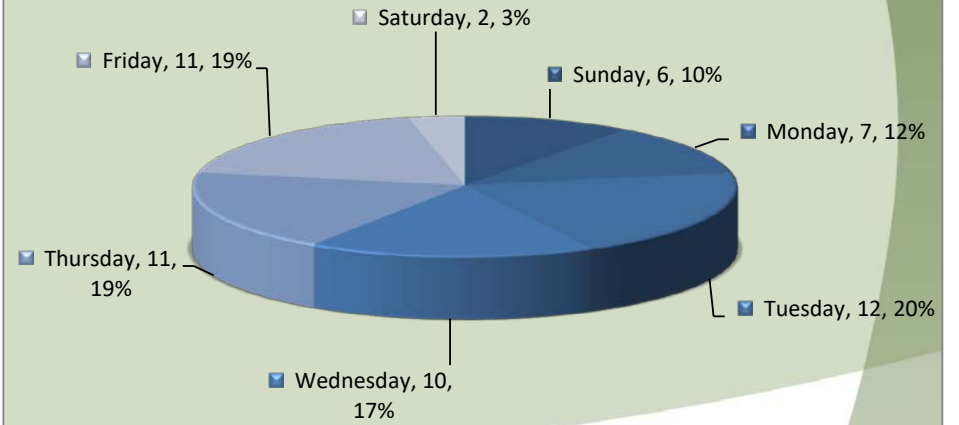
Call Type by Primary Deputy Sublimity - September 2020



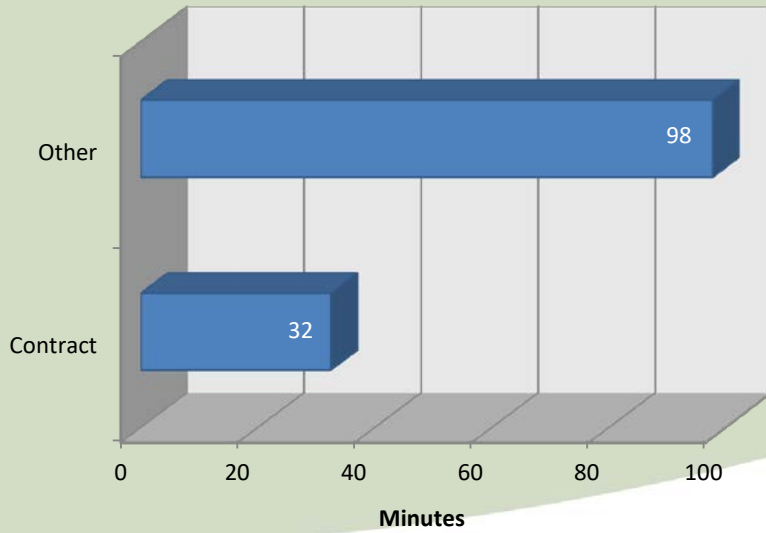
Calls for Service by Hours Range Sublimity - September 2020



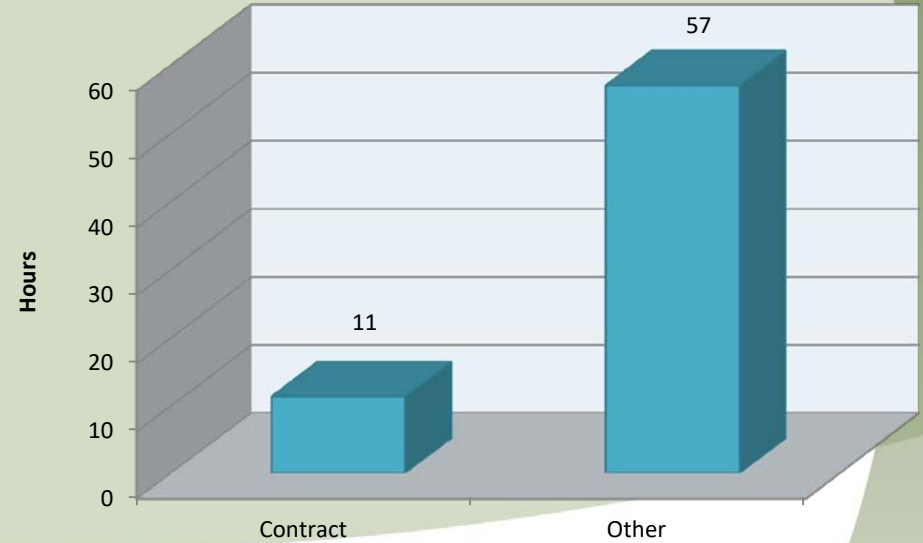
Calls for Service by Day of Week Sublimity - September 2020



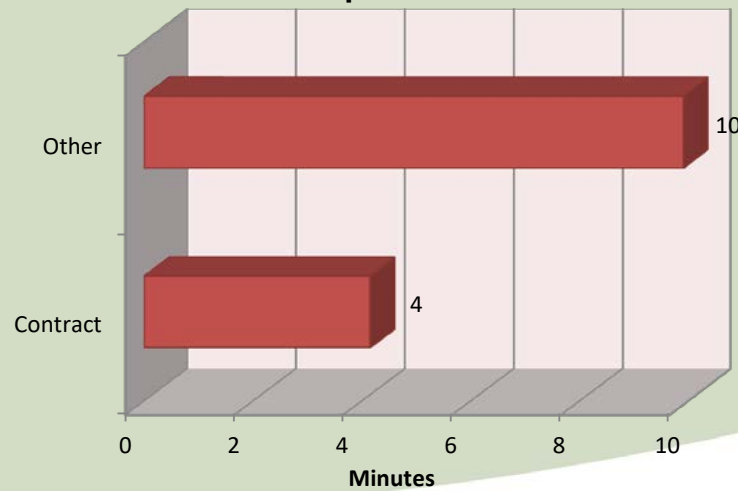

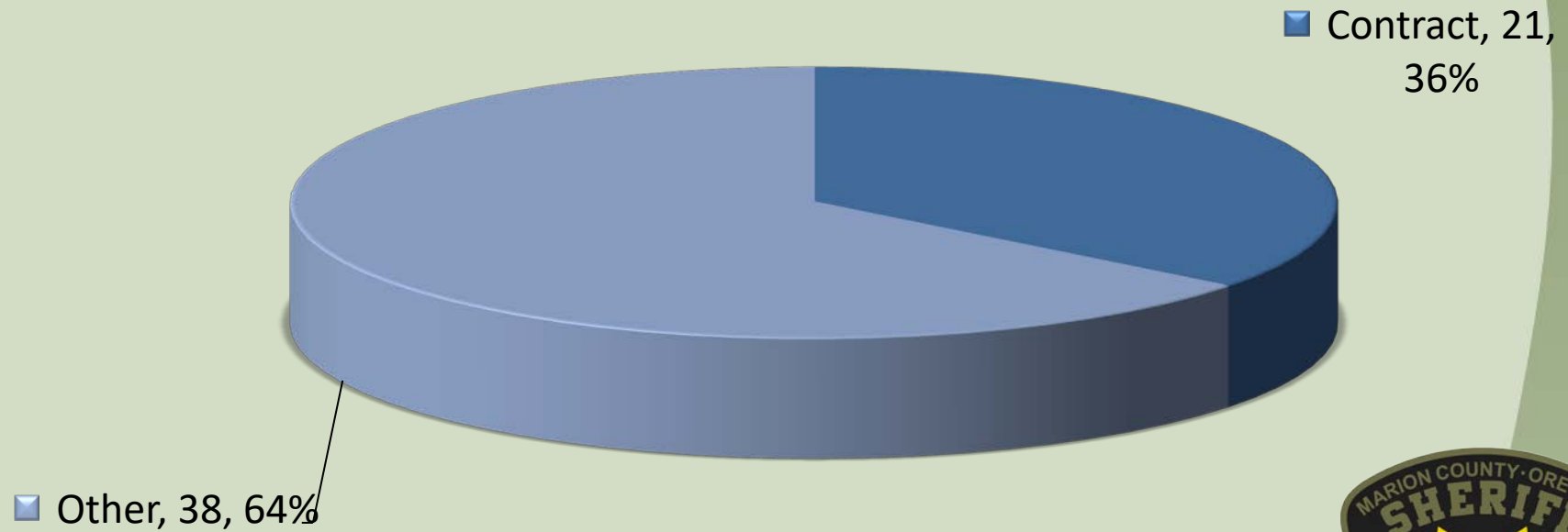

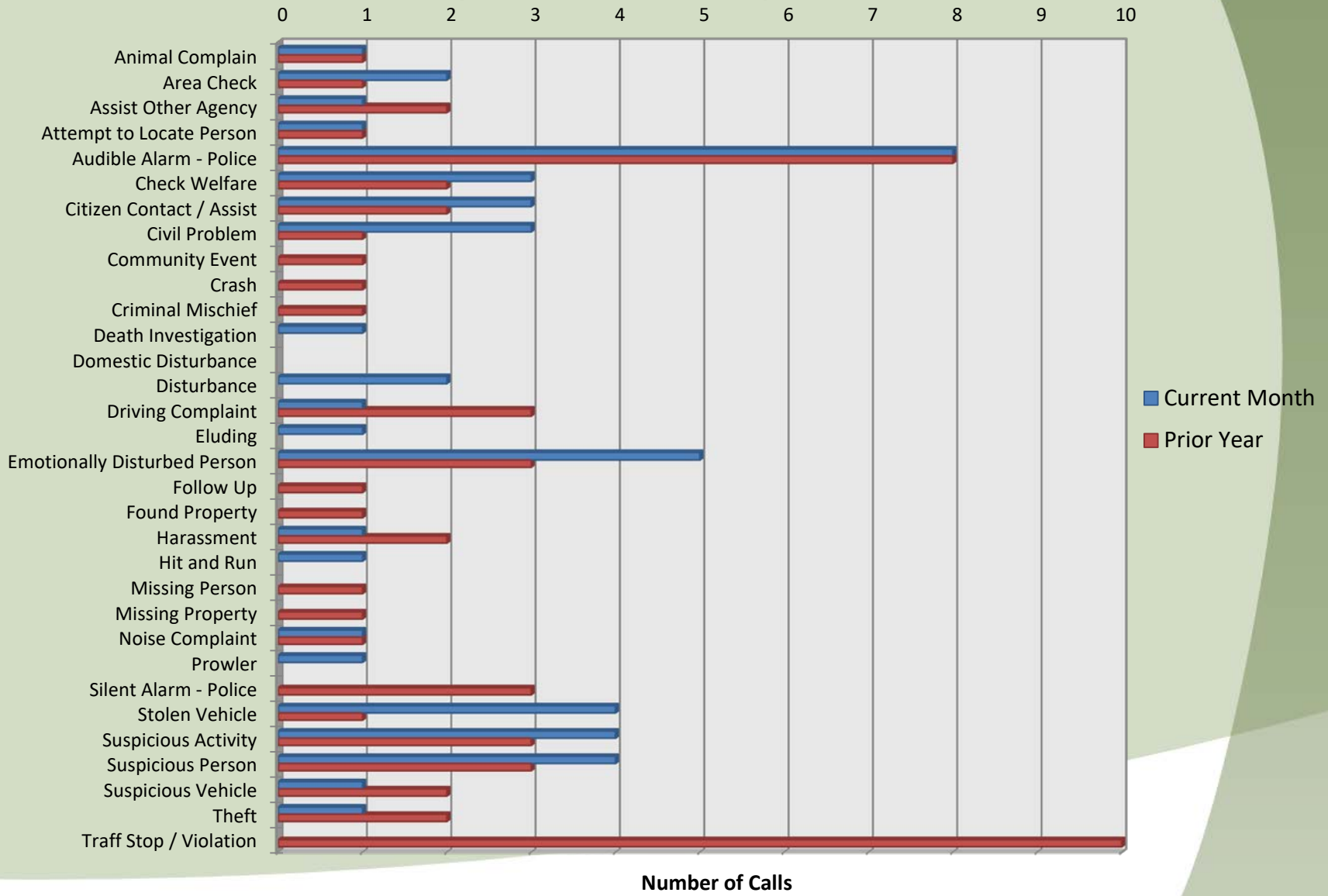
