## Marion County Sheriff's Office Victim Services Information

We believe that victims and their families should be supported once a court process is over. Marion County Community Corrections Division has a Victims Services program to provide information to victims about the conditions of supervision and any additional community resources that may be helpful. This may also include information regarding clarification/reunification on a person to person crime. Honoring your right to choose whether to engage with the Community Corrections Division, please contact at 503-540-8041 for any questions or concerns.

The Community Corrections Division is charged with monitoring and enforcing conditions set by the Court, the Board of Parole/ Post Supervision, the Local Supervisory Authority when an offender is placed on Parole or Probation. Offenders are often ordered by the court to have "no contact" with the victim of their crimes. These orders appear on release agreements, sentence orders and as conditions of supervision. If the offender violates this condition, there can be serious consequences. If you are a crime victim listed on the "no contact" order and the offender is not abiding by that order, call 911. It is important to remember that no protective order provides absolute safety.

***Reminder- if an offender is committing a new crime this must be called into Law Enforcement, we cannot arrest on new charges.***

## USEFUL INFORMATION FOR VICTIMS

What kind of information can crime victims receive?

We can tell you:

- The name of the Community Corrections Deputy (PO) and how to contact him/her.
- Why the person is under supervision.
- Conditions of supervision and what these mean and how they are enforced.
- Physical description and age of the offender.
- What geographic area to which the offender is released.

What assistance can Victims Assistance provide:

- Understanding your crime victims' rights.
- Assist you with safety planning and how to obtain a protection orders (no contact orders, restraining orders, stalking orders and sexual assault orders)
- Update you on significant changes regarding the offender and case status.
- Supply you with a recent photograph of the offender.
- Assist with reunification or clarification at victims' request
- Take time to listen
- Referral to community resources

## Vine Information- Offender Status Notification

If you would like to be updated on an offender's status, please sign up for Victim Information Notification Everyday (VINE) at [www.vinelink.com](http://www.vinelink.com) or dial 1-877-674-8463. You will need the offender's State ID number/SID#. You may also visit our jail roster and select an Adult in Custody's name to sign up to receive VINE messages.

### PROBATION

Supervised probation is a sentence imposed by the Court in which a convicted offender will be required to report to a Parole/Probation Officer. These officers will meet with the offender face to face at the office, the offender's home or place of employment. The PO supervises the offender to ensure the Court conditions are followed and contact may decrease as offender's behavior permits.

### PAROLE/POST PRISON SUPERVISION

An offender is placed on parole or post-prison supervision after they have served a prison sentence. When released from custody, they are considered to be on parole or post-prison supervision. The court no longer has jurisdiction, and the offender's conditions are set by the Board of Parole or the Local Supervisory Authority. These conditions will usually include a no contact with current victims.
