INFORMATIONAL

Foreclosed Property Tax ID #R13330

Summary of presentation:

- The tax foreclosed property is at 1305 George Street, Woodburn;
- The back of the house has a large amount of fire damage;
- Auctioned in October with no bids;
- Offered at private sale and no bids;
- Risk concerned with holding on to property;
- Policy allows us to private sale a property after is has gone to public auction and not sold;
- Contacted investors worked with in the past and received a bid;
- He thought Marion County was selling at minimum bid;
- Taxes owed on the property is \$29,219.70;
- Investor bid \$31,500; and
- Recommending to the Board to accept the bid.

- Looking for the okay from the Board to work with John Lattimer and Jan Fritz to identify additional funds for the third supplemental budget to go ahead and get the last of the bills paid;
- The invoices are for the Boys and Girls Club and the other was for baseballs for the event;
- Steering committee identified difficulty getting the grants to cover some expenses:

- Speaking with the nonprofit Law Enforcement for Youth, about continuing the event; and
- o Their intention is to take over the management and getting sponsors for the event.
- Jolene will arrange a meeting between the Board and Law Enforcement for Youth so the Board has clarity of their expectations.

Board Discussion:

- The Board will look into making a monetary commitment or sponsorship the next budget cycle; and
- Commissioner Carlson will organize a meeting to understand what role Law Enforcement for Youth would like the Public Safety Council to play and what the relationship will be.
