INFORMATIONAL

Potential Sale of a Tax Foreclosed Property to the Prior Owner of Record

Summary of presentation:

- Prior owner submitted written request to purchase property taken through tax foreclosure in November;
- At the time of foreclosure, the amount was \$21,000:
 - Need to get an update from Assessor's Office.
- Current renter looking for alternate living arrangements because property in foreclosure;
- Owner addressed letter from North Dakota;
- Liens are extinguished when the county takes the property;
- Investor asking about property as well;
- Foreclosure recording delayed;
- Owner in contact with Finance prior to foreclosure and throughout the process;
- Commissioners may sell the property back:
 - o Either for the full amount of back taxes, penalties and admin fee; or
 - On contract.
- Owner would like to purchase property back on contract;
- Annual taxes about \$2,300;
- No taxes paid since 2009, despite having a renter;
- Some counties choose not to sell back to prior owners;
- Title search done by Assessor found liens for child custody and banks in the owner's name;
- Selling on contract keeps the liens from being paid until the contract sale is completed;
- County has the deed on the property since November:
 - No rental agreement with person living on the property;
- Not interested in carrying a contract;
- Owner had a line of credit against the property;
- Assessor values the property at \$150,000;
- Lien holders would probably have to go to court to collect on the property if it was sold back to the owner;
- If the county does not sell it back to the property owner, the county will auction the property; and

- May provide prior owner a deadline to make full payment:
 - o 60 days from the first of the year.
- Renter notice with 60 days to relocate.

Discuss an Administrative Policy Pertaining to Animals in Marion County Facilities

Summary of presentation:

- No policy in place currently;
- Various issues with animals:
 - o Injuries with pet gates; and
 - Issues with fleas.
- District Attorney's Office and Juvenile Courts;
- Reviewed definitions with legal;
- Draft policy, procedure, and exception form:
 - Exception for service animals;
 - Policy allows for working animals;
 - o Dog control as well; and
 - o Documents location of animals in county facilities.
- Does not allow for therapy animals; and
- Policy will come before the board in upcoming board session.
